



APOLOGIES

Apologies for absence from the Meeting were received from District and County Councillor Ford, District Councillors Bale and Roberts, Mr. Penny (Egginton Parish Council), N. Ireland (Etwall Parish Council), J. Bates (Hilton Parish Council), J. Clarke and R. Mathews.

EA/24. POLICE ISSUES

Sergeant Sutherland gave an update on crime statistics for the period November 2009 to January 2010. Overall, there had been a slight reduction in crime levels and a breakdown was provided on specific areas. There had been a slight increase in the level of reported anti-social behaviour. A question was submitted about the need for the police to be represented at both this Area Forum and the corresponding Safer Neighbourhood Meeting. This issue had been raised previously and it was noted that the Area Forum was a three-way partnership involving the District and County Councils and the

Constabulary. It was also noted that the meetings had been close together this time.

EA/25. CHAIRMAN'S ANNOUNCEMENTS

The Chairman provided further information on Liberation Day, which would take place at the Bretby Conference Centre on 20th May 2010. The registration line would remain open until 6th April 2010. This year, priority was being given to people who had not attended before, which should help residents in rural areas to get the much sought after places. It was noted that residents had to be aged sixty-five or over to attend. To request a place, residents should ring the registration line 01283 595795 to book their place. Full details were available via the District Council's website.

EA/26. MINUTES

The Minutes of the Etwall Area Forum held on 3rd February 2010 were noted, subject to adding the attendance of Councillor Mrs. Wheeler at the last Meeting and recording the apologies submitted by Mr. Bates and Mr. Banton.

EA/27. REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

A report had been circulated with the agenda, which gave an update on the issues raised at the previous meeting.

EA/28. PUBLIC QUESTIONS ON ISSUES RAISED BY RESIDENTS

A resident reported the parking problems being experienced in the centre of Etwall. This had been exacerbated recently with the closure of a car park adjacent to a public house. The Chairman of Etwall Parish Council responded, confirming the problem and there was a discussion on a number of related issues. It was noted that the Constabulary's beat officer had been asked to monitor the situation. There was discussion about the John Port School, specifically ensuring adequate parking provision within the School complex for both staff and students and the fact that this was at times, impacting on parking at the new leisure centre. A local District Councillor, who was also a School Governor, offered to raise the concerns at a Governor's meeting, taking place later in the evening. The problems were further exacerbated by development works at the School. It was questioned whether the bus park at the edge of the complex could be used during the day, to provide some additional short-stay car parking. There were also safety concerns related to pupils crossing the main road in Etwall, where they were not using the pedestrian crossing correctly.

It was agreed that the above issues be referred to the John Port School Governor's Meeting and the local District Councillor would report back to the next Area Forum. The Forum Liaison Officer agreed to pursue the suggestion about creating additional short-stay parking during the day in the School's bus parking area.

A comment was made about the lack of bus services between Willington and Etwall. A presentation was given at the previous meeting by Community

Transport and the availability of the Council for Voluntary Services Social Car Scheme had also been raised. Reference was then made to the Joint Highway Forum hosted by the District Council. It was noted that a meeting had not taken place recently and the reasons for this were explained.

In Findern, a request was made for large 40 mph speed limit signs at the entrance to the Village from the A38 trunk road. It was agreed that the Forum Liaison Officer would pursue this matter and provide a report to the next Area Forum.

It was reported that the Findern Methodist Chapel had recently been refurbished. There remained a short stretch of road between the Chapel and Commonpiece Lane, which had a rough surface and got waterlogged, causing difficulty for those accessing the Chapel. The Forum Liaison Officer agreed to pursue this matter and would provide a report to the next Area Forum.

There was also discussion about the poor condition of roads in various parts of South Derbyshire, resulting from the adverse winter weather. With regard to Egginton Road in Etwall, it was confirmed this area had been inspected and it was hoped to improve the road surface early in the new financial year. In Egginton, Ashgrove Lane was a particular problem. It was being considered for surface dressing works within the 2011/12 financial year. It was noted that many other roads in Egginton had potholes and the temporary repairs did not provide an effective solution.

EA/29. COUNTY COUNCIL ISSUES - BIG CHOICES - WASTE CONSULTATION

The Forum Liaison Officer publicised a joint consultation by Derbyshire County Council and Derby City Council on plans for waste management over the next twenty years. This consultation ended on 9th April 2010 and residents' views were sought to shape the formation of a draft plan, on which further consultation would take place. A copy of the report was available via the County Council's website or by phoning Call Derbyshire.

It was noted that the District Council would also consider this document. A resident asked whether feedback to a previous consultation on a specific site would be taken into account. It was noted that the Big Choices Consultation was not site specific at this stage, but residents were encouraged to make their views known, as ultimately, site provision would need to be considered.

Arising from this report, a resident asked questions about charging based on the amount of waste collected and the arrangements for the disposal or recycling of batteries, fluorescent tubes and low energy light bulbs. It was confirmed that the District Council had no plans to introduce a charging regime based on the weight of waste collected. South Derbyshire sought to provide a choice, to educate and to encourage recycling. Confirmation was provided on the options available for disposing of batteries correctly and a specific initiative discussed was the Government funded scheme where shops would collect batteries for recycling. A further question concerned how waste that could not be recycled would be disposed of in the future and whether this would be a choice between landfill or incineration.

It was agreed that a presentation be made to the next Area Forum on recycling in South Derbyshire.

EA/30. DATE OF NEXT MEETING

Details of the dates and venues for future Area Forum meetings would be circulated to residents in due course.

REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

At the last Etwall Area Forum held on 10th March 2010, at the Egginton Memorial Hall, the following issues were raised. The issues are listed below, together with progress made to date:-

DERBYSHIRE COUNTY COUNCIL ISSUES

1. Main Street, Etwall: Parking Problems

Residents and local councillors raised concerns over parking difficulties on Main Street created by staff/students of John Port School. Residents struggle to park during the day, which is causing problems for those wishing to access local facilities, particularly the Post Office. The Parish Council is aware of the situation and has notified the Police. A Parish Councillor had spoken with the School and stated that their reaction had been good but it remained uncertain how to resolve the matter.

It was stated that the bus park was empty for most of the day and it was queried whether this could be used as short-stay parking for residents wishing to access the Post Office, etc. Would a limited waiting restriction be possible, with times outside those when buses are likely to be parked here?

DCC Liaison Officer advised that he would ask the Traffic & Safety section to investigate this request. There is also a School Travel Plan Co-ordinator who may have ideas on how to resolve the parking situation here. Enquiries with DCC's Traffic & Safety section have concluded that the bus park forms part of the school grounds and is not part of the public highway. As such DCC, as Highway Authority, are not able to implement any parking provision as it is effectively private land.

However, the matter is being addressed by the School Governors, the head teacher and the Parish Council. A working panel has been appointed to look into parking issues in Etwall and is currently undertaking an audit of vehicles and spaces within the school grounds and looking at other possibilities to alleviate the problems being experienced.

2. Burton Road/Doles Lane, Findern: 40mph Signage

Local residents reported that there was a lack of 40mph signage on Burton Road and Doles Lane, Findern. There are no terminal signs when exiting the A38 roundabout onto Burton Road and a lack of '40' repeaters travelling into the Village. It was stated that some of the

repeater signs had faded whilst others had gone missing altogether. Could DCC please consider introducing more '40' signs?

A site visit has been carried out by a DCC Traffic & Safety Officer in response to these concerns. It has been observed that, on entering Burton Road/Doles Lane, from the direction of the A38 roundabout, 40mph terminal signs are in position and clearly visible.

Additionally, 40mph repeater signs are sited at frequent intervals throughout the restriction - until reaching the start of the 30mph restriction - which again are clearly visible. It was noted, however, that there are 2 repeater signs that are badly faded and their replacement has been added to the maintenance programme. Drivers should be in no doubt that they are travelling through a 40mph restriction here and, as such, additional signage is not considered necessary at this time.

3. Lower Green Lane-Common Piece Lane, Findern: Carriageway Deterioration

A resident had reported carriageway deterioration on a patch of adopted highway, near to the Church Hall, running between Lower Green Lane and Common Piece Lane. DCC had originally advised that work would be carried out in 3 months. It is anticipated that surfacing works will be completed shortly.

4. Egginton Road, Etwall: Resurfacing

Concerns were raised about Egginton Road in Etwall, which had been in a poor state of repair for some time and, it was believed, needed resurfacing. DCC Liaison Officer advised that a number of roads had experienced surface course failure, due to the bad winter, frost and salt. Highways inspectors had visited roads in South Derbyshire and identified a number that required repair. It was hoped that repair work could be carried out early in the new financial year. Egginton Road had been identified for repair.

A local County Member also advised that she had been in contact with the Care Manager for South Derbyshire, who had reported that Egginton Road had been identified for patching. It was stated, however, that patching wasn't enough and that the road needed resurfacing. The Area Maintenance Care Manager has confirmed that the proposed repair for Egginton Road is in the form of machine patching. This form of patching involves resurfacing a short length of road.

5. Street Lighting Provision in Hatton

The above issue was raised at the Etwall Forum on 3rd February and related to a request for additional street lighting on Heath Way, Foston Close and Field Avenue, Hatton.

Advice has been received from Community Safety about funding possibilities. No funding is currently set aside within Community Safety for street lighting provision. If there is evidence of anti-social behaviour, disorder, fear of crime, criminal offences, etc, which could be reduced by improving lighting, a proposal could be put forward for when funding becomes available. To acquire evidence, police data would be looked into – calls for service, criminal damage, other crimes (e.g. assault, burglary, car crime).

SOUTH DERBYSHIRE DISTRICT COUNCIL ISSUES

At the last meeting, a request was made for a presentation on recycling. This is item No. 10 on tonight's Agenda.
