CL/73. MINUTES

The Open Minutes of the Meeting of the Council held on 10th November 2011 (Minutes Nos. CL/57 - CL/70) were taken as read, approved as a true record and signed by the Chairman.

CL/74. **DECLARATIONS OF INTEREST**

Councillors Ford, Harrison, Jones, Murray and Mrs. Patten declared a personal interest in respect of Agenda Item No. 10, concerning Minute No. EDS/48 of the Environmental and Development Services Committee, as Members of Derbyshire County Council.

CL/75. PRESENTATION OF RAM MAJOR'S SASH TO THE MERCIAN REGIMENT

The Chairman welcomed representatives of the Mercian Regiment to the meeting. He invited Councillor Atkin to make a presentation of a ram major's sash to the Regiment, as a gift from the Council and to mark his year in Office as Chairman. Lieutenant Colonel Turner received the sash and addressed Members, explaining the history of the ram and its significance to the Regiment. He spoke about the Mercian's predecessor regiments, gave examples of the calibre of the servicemen and urged the Council's support where possible, for those leaving the Regiment.

CL/76. CHAIRMAN'S ANNOUNCEMENTS

Members were advised of the death of Ivor Smith over the Christmas/New Year period and observed a minute's silence in memory of this former District and Parish Councillor. The Chairman confirmed the revised date for the Civic Council Meeting, which would now be held on Tuesday, 29th May 2012 at the Town Hall, Swadlincote. He also publicised the Civic Dinner, which this year would be held on 10th March at The Pavilion, Branston Golf Club. Finally, the Chairman urged Members to support a raffle in aid of his charity.

CL/77. **LEADER'S ANNOUNCEMENTS**

The Leader of the Council reported on the significant investment in the Nestlé factory at Hatton, which would create a further 125 jobs at the factory. He gave thanks to the Chief Executive for his assistance and congratulated the company, explaining the scale of investment by Nestlé in the area over recent years.

CL/78. HEAD OF PAID SERVICE ANNOUNCEMENTS

The Chief Executive echoed the sentiments of the Leader, confirming also the jobs safeguarded as a result of this investment. He then explained plans for the Council to engage with the community in commemoration of the Queen's Diamond Jubilee. This would include beacons, identifying the availability of small grants for street parties, information on the Council's website and a relaxation of certain street naming arrangements. He also referred to plans for a "picnic in the park", the Liberation Day, which would have a Jubilee theme this year and road traffic island planting.

CL/82. REPRESENTATION ON OUTSIDE BODIES

There were no amendments to the schedule of Council representatives on Outside Bodies.

CL/83. PARKING ENFORCEMENT

Members were asked to approve an extension to the current scheme of parking enforcement. Background was provided on the introduction of Civil Parking Enforcement (CPE) through Derbyshire County Council and a formal

Off Street Parking Places Order. All Council car parks were listed within the Order, with enforcement initially taking place at 4 car parks in Swadlincote. It was proposed to add additional car parks to the CPE scheme at High Street, Melbourne, Alexandra Road, Swadlincote, Rink Drive, Swadlincote and Hill Street, Swadlincote. This would necessitate additional hours for enforcement and it was proposed that these be increased to 12 hours per week.

The detail of the report provided further information about each of the car parks it was proposed to commence enforcement on. Appended to the report were details of the financial implications, including those for signage, for which a ring-fenced budget existed. The increased enforcement activity would generate additional costs, which would in turn be offset by an estimated increase in the number of parking notices issued.

Arising from the consideration of this item, Members reported concerns about the access to and egress from the Rink Drive car park in Swadlincote. This concerned the raised walkway to the new cinema and highway safety issues for pedestrians. Ideas were being pursued to improve safety at this location. A Member also asked about the reasoning for the time restrictions imposed on the Melbourne Car Park.
