Disturbance and disruption will be caused to local residents by customers leaving the premises. Some of the customers will have parked in local streets where parking is already a problem for residents.

The Indian restaurant on Derby Rd/ South St is not permitted to open at all on Sunday, the latest closing time allowed them is 11pm. I would suggest this for the proposed development.

I also urge that restrictions are put in place with respect to levels of noise emitted when music live or recorded is being played.
