I NOTE WITH SOME WRY AMUSEMENT THAT THE HOTEL DEVELOPMENT AT 50 DERBY RD, FOR WHICH PLANNING WAS GRANTED, HAS BEEN SUMMARILY AND PERFUNCTORILY ABANDONED IN FAVOUR OF A "BALLROOM", WITH LICENSING TO ENCOMPASS THE ENTIRE GARDEN, ALLEYWAY AND PAVEMENT FRONTAGE.

THE PREVIOUS RÉGIME, TRADING WITH A CLUB-ONLY LICENSE AS THE LIBERAL CLUB, WHICH DID NOT INCLUDE THE GARDEN, STILL MANAGED TO CREATE AN UNPRECEDENTED AMOUNT OF NOISE DURING BOOKED FUNCTIONS. THIS MUST NOT BE ALLOWED TO HAPPEN AGAIN.

TO MEET OBJECTIVE NO. 3: THE PREVENTION OF PUBLIC NUISANCE, I PROPOSE THE FOLLOWING:

- ① ALL WINDOWS AND DOORS TO BE KEPT SHUT DURING LIVE AND RECORDED MUSIC EVENTS.
- ② THAT DOUBLE GLAZING / SOUNDPROOFING BE PART OF THE WINDOWS REFURBISHMENT, TOGETHER WITH SUITABLE BUILDING AIR-CONDITIONING, IN ORDER THAT ① ABOVE CAN BE ACHIEVED.
- ③ THAT THE SOUND LIMITER OFFERED BY THE APPLICANT BE SET BY SOUTH DERBYS. ENVIRONMENTAL DEPT, AND THAT THIS LEVEL, ONCE SET, WILL NOT BE ALTERED.
- ④ THAT THE GARDEN AREA WILL NOT BE LICENSED.
