The Second Annual Assembly of Standards Committees provides an opportunity for members and officers to come together to discuss the practical implementation of the Code of Conduct, the implications of regulations covering local investigation and determination and building confidence in local democracy.

SECTION 66: LOCAL DETERMINATION AND INVESTIGATION

THE RT. HON NICK RAYNSFORD MP, Minister of State for Local Government and the Regions, speaks about the Government's commitment to building confidence in local democracy.


