

## Proposed Police Licensing Conditions for;

### **Willington Sports Bar.**

Twyford Road, Willington.

- 1) No person under the age of 18 shall be allowed on the premises at anytime except in accordance with one of the following provisions;
- 2) Prior to 2130hours any person under the age of 16years will only be allowed access to the licensed area of the premises when accompanied by a responsible adult.
- 3) Any person aged 16 or 17years of age will only be allowed access to the licensed area of the premises until 2300hours when accompanied by a responsible adult. The only exceptions being family orientated events, pre arranged private functions and staff for the purpose of work.
- 4) The only other exception for an individual aged under 18 to be on the premises after 2130hrs is;
- 5) If an individual is under 18 and is a playing member of a team participating in an affiliated league or cup competition being held at the premises on that date, then that individual may be in the licensed area during the duration of the competition on that date. All underage individuals will have their details registered in a log book held at the premises with the name of the competition, date of the competition and the hours that the competition was played between.
- 6) Customers encouraged by staff to leave the premises quietly and respect the needs of neighbouring properties
- 7) A CCTV system shall be installed and operated at all times the premises are open to the public. The recording system must be maintained in good working order and any faults repaired as soon as possible. (it is recommended that all maintenance paperwork be kept to show that the retailer has shown all due diligence in maintaining the system)  
The CCTV recording unit is to be kept secure, to be opened only by the premises licence holder or authorised, designated member of staff.
- 8) All CCTV recordings must be retained for a minimum of 14 days unless negotiated otherwise. Any authorised officer or Police Constable can view the recording at any reasonable time and obtain a copy if required.

**9)** There must be a person trained on the use of the system either at the premises or available to retrieve any recorded images or data upon request of a Police Officer or other authorised person acting on behalf of a Responsible Authority as detailed in Section 13 of the Licensing Act 2003.

**10)** All cameras will be of a specification that gives good image quality in low light. Digital recordings are to be made in real time, time lapse not to be used. The recordings will be fit for the purpose. *(For the avoidance of doubt, images shall be clear and in focus).*

**11)** The premise licence holder or DPS shall ensure that the operating lighting levels at the premise will be maintained at a level that will ensure the optimum recording and viewing capabilities of the CCTV system.

**12)** A noise limiting device shall be installed and maintained by the Licensee in such manner as to control all sources of amplified music at the premises in order to ensure that music will be at a reasonable level at the nearest noise sensitive point as determined by the Environmental Health department.

**13)** A record of the agreement shall be held on site and made available to an authorised officer on request.

**14)** A log explaining the guidelines for the noise limiter must be completed by both the DPS and the artist that is using the noise limiting device. This log shall contain guidance on the use and installation of the device and shall also be accompanied by a copy of the agreement with the South Derbyshire Pollution Team, explaining the noise levels.

**15)** At all times when regulated entertainment is taking place the Designated Premises Supervisor or nominated deputy will carry out regular checks of the perimeter of the premises in particular at points adjacent to nearby residential properties to ensure that noise nuisance is not being caused and if it is to take immediate steps to prevent further nuisance.  
*(For the avoidance of doubt, these checks shall be carried out HOURLY from 2100hrs until close).*

**16)** A written record will be kept of those checks and will be made available for inspection to an appropriate officer of the local authority.
