DC/58. **APOLOGIES**

DC/59. **REPORT OF THE HEAD OF PLANNING SERVICES**

The Head of Planning Services submitted reports for consideration and determination by the Committee and presented oral reports to the Meeting to update them as necessary. Consideration was then given thereto and decisions were reached as indicated. The contents of the following reports were noted:-

- (e) ***The installation of traffic control bollards at Brethby Park, Brethby Hall, Brethby (9/2008/1064/NO). Mr T. Harper (applicant) attended the Meeting and addressed Members on this application.***
- (f) ***The variation of condition 13 of planning permission 9/2007/0010/F for the retention of fascia boards at Broadlands, Sutton Lane, Etwall (9/2008/1077/B) – it was agreed to ask the developer when the large advertising billboard outside the development would be removed.***
