



	The minutes were agreed as a true record of the last meeting.  PC Bill Crerar was unable to give updates as he has been recalled and is to be replaced by PC Kev Cassidy. PCSO Dave McMillan gave his and PC Crerar's updates under Agenda Item 3.	
3	Safer Neighbourhoods Sergeant's Overview / Priorities Update	Action
	Sgt Summers reported the latest year to date crime statistics covering 1 April to 30 June 2015 as follows: <ul style="list-style-type: none"> <li>• Assault down from 16 last year to 12 this year</li> <li>• Robbery up from 0 last year to 1 this year</li> <li>• Sexual offences up from 0 last year to 5 this year</li> <li>• Dwelling burglary theft down from 3 last year to 2 this year</li> <li>• Non-dwelling burglary theft up from 11 last year to 12 this year</li> <li>• Theft of motor vehicle up from 2 last year to 3 this year</li> <li>• Theft from motor vehicle up from 5 last year to 7 this year</li> <li>• All theft (including other) up from 40 last year to 44 this year</li> <li>• Damage (including arson) down from 22 last year to 5 this year</li> <li>• Drug offences remain the same at 2 each year</li> <li>• All crime (including miscellaneous) down from 82 last year to 72 this year</li> <li>• Anti-social behaviour up from 59 last year to 65 this year</li> </ul> Sgt Summers highlighted the increase in sexual offences, but reassured the meeting that this follows the national trend following the Jimmy Savile case in that people are more confident reporting such issues to the Police. Sgt Summers also mentioned that damage offences have returned to normal levels now following a spate of car scratching being reported last year.  Sgt Summers requested that parking concerns be logged by dialling 101. The PCSO will then address concerns and report back on actions taken.	

	<p>All crime figures are available on line and on the police website.</p> <p>PCSO McMillan gave his update including action points from the last meeting as follows:</p> <ul style="list-style-type: none"> <li>• The issue of HGV's illegally using roads as shortcuts was addressed by PC Crerar, PCSO McMillan and Trading Standards officer. On 23 March there were no sightings during a visit to Drakelow, but 2 tickets were issued on Woodville Road, Overseal. A follow up visit on 30 March resulted in 1 ticket at Drakelow and 1 at Overseal. Discussions were held with transport managers at Reabrook at Moira and the building site at Hepworth Road, Woodville in order to try to educate drivers about weight restrictions.</li> <li>• Inconsiderate parking at Rosliston – PCSO McMillan issued 4 tickets last Sunday.</li> <li>• Drug offences – 1 person is on bail charged with the production of cannabis at Coton-in-the-Elms. 1 call was received about a youth smoking a small amount of cannabis at the youth shelter at Overseal. 2 people are being charged with the production of cannabis at Linton Heath.</li> <li>• Crime Prevention Officer has given advice on site security at building sites at Drakelow and Coton Park. No crimes have been reported recently.</li> <li>• Number Plate Operation will take place at Overseal next week.</li> </ul>

	<p>Phil Marriott apologised to those who may not have received their minutes and paperwork in time. He followed with his report as follows:</p> <ul style="list-style-type: none"> <li>• No funding applications received for this area so far. Phil reminded the meeting that funding is available for appropriate projects.</li> <li>• Phil emphasised the importance of using good quality locks, coach bolts and non-return head screws to protect valuables in sheds from thieves. The Safer Homes Scheme helps vulnerable people by providing locks and alarms ensuring homes are properly secured free of charge. Anyone can refer vulnerable people to the CVS for this service.</li> <li>• Liberation day took place on 22 May and was very successful again. Entertainment was provided by a Beatles tribute band.</li> <li>• Phil highlighted a variety of leaflets he had provided such as How to Stay Safe Online; Green Dog Walker Scheme; Summer Activities for Children and the Safer South Derbyshire Partnership update newsletter.</li> </ul>	<p>PM to order new supply of Green Dog Walker leaflets for SDDC offices</p>

	<ul style="list-style-type: none"> <li>• Resident raised ongoing issue of cold calling at Linton despite window stickers and an article in the Burton Mail. Phil Marriott agreed to revisit the problem with Trading Standards.</li> <li>• Resident raised ongoing issue of dog fouling at Linton. He also highlighted new procedures used by the local authority in Daventry as reported in a national newspaper where dog walkers receive an instant £100 fine if found not to be carrying poo bags. Sgt Summers suggested that more information be sought with a view to implementing similar procedures in South Derbyshire using the Crime &amp; Policing Act introduced last year.</li> <li>• Resident reported picking up spliffs in playground at Linton recently.</li> </ul>	<p>PM to contact Trading Standards</p> <p>PM to seek advice from Legal Dept</p>

LA/01 **APOLOGIES**

Apologies for absence from the Meeting were received from Heather Wheeler MP

LA/03 **CHAIRMAN'S ANNOUNCEMENTS**

Councillor Pat Murray introduced himself as the new Chairman of the Linton Area Forum and District Councillor for the Seales Ward.

Councillor Beth Hall was proposed as Vice Chair by Councillor Bob Wheeler and duly seconded by Councillor John Grant.

Councillor Neil Atkin introduced himself as the new Chair of South Derbyshire District Council and outlined his aims for the coming year. He named his theme for the year as Unsung Heroes in the Community.

## **South Derbyshire Sport, Recreation, Community Facility Strategy**

A strategy for the future provision of built community facilities, including formal open space and play is being developed. The Strategy will aim to provide a plan for the provision of community infrastructure for the growing population, building on the significant progress made in recent years. Parish Councils and community groups will be consulted and a workshop will be held in September to allow more in depth discussion with stakeholders.

## **Derbyshire Cycle Plan**

The County, City, Districts and a number of other bodies are producing a Plan for Cycling which aims to raise the participation of cycling in the County significantly over the next decade. The consultation process will be promoted from next week via the Derbyshire Sport website and the District Council will host a briefing session for interested parties. A South Derbyshire Action Plan will be developed from that briefing session and will feed into infrastructure development and cycle participation and events.

## **Grove Climbing Centre**

A £1million development of a Climbing Centre in Swadlincote at the Green Bank Leisure Centre is progressing with a completion date of October. A further stage of the project includes the provision of a Skatepark in Newhall Park and an Outdoor Gym in Eureka Park

## **Members and Parish Council Briefings**

Following on from the sessions that were delivered in previous years, a new series of briefing sessions are planned for the coming year starting with Sport, Recreation and Open Space Strategy and Development on 16 September. The full programme of dates for 2015/16 is as follows:

16 September 2015	Sport, Recreation and Open Space Strategy and Development - Reducing Physical Inactivity and Developing a Community Facility Infrastructure
14 October 2015	Planning and Enforcement - What is a Planning Consideration?
18 November 2015	Environmental Protection - Food, Noise and Nuisance
27 January 2016	Refuse and Recycling - Keeping the District Clean and Green



In addition, following the meeting, Safer Neighbourhood Wardens visited both Pound Stretcher and B&M stores to seek reductions in the levels of external litter. Verbal requests for action were made to the store managers at both sites and within two weeks significant improvements in the levels of external litter were observed at both sites.

LA/06 **PUBLIC QUESTIONS ON ISSUES RAISED BY RESIDENTS**

Discussion followed regarding a County Council Scheme aiming to encourage residents to park off-road. Clearer information regarding the exact costs involved to install dropped kerbs would be helpful to residents. A suggestion was made to convert wide grass verges currently being churned up by vehicles into laybys. The Forum Liaison Officer agreed to clarify the issue next time.

***ACTION – Forum Liaison Officer to report back to a future meeting***

An empty house in Netherseal has been falling into a state of disrepair for many years since the owner died and his son is in prison. Apparently the property does not appear on the land registry so the District Council has advised that nothing can be done.

***ACTION – Stuart Batchelor to investigate any possible action and report back to future meeting***

Improved signage regarding width and weight limits is required around the Bailey Bridge in Walton on Trent. Large vehicles have nowhere to turn around resulting in chaos. Discussion followed regarding the timescales involved in building the Walton bypass bridge.

***ACTION – Forum Liaison Officer to review the issue and report back to a future meeting***

Concerns were expressed regarding the impact of the new housing development and the new Power Station proposed at Drakelow in terms of increased volumes of traffic. The Forum Liaison Officer replied that these issues will have been discussed with the Planning Authority and a traffic impact assessment will have been carried out.

A Planning Enforcement Committee is due to be held at 6.30pm on 14 October 2015 when the plans will be discussed.

Additional concerns were expressed regarding the shortage of school places. A study into this has revealed that it is possible to build onto existing schools.

Continuing issues regarding potholes at Linton Heath and Netherseal were raised. The Forum Liaison Officer asked that any dangerous potholes be reported to the County Council.

At the last Linton Area Forum held on July 15, 2015, at Coton in the Elms Community Centre, the following issues were raised and a progress report is provided.

**Derbyshire County Council Issues:**

**Cadley Hill Roundabout, Castle Gresley: Carriageway Concerns (SBS 8051318)**

Carriageway works for the A444 Cadley Hill roundabout will be considered for inclusion in the Capital Scheme submission for the next financial year (2016-2017).

As part of an A-classified route, the roundabout will continue to be monitored during regular routine inspections and any safety defects will be identified and repaired as appropriate.
