Walton-on-Trent, with Croxall-cum-Oakley, and Coton-in-the-Elms with Rosliston; Linton and Castle Gresley; Seale and Lullington

A scheme to create two new united benefices in accordance with the Repton deanery plan.

## Seale and Lullington and Coton-in-the-Elms

- 1. The parish of Coton in the Elms shall be separated from the united benefice of Walton-on-Trent with Croxall-cum-Oakley and Coton-in-the-Elms with Rosliston and be joined with the united benefice of Seale and Lullington to form the new united benefice of Seale and Lullington with Coton-in-the-Elms.
- 2. The patrons of the new united benefice shall be

The Bishop of Derby Mr R D Neilson Mr C W Worthington

who shall exercise their patronage jointly.

- 3. The first incumbent of the new united benefice of Seale and Lullington and Coton-in-the-Elms shall be the Revd David Adams, should he be the priest in charge at Seale and Lullington and minister responsible for Coton-in-the-Elms when the scheme is confirmed.
- 4. The parsonage house for the new united benefice shall be Netherseal Rectory, Netherseal, Swadlincote, Derbyshire DE12 8DF.
- 5. The new united benefice shall be in the deanery of Repton and within the Archdeaconry of Derby.
- 6. Each parish within the new united benefice shall remain distinct.

## Walton-on-Trent with Croxall-cum-Oakley, Rosliston and Linton and Castle Gresley

7. Linton and Castle Gresley shall be united with Walton-on-Trent with Croxall-cum-Oakley, and Rosliston to form the new united benefice of Walton-on-Trent with Croxall, Rosliston with Linton and Castle Gresley. 8. The patrons of the new united benefice shall be

who shall exercise their patronage jointly.

- 9. The parsonage house for the new united benefice shall be The Rectory, 2 Station Lane, Walton-on-Trent, Swadlincote, Derbyshire DE12 8NA.
- 10. The parsonage house known as The Vicarage, 40 Main Street, Linton, Swadlincote, Derbyshire DE12 6PZ shall be transferred to the Board of Finance for sale.
- 11. The new united benefice shall be in the deanery of Repton and within the Archdeaconry of Derby.
- 12. Each parish within the new united benefice will remain distinct.
