APOLOGIES

CYS/38. MINUTES

The Open Minutes of the Meeting held on 4th December 2006 and the Special Meeting held on 15th January 2007 were taken as read, approved as true records and signed by the Chair.

CYS/39. DELIVERY OF COUNCIL SERVICES VIA THE POST OFFICE NETWORK

The Committee considered a report which advised Members of the decision from the Council Meeting on 25th January 2007 in respect of the delivery of Council Services via the Post Office Network. At that Meeting the Council resolved as follows:-

- (1) That the Council explores the delivery of services via the Post Office Network and that discussions continue with the National Federation of Sub-Postmasters.
- (2) That the possibility of the Safer South Derbyshire Partnership delivering out-reach services via the Post Office Network be explored.
- (3) That a campaign be undertaken to promote the Rate Relief Scheme to the National Federation of Sub-Postmasters, in order that Post Offices in the District can maximise their opportunities in making a claim.
- (4) That an Information Kiosk be installed on a trial basis at a Post Office site, preferably in the north-west of the District.
- (5) That Council planning policies in the local development documents support the provision and location of Post Offices in villages, where significant new development is planned.

The Committee was advised that a meeting involving both Officers and the Chair of this Committee would take place on 22nd February 2007 to discuss progress on the delivery of Council services via the Post Office Network.

***It was agreed:-***

- ***That the report of the Community Scrutiny Committee on the delivery of Council services via the Post Office Network to the Council Meeting on 25th January 2007 be copied to all postmasters in the District, the National Federation of Sub Postmasters and all Parish Councils in the District.***
- ***That Officers investigate those areas in the District where Post Office services are not available, but which have buildings where Post Office services could be located and this matter be considered as a possible item for scrutiny in the future.***

**CYS/40. ARRANGEMENTS FOR STREET SCENE REVIEW**

The Committee was advised on the progress made with the Street Scene Review following the approval of this Committee's proposals by the Environmental and Development Services Committee. A supplementary report on this matter was circulated to all Members present at the Meeting.

***It was agreed that a meeting of the relevant District Council Officers, the Chair of this Scrutiny Committee and the Chair of the Environmental and Development Services Committee be arranged to discuss progress on the Street Scene Review and that a meeting then be organised between the above parties and representatives from Derbyshire County Council.***

**CYS/41. CLEAN NEIGHBOURHOODS AND ENVIRONMENT ACT**

A report on the new powers introduced by the Clean Neighbourhoods and Environment Act 2005 was circulated to all Members present at the Meeting. Members were advised that the Clean Neighbourhoods and Environment Act introduced new powers for local authorities which included the ability to serve Fixed Penalty Notices for environmental offences and also introduced significant changes to the Fixed Penalty Notices regime.

The main provision of the Act which affected the Council were detailed as follows:-

- Nuisance parking
- Abandoned vehicles
- Failure to produce authority (waste transfer notice)
- Failure to furnish documentation (waste carriers licence)
- Litter
- Litter/street litter control notices
- Unauthorised distribution of literature
- Graffiti and fly posting
- Offences in relation to waste receptacles
- Offences under Dog Control Orders

***It was agreed:-***

- ***That the Council's Corporate Management Team be requested to report back to this Committee on arrangements made for the exercise of the new powers available under the Cleaner Neighbourhoods and Environment Act 2005.***

- ***That the Head of Environmental Services be requested to submit a report to the next Meeting of the Committee on the number of Fixed Penalty Notices issued under the Clean Neighbourhoods and Environment Act 2005.***

#### CYS/42. DERBYSHIRE PCT: MEETING ARRANGEMENTS

The Committee was advised that its Chair and the Council's Chief Executive would be meeting with the Derbyshire County PCT Chief Executive on 22nd February 2007 to discuss relevant PCT issues.
