## HEARING FOR AN APPLICATION FOR THE VARIATION OF A PREMISES LICENCE UNDER THE LICENSING ACT 2003

#### 1. PURPOSE

1.1 To determine an application to vary a premises licence received by this Authority on 28<sup>th</sup> May 2015 from Marston's Plc. A copy of the application is attached as **Appendix 1** and a copy of the existing premises licence is attached as **Appendix 2**.

#### 2. BACKGROUND

- 2.1 The applicant is seeking to vary the current premises licence as follows:-
  - to extend the terminal hour for licensable activities;
  - to extend the opening hours of the premises;
  - to authorise seasonal variations for licensable activities; and
  - to remove the condition restricting the use of the external area which states "The licensee shall ensure that no alcohol is consumed outside the premises after the hours of 22:30 hours".

Further details are indicated in paragraph 3 below.

#### 3. APPLICATION DETAILS

3.1 The applicant requests the Licensing Authority to permit the following:

After negotiation with the applicant's solicitors, Derbyshire Constabulary have withdrawn their representation as the applicant has formally amended the hours requested on their variation application and agreed to add two additional conditions to the operating schedule. #### 4.2 Other Parties

Written representations have been received from 15 residents during the 28 day consultation period based on the prevention of crime and disorder and the prevention of public nuisance licensing objectives. Three of these residents have requested that they remain anonymous. Copies of all of these representations are attached at **Appendix 6.** 

Written representations have been received from Councillor John Harrison and Councillor Jim Hewlett, the elected District Councillors for the Melbourne Ward, during the 28 day representation period based on the prevention of crime and disorder and the prevention of public nuisance licensing objectives. Copies of their representations are attached as **Appendices 7 and 8.** 

4.3 A map showing the location of the premises is also attached as **Appendix 9.** 

#### 5. OTHER RELEVANT CONSIDERATIONS

- 5.1 The Authority should consider its responsibilities under the Crime and Disorder Act 1998 and the Human Rights Act 1998 when considering the fair balance between the interests of the applicant and the rights of local residents.
- 5.2 Any decision taken by the Sub-Committee must be appropriate and proportionate to the licensing objectives being pursued.
- 5.3 Members are reminded that whenever they make a decision under the Licensing Act 2003, they have a duty to act with a view to promoting the licensing objectives.
- 5.4 When considering any representations, only those issues relating to the four licensing objectives should be considered and appropriate weight given to the importance and relevance to the application and each representation.
- In making its decision, Members must also have regard to the Statutory Guidance issued under section 182 of the Licensing Act 2003 and the Council's Licensing Policy. If Members depart from either, they must specify their reasons for doing so.

#### 6. DETERMINATION

- 6.1 The Sub-Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
  - 1. Grant the licence in accordance with the application;
  - 2. Modify the conditions of the operating schedule by altering or omitting or adding to them;
  - 3. Restrict from the scope of the licence any of the licensable activities to which the application relates;
  - 4. Reject the whole of the application.
- 6.2 Members are asked to note that they may not modify the conditions or reject whole or part of the application merely because they consider it desirable to do so. It must be appropriate to do so in order to promote the licensing objectives and any such step must relate to any outstanding representation made.
- 6.3 If Members grant the application, the details of the operating schedule will be incorporated into the licence as conditions. The licence will also be subject to certain mandatory conditions.

#### 7. RIGHT OF APPEAL

7.1 Members should note that the applicant or persons making representations have the right of appeal against any decision made by the Sub-Committee.



With regards to written representation regarding the above premises, I confirm that my Manager, Matthew Holford, will be in attendance. He will not be calling any witnesses.

My objection relates to the variation of the hours of use restriction on the outdoor area. The garden use for licensable activities is currently restricted to 10.30pm, and the applicant sought to vary this to be in line with the variation of general opening hours (i.e. beer garden opening hours 2.30am weekends and 1.30am weekdays). I am of the opinion that noise from patrons using the garden, and access and egress to rooms of the premises where amplified music is regularly played will be likely to cause a public nuisance to neighbouring residents during these extended, noise sensitive hours.

I have visited the premises and, following discussions with the DPS and the applicant's solicitor, as no other noise control options were readily apparent, the DPS agreed that an 11pm cut off time would meet their business needs.

Provided this is effectively managed then I have no evidence to suggest that this will give rise to an unreasonable impact on neighbours. At the time of writing despite repeated requests I have been unable to get written confirmation of this agreement from the applicant.



Dear Sirs,

I am writing to object to the application made by the Alma Inn (of 59 Derby Road, Melbourne, SDDC/001975) to extend its licencing hours on weekdays and at weekends, and to remove the late night outside drinking ban.

I live directly opposite the establishment and am deeply concerned about the noise levels and increased anti-social behaviour associated with later opening hours. Already, pub-goers are often a noise nuisance at weekends and I am concerned that this will worsen with later opening hours. The properties directly opposite the pub are subject to conservation restrictions, and are therefore restricted to single glazing. Noise from people leaving the pub late at night is already a disturbance and this will only worsen with extended hours. Allowing outside drinking later into the night will also increase noise disturbance for local residents.

In the past year, I am also aware of at least two incidents of antisocial behaviour when the Police have been called to the pub premises. Again, I am concerned that this will only increase with later opening hours. In one instance I returned to my property late in at night to find an individual lying in the doorway having left the Alma Inn. This antisocial behaviour will be amplified with extended opening hours.

Given that the Alma Inn's licence was put under review in 2012 following "repeated and consistent breaches" of the conditions of its licence I believe that the application to extend its opening hours and removing the ban on late night outside drinking should be denied due to its residential location and the negative impact this would have on nearby residents.

As a resident of South Street, Melbourne, I would like to object to the application to extend the licensing hours of The Alma Inn. Since the opening of Amalfi's restaurant and the extended opening times of the Zeerah's restaurant we have noticed an increase in the noise and traffic particularly in the bottom half of South Street. On numerous occasions the street has been blocked by customers parking cars inappropriately and delivery vans blocking access. At times, it is extremely difficult to exit the street onto Derby road and to park in the street. At least at the moment we know the noise and disruption is contained within reasonable hours. Although it is also worrying whether emergency vehicles will have access to South Street at such times.

Extending the opening hours of the Alma Inn to 1.30 in the week and 2.30 at weekends is inconceivable given that the pub is located in a residential area. As a local resident to the Alma (I live opposite) I strongly object to the application to extend hours of opening. The last time that the Alma tried to extend their hours, the police objected saying:

'Given the residential location of the Alma Inn there is a likelihood of increased complaints regarding noise and antisocial behaviour as people make their way home at a later time. The streets are quieter at this time of night so any noises tend to be amplified'.

This statement will still stand true. Living opposite the Alma Inn, it is noisy in the evenings, particularly weekends and I have heard neighbours shout from their windows to people leaving because of the noise they make and their disregard to local residents. As people leave, they can stand talking (more often arguing and shouting - we have heard many drunken arguments in the street as people head to the pub later in the evening or leave after it has closed), I am a single mum to a 5 year old and would not dream of asking someone who has clearly had a lot to drink to quieten down, for worry about what the consequence of that may be. This is without the people who stand outside smoking because of the smoking ban, so of an evening there is, more often than not, people standing around outside.

The other concern I have is that opposite the Alma there is a restaurant called Amalfi White, and next door an Indian Restaurant called Zeerah. If the hours are extended at the Alma, it will give them rise to try to extend their hours too. On busy Friday and Saturday evening, the noise generated from the three can be loud in the street outside. If the Alma gains its extension, then that opens the doors for the others to try to follow suit, making the problem of noise (that already exists) much, much worse. Not to mention the extra strain it would add to parking as people are in the area for longer. This is already a nightmare in Melbourne.

The Alma Inn has tried and failed to extend their hours so many times in the past, to believe it would be beneficial to extend their hours this time age 45 or yould be a joke, as the same issues that have prevented it before will still exist.

Your comments: These comments refer to the Alma Inn Melbourne. The Alma Inn is a drinking pub that has made little effort to extend its offer to food. It is situated in residential area with the unofficial "beer garden" five metres from my bedroom window. The current restrictions minimise the noise from the pub late at night but the noise on a summers day shows the potential noise levels. Further there is often very bad language particularly when there is small groups of drinkers as they are not aware that we are just behind the wall. The application provides no evidence that things have changed since 2005 and in particular the view held by the police that extended hours are likely to lead to an increase in noise and anti-social behaviour. In fact I have had to make a complaint regarding noise and drinking outside after 10.30pm, in fact this went on for 15 minutes at about 11.30pm disturbing our sleep. Removing this restriction would make a nonsense of the Planning Restriction on the use of the outside smoking shelter that cannot be used after 10pm because of the threat to the amenity of the residents (9/2012/0790) This application is nothing but an attempt to make the Alma the last bar open in Melbourne with all the problems associated with late night drinking including the noise of the clients leaving the area at closure in the early hours of the morning.



The hours being applied for are the same as those sought when the licence was first applied for. I wish to object to any alteration to the current hours for the same reasons that these hours were refused when the licence was originally granted; A1 refers

In particular the representations say:-

'The Alma Inn at Melbourne have submitted an application for a new premises licence, and have asked to serve alcohol until 1am (01:00hrs), Sunday thru Thursday and until 2am (02:00hrs) Friday and Saturday. The police feel that the hours proposed for service of alcohol are excessive'.

Of Particularly relevance to this further application for the same terminal hours is the following reason given at A1.

'Given the residential location of the Alma Inn, there is likelihood of increased complaints regarding noise and anti social behaviour as people make their way home at a later time. The streets are quieter at this time of night, so any noise tends to be amplified'.

The reasons given at A1 for objecting to the hours requested at the granting of the licence are as relevant today as they were then if not more so. The as yet unoccupied development of 55 Derby Road adjacent to The Alma Inn where multiple residential units are currently being developed increases the need to maintain the protection of residential properties from late night noise, crime and disorder and anti social behaviour - not to diminish this protection.

Furthermore the reasons given by the licensing committee for granting the reduced hours currently enjoyed by The Alma Inn and for imposing the condition the variation seeks to remove are equally relevant today; A2 refers.

These reasons being;

'Having taken into account the four licensing objectives, the guidance issued under section 182 of the Licensing Act 2003, the Councils Licensing Policy and the Human Rights Act 1998, the panel sought to balance the interests of the applicant and the representations made by interested parties.

The panel felt it was reasonable and proportionate to allow the premises licence, in part, with amendments subject to the conditions specified which are imposed to specifically address the concerns raised, in particular the prevention of public nuisance, the prevention of crime and disorder and public safety.'

The current application to vary the licence hours seeks to upset the above balance in favour of the Licensee thereby undermining the Licensing Objectives.

2/. The application seeks the removal of the following condition:-

The licensee shall ensure that no alcohol is consumed outside of the premises after the hours of 10:30 pm. - 'The Condition'.

I wish to object to the removal of the condition for the following reasons -

The condition was imposed upon the licence by the Licensing Committee of South Derbyshire District Council in accordance with their duty to promote the licensing objectives and in response to multiple representations from concerned residents and other people.

The applicant believes there is justification for removing this condition as a consequence of the proposed variation to extend the current permitted hours for the sale of alcohol. (Section L of the application form refers). This is both perverse and absurd when the condition was imposed as a consequence of the grant of the already extensive hours enjoyed by the Alma Inn which exceed other licensed premises in the area. In the event that the extended hours were granted this does not of itself justify the removal of the condition. Nor does the refusal to grant the extended hours.

The application also seems to suggest that because the premises currently operate without particular issue this is a further reason for removing the condition.

Assuming the premises do currently operate without particular issue. This cannot and does not justify the removal of the condition. This merely illustrates that the condition is actually working and is performing its function of promoting the licensing objectives and protecting nearby

What is an acceptable level of noise at say 10:00 pm is totally different to what is an acceptable level of noise at say midnight, and the propensity for disturbance, anti social behaviour and crime and disorder increases the later into the night that you go and the more intoxicated people become. If this were not true there would be no need to have imposed such a condition at these premises in the first place, or at adjacent premises such as 'The Amalfi White' and |'Harpurs'.

When in the past the patrons of the Alma In have been allowed to drink outside the premises late at night, in breach of the condition, this has inevitably resulted in instances of crime and disorder, anti social behaviour and noise nuisance. This is graphically illustrated by the video evidence at A3 (not meant to be exhaustive evidence) and the subsequent police incident number 832 when patrons drinking outside the premises late at night in breach of the condition led to a night of extreme disorder involving the setting alight of one of the patrons and the assault of another. (Letter to the Council at A4 refers) This incident necessitating both police and ambulance attendance. Alec Judge the victim of this particular evenings excess being awarded in excess of £6000 in criminal damages as a consequence. These instances being examples only of the many instances in the past when drinking outside the premises late at night in breach of the condition was commonplace as were

Following the introduction of the Police Action Plan at A5 and the current observance of the condition by the licensee late night crime/disorder or nuisance from people drinking outside the premises has all but been eradicated which only serves to illustrate why this condition should remain. The argument that the condition can be removed because there currently is not a problem from people drinking outside the premises late at night is a self defeating argument. There is not a problem currently late at night because there is a condition preventing the external unsupervised consumption of alcohol that creates the problem in the first place. Remove it and there will be a problem, the history of problems related to late night external drinking at these premises tells us so.

The Alma Inn at Melbourne have submitted an application for a new premises license, and have asked to serve alcohol until 1am (01:00hrs), Sunday thru Thursday and until 2am (02:00hrs) Friday and Saturday. The police feel that the hours proposed for the service of alcohol are excessive, especially when taking into account the current concerns over the UK's "Binge Drinking" culture, and are making representations with regard to this application for the following reasons:

- Given the residential location of the Alma Inn, there is likelihood of increased complaints regarding noise and anti-social behaviour as people make their way home at a later time. The streets are quieter at this time of night, so any noise tends to be amplified
- The Swadlincote Police Section Inspector fears a rise in crime (Assaults, Public Order. Criminal Damage and Domestic Violence), that may come about as a result of longer drinking hours. This is a genuine concern, based upon the fact that traditionally crime and calls for service tend to rise around the extended drinking times on Bank Holidays. This would mean that the issue of police resources would have to be considered, and may mean that officers have to be diverted from other key police objectives such as Community Beat Teams.
- We oppose the 20 discretional days per annum that are asked for if the proposed hours are not granted, and we oppose the premises being able to open for licensable activities to show the broadcasts of televised sporting events. Instead these two points should be amalgamated and treated as discretional or event days. The Association of Chief Police Officers (ACPO) recommends that only 12 "discretional" events should be permitted per annum, with 14 days written notice given to the police, and the police to have right of veto if they feel that any of the four key licensing objectives have been compromised. (The following wording has been used on other premises applications from John Gaunts solicitors. "The non specific sporting extensions in Box M shall be restricted to 12 occasions per annum, on 14 days written notice pages of the police shall have a right of veto on the grounds of contravention of one or more of the licensing objectives, such right of veto not to be unreasonably exercised").

Also this premises application is woefully short of key information for the police to consider the new times proposed, for instance:

- What is the capacity of these premises? This is important for us when considering any
  resource issues and likely impact on crime and disorder.
- In section "P" it mentions that the licensee has undertaken his own risk assessment. Is it
  possible to have a copy of this forwarded to us?
- I appreciate that any door supervisors employed at the premises will be SIA registered, but will the premises use door supervisors? If so what number, and under what conditions? Will a record of door supervisors who have worked at the premises be retained for a period of 12 months and will this record be able to be produced at the reasonable request of a police officer or the licensing authority?
- What measures will be employed to reduce disorder?
- Is there a CCTV system installed at the premises?
- Would the Licensee / Premises owner be willing to comply with the reasonable recommendations of the crime reduction officer?

Until this information becomes available the police will not be willing to consider any variation of the premises license, and recommend to the committee that there should be no change to the current permitted licensing hour's i.e.

Sundays and Good Friday: 12:00 - 23:30

New Years Eve: 10:00 - New Years Day - Terminal hour as existing.

Dear Sirs.

This letter is to appraise you of an unacceptable situation at the Alma Inn. Derby Road Melbourne.

Nuisances and breaches of the peace have regrettably become more commonplace in the last 12 months and I believe that there have been a number of complaints.

The previous licencee retired two weeks ago and with scarcely a moment for breath, the premises re-opened on Saturday, 10<sup>th</sup> March. Around midnight, alcohol was served to hooligans in fancy dress who proceeded to run amok in the early hours: streaking down the high street, creating an infernal din, setting off fire extinguishers, leaving a trail of devastation and, we are led to believe, committing criminal acts concerning arson/causing grievous bodily harm by fire. The police and ambulance service both attended and the police were accompanied by SOCA /Derbyshire scientific police on Sunday morning to conduct enquiries at the Alma Inn.

On Sunday morning, I entered the premises which were in a state of carnage. I asked for the licencee who gave his name as Mr. Derek Moffatt. When I told him that I was a neighbour, he asked the question "what's up?" (as though Saturday night's activity were perfectly normal and acceptable). As I pressed for answers, he then seemed to deny being the licencee, saying the trouble "was nothing to do with him". He could not give the name of the licence holder, however. The police constable taking a witness statement suggested contacting authorities in Derby!

On Monday I rang the police, who confirmed that a D.C Suett (Collar 3221) telephone 03451233333 was investigating but since criminal charges were likely to be pending, no further information could be released.

You will agree that we have an intolerable situation with this public house, which, long suspected of being out of control, is now confirmed to be out of control, with seemingly no one aware of who is the licencee, nor, presumably, responsible for running an orderly premises. One can only conclude that the ultimate desire of the beneficiaries (believed to be Marston's brewery) is to maintain as disorderly a premises as possible to maximise their profits, at the expense of residents.

It has been a blight on our lives for a considerable time and this incident is the final straw. Something has got to be done about it and I would respectfully request your reaction, comments and advice.

An Action Plan was agreed between the Police, the DPS of the Alma Inn and the premises licence holder, Marstons.

The Action Plan was drawn up after a meeting at the Alma Inn to discuss the issues surrounding the pub, and to seek a way

forward to alleviate similar issues occuring in the future.

An outline of the actions include:

- . The Premise Licence Holder or nominated representative shall discuss any incidents from the past weeks trading at least weekly. Any issues highlighted to be documented with clear actions to be taken.
- A further agreement to cease the use of external drinking area from 22.00hrs. The DPS to be responsible for policing this request.
- The DPS to perform regular external checks to ensure groups or individuals are not congregating at the main door way and are making full use of the beer garden when appropriate. A record of these checks to be documented and any actions taken.
- The DPS to inform any emergency service (as appropriate) when an incident has occurred on or within the curtilage of the premises.
- Signs informing patrons of the use of the external beer garden to be displayed in clear unobstructed areas within the venue. Accompanied by notices highlighting that smoking and drinking are not permitted within the immediate vicinity of the main entrance (car park).
- Ashtrays, bins and other paraphenalia to be removed from the main entrance area.

It is proposed to review this plan on 25th May 2012 by the same parties, and any subsequent meeting will be scheduled following this date.





We wish to object to the application by Marstons for an extension to the hours for the sale of alcohol at The Alma Inn, 59 Derby Road, Melbourne, DE73 8FE.

The hours being applied for now are the same as those requested when the licence was first applied for. We wish to object to any alteration to the current hours for the same reasons these hours were refused when the licence was originally applied for. The police felt the hours applied for at the time of the original application were excessive. The reasons for the objections to excessive hours is as relevant today as it was when the licence was originally applied for.

The Alma Inn is located within a residential area and any change to the current hours are likely to cause distress to residents giving rise to an increase in complaints regarding noise and anti-social behaviour as people make their way home at a much later time than they do presently.

Easytiger Platinum have been converting their property (which is adjacent to the Alma Inn) to residential units. Two of these units are now complete and have gone on the market for sale this week. If the application to extend the hours for the sale of alcohol at The Alma Inn are granted, it is likely to adversely affect the saleability of these units and the market value. Not only would this increase noise and disturbance for the residents living directly next to The Alma Inn but could increase the risk of criminal damage to these properties. Due to the properties being in the conservation area, we are unable to protect the properties further from noise pollution due to South Derbyshire's insistence on single glazed windows on the front elevation. Derby Road is a narrow road and suffers from traffic congestion and any increase in traffic is not in the interests of residents and local businesses.

The proposed variation application requests the terminal hour for licensable activities to be 2am the morning after for bank holidays, Christmas Eve and Boxing Day. These are days that most residents would be enjoying relaxation time around their homes and would not be wanting excessive noise and disturbance during these times. Equally during the week, most residents would not wish to be subjected to noise and anti-social behaviour continuing until 1.30am.

The proposed variation application also seeks to remove restrictions on the use of the external area by removing the following condition "the licensee shall ensure that no alcohol is consumed outside the premises after the hours of 22.30 hours". We strongly object to the removal of this condition. The outside area of The Alma Inn is literally the other side of the boundary wall to the residential development of Easytiger Platinum. Easytiger Platinum have planning permission granted for a large residential new build at the rear of the two converted units. This new property is likely to appeal to families. The Alma Inn is not a family pub; the noise and language from this outside drinking area would be a concern to any potential buyer especially those with children. When the property at 55 Derby Road was used as a commercial building, glasses and bottles were regularly thrown over the boundary wall and left outside our property. Not only is this a nuisance, it is dangerous too. When in the past the patrons of the Alma Inn have been allowed to drink outside the premises late at night in breach of the current condition, this has inevitably resulted in instances of crime and disorder, anti-social behaviour and noise nuisance. What is an acceptable level of noise at say 10:00 pm is totally different to what is an acceptable level of noise at say midnight and beyond, and the propensity for disturbance, anti-social behaviour and crime and disorder increases the later into the night that you go and the more intoxicated people become.

The Alma Inn is not located in a city or town where very long licencing hours are more commonly granted. This is a desirable village location and the pub must have licencing conditions that are easily understood, precise, enforceable, and unambiguous and give the same level of protection to residents as that given to residents living around other licenced properties in Melbourne. We cannot see that granting these variations to the conditions currently in place will promote the licencing objectives and protect nearby properties and businesses and will give rise to an increase in complaints to the police.

We would seek that no changes are made to the current conditions of the licence.

### Details of representation:

We wish to object to the application by Marstons for an extension to the hours for the sale of alcohol at The Alma Inn, 59 Derby Road, Melbourne, DE73 8FE.

The hours being applied for now are the same as those requested when the licence was first applied for. We wish to object to any alteration to the current hours for the same reasons these hours were refused when the licence was originally applied for. The police felt the hours applied for at the time of the original application were excessive. The reasons for the objections to excessive hours is as relevant today as it was when the licence was originally applied for.

The Alma Inn is located within a residential area and any change to the current licencing hours are likely to cause distress to residents and disruption to local businesses with an increase in complaints of anti-social behaviour and criminal damage.

The One Off have been established as a business in Melbourne since 2005 and are located quite close to The Alma Inn on the opposite side of the road. Our employees are respectful of the village residential location and care about the residents. Our building was refurbished to enhance the area. We feel that the changes to the current conditions of the licence granted to The Alma Inn would have a detrimental impact on the area and spoil its good reputation. We have concerns that our property could be at risk of criminal damage from people making their way home much later and possibly more intoxicated.



# CLLR JOHN HARRISON'S STATEMENT OF OBJECTIONS TO THE PROPOSED EXTENSION OF THE PERMITTED LICENSING HOURS EXTENSIONS AT THE ALMA INN, MELBOURNE.

- 1. As an Elected Member for the SDDC Melbourne Ward, I submit this my strong opposition to this Application to extend the permitted licensing hours to 01.30 hrs on weekdays and 02.30 hrs at weekends for the reasons set out below.
- 2. Having regard to the statutory Licensing Obectives and, in particular, the prevention of crime and disorder, public safety and the prevention of nuisance, I share the fears of my constituents who live within the immediate vicinity of The Alma Inn, many of whom have submitted direct representations themselves, that the stated objectives are in danger of being regularly breached.
- 3. The Alma Inn is located in a predominantly residential area, which enjoys conservation status, with no discernable ambient noise at 02.00hrs and 03.00hrs when the last customers would be departing, thereby amplifying the noise made by their vehicles, voices or footfall, effectively in the middle of the night. Because of the conservation status of the affected properties, these residents are unable to install double glazing to attenuate the associated noise pollution.
- 4. Sleep patterns of the residents in this vicinity, including young school children, will be endangered adversely, impacting on their ability to carryout work and other activities the next day.
- 5. Notwithstanding that I have not received any complaints since the current Designated Premises Supervisor was appointed some 2 years ago, the fear of noise pollution and anti social behaviour outside the appplicant's direct control remains a real concern to my constituents and, therefore, myself as their Elected Member.
- 6. I strongly recommend refusal.
