Please disclose to the Licensing Authority/ Licensing Committee and Applicants only at this stage.

Disclosure to other parties prior to hearing may prejudice any alternative dispute resolution process and subsequent committee hearing / court appeal.

The Hawk & Buckle has asked to be allowed to serve alcohol until 1am 7 days a week, and whilst it is accepted that the style, concept and location of this venue is not considered "high risk", the Swadlincote police section inspector has concerns that he may not have the resources to deal with incidents that might occur at the premises, due to the large geographical area covered by Swadlincote police section and the limited resources available.

It is suggested that a terminal hour of midnight for weekdays (Sunday – Thursday), and 01:00hrs for Friday and Saturday would be more manageable for the police resources available.

Also the Association of Chief Police Officers (ACPO) recommends that only 12 "discretional" events should be permitted, for which the police must be notified in writing not less than 14 days before the event, and that police shall have absolute veto over any events that are likely to impact on the four licensing objectives.

If the application is amended to reflect the above, then the police will be in a position to withdraw the objection, thereby negating the need for a formal committee hearing.
