1	Chairman's Introduction and Apologies	Action	
	Ed Hicklin welcomed everyone to the meeting and introductions were made by the panel.		
	Apologies were received from David Martin; Tom Mills; Ken Atkin; Adam Seal; Richard Strand		
2	Minutes of Last Meeting (to be agreed) and update on actions		
	The minutes were agreed as a true record of the last meeting.		
	Cllr Harrison requested clarification on the ASB calls to service figures in item 3. Sgt Bateman explained that these would be financial year to date figures compared with the same period last year and would be from 1 st April to the end of month before the meeting.		
3	Safer Neighbourhoods Sergeant's Overview/Priorities Update		
	Sgt Todd discussed recent crime figures from 1 st April to-date compared with the same period in 2012.		
	Overall, year to date since 1 st April a total reduction in crime of 36% 42 fewer theft offences, a 41% reduction although 3 more dwelling burglaries and 1 more shoplifting offence. Police have spent time and effort investigating thefts from motor vehicles and have seen a reduction in that area of 52%, i.e. 12 crimes less. Overall this is a low crime area. Figures may show large percentages but the actual numbers are low.		

	<p>Positive outcomes stand at 21.3% of all crimes being detected.</p> <p>Anti-social behaviour is down 42%, i.e. 47 fewer calls for service this year so far since 1st April 2013.</p> <ul style="list-style-type: none"> • PCSO Emma Guest updated the group with work carried out by the Area 3 SNT team since the last meeting. Following a large increase in shed breaks the team have been distributing leaflets giving residents essential advice on keeping their tools and equipment safe. • Residents were urged to sign up to the Community Messaging scheme – Derbyshire Alert, which sends emails out advising of crimes and incidents in local areas. It's also used to issue appeals. There is a link on the Derbyshire Constabulary website which enables registration onto Derbyshire Alert. • Lots of schemes operate in the area including Neighbourhood Watch, Horse Watch and Farm Watch. • Last year saw a rise in allotment break-ins but following positive initiatives by Police and the Partnership, none have been reported this year. • Residents were reminded that local crime figures could be obtained from the Police.uk website • Sgt Todd stated that recently arrests had been made and power tools recovered following a non-dwelling break. • Following complaints of speeding close to the old Aston Hospital site, a site meeting was held to address issues. <p><u>Update on priorities</u></p> <p>Speeding – speed checks have been carried out and the majority of people offending were found to be locals. Cars on Shardlow Road, Aston have been clocked doing excessive speeds towards Shardlow.</p>	
4	<p>Partnership Update / Funding / New Project Ideas</p> <ul style="list-style-type: none"> • Sgt Bateman discussed the current spend on Area 3 projects only totalling £495, leaving available funds of £3,505 until Christmas time. After this any underspend goes into a big pot, which is available for all areas to bid into. • The Partnership has been working alongside the Shout Out group and been involved in school input sessions with a debate group at William Allitt School. • The Partnership is now on Facebook, where stories, initiatives and future events are posted. • The Council's Sports team are running the summer scheme throughout the school holidays and a leaflet detailing all the activities was available at the meeting or by contacting the District Council. • This meeting would be the last for the current Chairman, Ed Hicklin. Vice Chairman is Cllr Peter Watson who will take over at the next meeting. Nomination forms are now available for the new Vice Chair and anyone interested was encouraged to put their name forward. • Sgt Todd and PCSO Emma Guest are now on Twitter and available to follow. 	


	<ul style="list-style-type: none"> • The website Immobilise.com was discussed. This website enables people to register their tools and equipment with serial numbers. Police check this system when in possession of stolen goods. • The Council's Safer Neighbourhood Wardens have dog stencils that they can utilise in parks and open spaces. A stencilled message is sprayed onto the pavement to warn about dog fouling and the penalties for not picking up after your dog. 	
5	Local issues – open forum (20 minutes)	
	<ul style="list-style-type: none"> • Cllr Atkin thanked Police for their response following break-ins at Stenson Bubble and highlighted that a lack of success stories get issued. Sgt Todd confirmed that good news stories are often put out on the Derbyshire Alert system. • Resident raised that pavements around Borrowash bridge have been widened. He requested that signage be put up to advise cyclists to re-join the carriageway as they are not doing so at present and people have been knocked over. • Weston on Trent residents raised that there is a problem with traffic parking on pavements throughout the whole village. This is 24 hours a day and pedestrians have to go into the road as they cannot walk along the pavement. Sgt Todd discussed that the Council deal with parking restrictions and the Police deal with obstructions. He urged residents to call 101 in the case of an obstruction. It was also raised that on Weston Road towards Aston on Trent, vehicles are parked on both sides of the road. Insp. Lidsey confirmed that there was currently a review ongoing with Police powers, which includes parking issues. • Elvaston Parish Council discussed a new bus shelter, which cost £2,000 and had been vandalised. Police stressed that incidents such as this should be reported. • The District Youth Worker in attendance at the meeting discussed the summer provision in Melbourne. • Cllr Harrison raised that boundaries had changed and questioned whether the Police boundaries would be following suit. • Residents asked how to obtain Smartwater. Sgt Bateman advised that this would be a good project for Safer Neighbourhood funding through a local NHW group • Resident raised that at Bolton Moor there had been reports of cats and birds being killed. Police confirmed they were aware of this and a full investigation had been made. • Police advised that it was not recommended to take photographic evidence of vehicles parking obstructively. 	<p>Cllr Davison to raise this issue with Highways</p> <p>Sgt Bateman to raise with Chris Smith</p>

MA/1. APPOINTMENT OF CHAIRMAN

It was noted that Councillor Harrison had been appointed Chairman of the Melbourne Area Forum at the Annual Council Meeting.

APOLOGIES

Apologies for absence were received from D. Martin (Aston-on-Trent Parish Council), K. Atkin (Barrow-on-Trent Parish Council) and N. Hawkesworth and A. Mitchell (Shardlow and Great Wilne Parish Council).

MA/2. APPOINTMENT OF VICE-CHAIRMAN

It was agreed that Councillor Watson be appointed Vice-Chairman of the Melbourne Area Forum for the ensuing year.

MA/3. MINUTES

The Minutes of the Melbourne Area Forum held on 4th February 2013 were noted.

MA/4. **REPORT BACK ON ISSUES RAISED AT THE LAST MEETING**

The Chairman referred those present to the report circulated with the Agenda. An update was provided and questions were invited. There was discussion about the numbers of heavy commercial vehicles crossing the Swarkestone Causeway and the Forum Liaison Officer agreed to seek statistics from the County Council for the last three year period. Related issues raised were the signage on the A50 trunk road, which was a matter for the Highways Agency and the installation of enforcement cameras on the Swarkestone Causeway. It was noted that a section of road between the A50 trunk road and the Swarkestone Bridge was not subject to a weight restriction. There were also rights of access for some local businesses. The Chairman gave a verbal report as a follow up to the water leak in Melbourne and the remedial works undertaken.

MA/5. **PUBLIC QUESTIONS ON ISSUES RAISED BY RESIDENTS**

From a parish survey, concerns had been raised about speeding traffic through the village of Weston-on-Trent. Reference was made to speed surveys in the adjacent village of Aston-on-Trent and a 30mph speed limit was sought between the two villages. There was discussion about the criteria that had to be satisfied when seeking to impose a 30mph speed limit. Differing views were expressed on whether this request should be supported or such a speed limit would be observed. The Forum Liaison Officer was asked take this matter back to the County Council's Highways Department, but it was explained that the setting of speed limits was a matter for the Department for Transport.

Surface water flooding problems were reported due to blocked drains, with particular reference made to the Old Chapel area of Twyford and Wilne Lane in Shardlow. It was explained that a gully mapping exercise was being undertaken, to identify those which needed more frequent maintenance.

There was discussion about repeated damage to the Swarkestone Bridge and Causeway when vehicles collided with the structure. An engineers report was sought on the condition of the Bridge and Causeway and the Forum Liaison Officer was asked to raise this with colleagues at the County Council. Related to this, there was discussion about the feasibility of providing a bypass, the financial implications and whether such a bypass was still on the list of County Council Capital Schemes.

An update was sought on the County Council's review of street lighting, specifically a proposal submitted for Shardlow where alternate street lights would be switched off overnight. An update would be provided to the next meeting.

A district councillor referred to flood warning signage. An Ingleby resident had approached him with an offer to erect and remove such flood signage, to provide a more responsive service. It was suggested that the Councillor speak to the Forum Liaison Officer after the Meeting.

MA/6. COUNTY COUNCIL ISSUES

County Councillor Davison addressed the Meeting about the recently reformed Local Area Committees. He gave an outline of the issues covered at the recent Meeting and those proposed for the next Meeting. County Councillor Mrs. Chilton also commented on this matter.

MA/7. DISTRICT COUNCIL ISSUES

The Chief Executive reported on the commencement of the "easy green recycling scheme". Residents would shortly receive a green wheeled bin in which a variety of recyclable materials could be placed. He publicised road shows on 15th August at Melbourne and Boulton Moor, at which residents could find out more information about the revised arrangements. The Chief Executive responded to residents' questions regarding storage of the bins and confirming that fortnightly collections would continue, with a collection calendar being provided to residents. The current collection arrangements for the elderly and infirm would also continue.

The Chairman also addressed those present. He gave a report about the decision to buy out of the national housing subsidy system and the benefits this would have for South Derbyshire. Related to this, the Council would start building some additional homes to address the significant affordable housing shortage. Finally, the Chairman gave an update on the Melbourne Sporting Partnership scheme.

MA/8. DATE OF NEXT MEETING

The date and venue for the next Melbourne Area Forum would be confirmed in due course.

REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

At the Melbourne Area Forum held on 30th July 2013 at Weston-On-Trent Village Hall, a number of issues were raised. These issues are listed below, together with progress made to date:-

1. SWARKESTONE CAUSEWAY

Enforcement action at Swarkestone Causeway, as carried out by DCC's Trading Standards, for the past 2 financial years, is as follows:

2011/2012

9 enforcement checks conducted (5 of which were in conjunction with the Police) – 48 breaches investigated. 3 prosecutions were taken – operator fined £1800 for 2 offences + costs of £115; operator fined 3 x £1000 + costs of £115; owner/driver fined £1000 + costs of £115 [NB: £1000 per offence is maximum penalty]. 8 complaints were received.

2012/2013

9 enforcement checks conducted (3 of which were in conjunction with the Police) – 30 breaches investigated. 1 prosecution taken – operator fined £270 + £115 costs. 11 complaints were received.

2013/ 11.9.13

4 enforcement checks conducted (1 of which was in conjunction with the Police) – 21 breaches detected. 6 complaints received to date.

A copy of the Weight Restriction Monitoring Form is attached. This can be used by residents to report any vehicles they believe to be in breach of a weight restriction. Completed forms can be submitted to DCC Trading Standards for investigation as appropriate. The forms also allow the department to identify trends in abuses and justify further enforcement checks.

Enquiries have also been carried out with officers in the Traffic & Safety Team, who concur that signage from the A50 is adequate and no benefit is envisaged from providing further signs. If HGV drivers are following their Sat Nav systems there is little that can be done to mitigate for this.

2. LONDON ROAD, SHARDLOW

It is assumed that the section of road referred to is the less developed section of London Road from the church, in an easterly direction, to the Clock Warehouse public house (where it begins to build up again).

The Department for Transport Circular 01/2013 'Setting Local Speed Limits' stipulates that *"The minimum length of a speed limit should generally be not less than 600 metres to avoid too many changes of speed limit along the route"*. The less built-up section of road between the church and Clock Warehouse is fairly short – roughly 350 metres in length – and therefore it would not be appropriate to introduce a 40mph limit over such a short section, between two 30mph limits.

In contrast, the 40mph section between Weston on Trent and Aston on Trent is notably longer – in the region of 1100 metres – and therefore a 40mph speed limit is appropriate under DfT criteria.

3. A5132 TWYFORD ROAD, TWYFORD: CARRIAGEWAY FLOODING

Two gullies were located in this area. One was buried in the grass verge and has subsequently been dug out. Both gullies were then cleaned and jetted on 13 August 2013 and found to be running satisfactorily.

4. DAMAGE TO SWARKESTONE CAUSEWAY

The Causeway is a scheduled ancient monument and any repairs need to be sanctioned by English Heritage. DCC's Structures section is currently preparing an application to English Heritage for a series of year on year repairs. Budget permitting, we would like to start these works in the next financial year. The proposed automated enforcement system, when installed, will hopefully provide a further tool in the protection of the structure.

In regard to the request for an engineering report, we do not have one of these readily available. However, the Causeway had its bi-annual general inspection in recent weeks and the summary from this will be available shortly. The summary will be in a technical format but if some salient points can be drawn from this they will be provided to the forum as appropriate.

A bypass for Swarkestone is included on a long list of major schemes in our LTP3 (Local Transport Plan). It was excluded from a shorter list recently put forward to the new D2N2 Local Transport Board, simply because it wasn't viewed as deliverable within the 2015-19 period which was stipulated in the funding conditions.

The next batch of funding for major projects will be released in July 2014 through the Single Local Growth Fund and DCC will need to review its priorities once the terms of reference for this is established.

5. WILNE LANE, SHARDLOW: CARRIAGEWAY FLOODING

All the gullies on Wilne Lane were cleaned and jetted on 13 August and found to be running.

6. PART NIGHT LIGHTING SCHEME FOR SHARDLOW

It is not possible to guarantee a switch off of every other light as part of the scheme as Derbyshire County Council have a criteria to operate to (there are likely to be many street lights that do not meet the criteria were we to switch off every alternate light).

The Parish Council will be given opportunity to view and comment on the proposals when we have prepared them and we will always try to take on board local issues, provided that there are good reasons for doing so.

The scheme for Shardlow is likely to be undertaken in Phase 20, which is anticipated to take place at the end of this year or early in the new year. As already stated, the Parish Council will be given ample notice of our plans.
