# FM/68. BUDGET REPORT 2011/2012 INCORPORATING THE CONSOLIDATED BUDGET PROPOSALS AND FINANCIAL PLAN TO 2016

Under Minute No. FM/64 of 13th January 2011, the Finance and Management Committee had considered this item. A copy of the report had been provided to consultees ahead of the Meeting. The report detailed the Council's overall financial position for the 2011/12 budget round. Essentially, it built on the financial plan and strategy approved in October 2010 and covered the following points:-

- The Council's provisional financial settlement for 2011/12 and 2012/13 with estimated on-going implications for 2013/14 and beyond.
- The Council's current spending and proposed base budget position for 2011/12.
- The General Fund's 5-year financial projection including proposed spending by policy committees and associated analysis to 2015/16, which formed the Medium Term Financial Plan (MTFP).

- The proposed council tax base for 2011/12 and collection fund position, 2010/11.
- A review and update of the existing capital investment programme and financing available.
- Outline proposals for meeting the shortfall in overall government grant from 2011/12 and the projected budget deficit.

Jo Smith addressed the Meeting, thanking the Council for maintaining grant levels to the voluntary sector. With regard to the National Non-Domestic Rates, it was noted that the Council for Voluntary Services (CVS) did not presently receive 100% rate relief. She was advised to contact Officers within the Revenue Section to ensure that the CVS and all other voluntary organisations were receiving the correct amount of rate relief. Reference was also made to the Government initiative for bringing empty properties back into use. An offer was made by the CVS to support the Council in making the best use of such empty properties. The representatives were thanked for their involvement in the budget process.
