#### REPORT OF THE CREMATORIUM MANAGER

(CM)

#### (a) Statistics

The Crematorium Manager submitted statistical information on the Crematorium since it came into operation. The Joint Committee noted that between the opening of the Crematorium on 15 March 1975 and 31 October 2003 there had been a total of 33,990 cremations.

The Joint Committee noted annual cremation figures for the last five years.

#### (b) Survey Analysis

The Joint Committee received, for information, survey analysis from the applicants for cremation (usually the main mourners).

## (c) Extension to the Anglesey Chapel and Car Park

The Crematorium Manager reported that building works to extend the Anglesey Chapel and Car Park were on schedule and due for completion in December 2003.

#### (d) Improved Access to the Book of Remembrance

The Joint Committee noted that the Book of Remembrance could now be viewed over the Internet visiting the websites at East Staffordshire Borough Council (www.eaststaffsbc.gov.uk) or South Derbyshire District Council (www.south-derbys.gov.uk/crematorium). The three volumes contained all the memorial inscriptions since the Crematorium opened in 1975.

The Chairman reported that there was also a digital Book of Remembrance in the Remembrance Chapel. Memorial inscriptions were viewed by means of a swipe card. Additional screens containing photographs, poems or some biographical details about the deceased could also be arranged.

#### (e) Millennium Wood

The Joint Committee noted that the area of open ground in the Millennium Wood had been sown with wildflower seed. Maintained as a spring/summer meadow, it would contribute to the Crematorium's biodiversity programme.

#### (f) Open Day

The Chairman reported that the Open Day which was held on Sunday, 7 September 2003, had been a success with approximately 80 visitors being shown around the chapel and cremator rooms.

### FEES AND CHARGES

The Joint Committee noted details of the fees and charges which had been approved by the Chairman and Vice-Chairman.
