2. Police Safer Neighbourhood Team (SNT) Report and Police Q&A

Police Community Support Officer (PCSO) Karen Coldicott provided the following update: -

Since the last forum meeting, we have been busy completing our Neighbourhood priorities which have historically been set by concerns raised within these community forum meetings, now decided using additionally using the information gathered internally such as:

- Incidents reported
- Engagement/concerns raised in the community via our social media
- Discussions and meetings with partner agencies (Community Safety Partnership)
- Derbyshire Alert message replies
- Derbyshire Talking surveys in the community.

From the above, the Neighbourhood priorities were and remain: -

- 1. Speeding
- 2. Anti-social behaviour open spaces (parks etc.)
- 3. Anti-social behaviour Swadlincote town centre
- 4. School parking

If you are not already receiving Derbyshire Alert messages, please sign up via www.derbyshirealert.co.uk and complete the Derbyshire Talking surveys so we can see what matters to you.

In terms of good results, a drugs Warrant was executed on March 4, 2022 at Oversetts Road, Newhall whereby a 40-year-old female was arrested for Cultivation of Cannabis and Possession with intent to supply.

A 14-year-old boy has been charged with vehicle interference, public order, and possession of an offensive weapon. He was arrested at St Catherine's Road for allegedly interfering with a stolen moped.



A Jaguar stolen from a driveway in Midway, within 10 minutes of it being stolen the tracker alerted Officers to its location where it was found.

Multiple reports had been made of a motorbike driving dangerously in Newhall with a pillion on the back with no helmet and no insurance on the bike; the motorbike has now been located and seized.

A series of S59's have been issued to nuisance riders on mopeds arounds Newhall Park.

Numerous vehicles have been seized in the local area for either having no insurance or no driving licence.

With regards to a warrant which was carried out at Chestnut Avenue, both class A & B drugs were recovered along with stolen property. Vehicles have also been recovered as a possession of criminal property and occupants of the same address were arrested for possession with the intent to supply, and possession of criminal property.

Speed checks are being completed throughout the area on a regular basis, alongside Community Speed Watch Groups. Please get in touch if you have any concerns about a particular area.

School patrols are being completed throughout the local area. Regular patrols are being completed around parks, community centres and other green areas to try and prevent antisocial behaviour (ASB).

There have been many school, preschool and youth group talks completed highlighting topics such as road safety, anti-social behaviour (ASB), hate crime and how the Police can help.

There have been events conducted throughout the local area and engagement with the community to raise awareness of crime prevention, Derbyshire alert sign ups, as well as Cuppa with Copper.

There are now various ways to report incidents to the Police, you can Call 101, Direct Message @derpol on Twitter, Direct Message Derbyshire Constabulary on Facebook and via the website - www.derbyshire.police.uk

The Newhall and Midway SNT has changed slightly and now consists of: PC Mark Holmes, PCSO Karen Coldicott and PCSO Rachael Jackson.

Councillor Dunn thanked PCSO Coldicott for the update and asked for thanks to be passed onto Sergeant Nizzer and fellow team members for posting informative and humorous posts on social media; it is appreciated by many.

Councillor Dunn raised a concern about the parking issues on the mini islands of Plumber Road and Meadow Lane, as well as the junction of Southdrive and Westwood park.



PCSO Coldicott highlighted that the SNT will speak with the residence of South Drive again and will further look at the regulations regarding mini islands. Any offences noticed by the Police will be dealt with appropriately.

ACTION: PCSO Coldicott to patrol South Drive to look at parking issue and follow up on regulations of mini islands.

Councillor Dunn thanked PCSO Coldicott in advance.

3. South Derbyshire Community Safety Partnership/ Safer Neighbourhood Grants Update

Chris Smith provided the following update:

New Communities Team Service Assistant

Following interviews held earlier this month the Communities Team has appointed Rosie Collins to the role of Service Assistant. Rosie previously worked as a Sports Casual for several years and will join the team on April 5, taking over from Debbie who has moved into a new role as Community Safety Officer.

Police Community Engagement Events

Debbie Punter, our Community Safety Officer has been supporting the police with the community Engagement events around the District, as has Mark from the Safer Homes Scheme picking up referrals and offering people security advice. Offering residence with Community Safety Advice and dealing with Anti-Social Behaviour complaints at such events.

ASB Warning Letters

Claire Rawlins our ASB Officer has worked closely with the SNT team to issue Warning Letters to a group of young people who have been causing ASB in Swadlincote Town Centre over Christmas holidays and into January. Some of the young people were also issued with banning orders from two of the local shops. Debbie has also written out to all the parents of local secondary schools (via the schools) warning the pupils that ASB will not be tolerated.

Gresley Rovers Football Club

Debbie has also liaised with Gresley Rovers Football Club who have supplied sixty free tickets for the Gresley Rovers v Selston game on 26th February. The tickets were distributed to secondary schools local to the Gresley area (Pingle, Granville and William Allitt) to give pupils an opportunity to go to a real-life football match.

Liberation Day

Liberation Day will return this year after a two-year break. It will take place in May at Maurice Lea Park and will be the usual mixture of entertainment and information.



Safer Neighbourhoods and Community Funding

There has been one application received from The Old Post in Newhall for £275 which will go towards a replacement CCTV camera. We are currently just waiting for some additional information before it can be approved.

The money will again be available next year for community projects which are up to £4000. Please contact Chris or Debbie if you have any ideas for projects and we will help you with the application process which is really simple.

Councillor Sean Bambrick (Chair) asked how long is left in order to apply for this year's funding.

Chris Smith answered within the next week or two is the deadline for this year, however the money does roll over to the next financial year.

Debbie Punter raised a question on behalf of a resident regarding ASB on Newhall Park, whether it would be appropriate to install mobile CCTV.

Chris Smith acknowledged it is not a circumstance whereby installation of CCTV can be justified as there are no current issues to warrant putting CCTV cameras up.

Chris Smith highlighted that in line with the current figures, it shows there has been one crime and one ASB incident recorded since October 2021 at the park. It will be closely monitored and will be considered in the future if we do have issues there.

Alan Hillier explained PC Williams has recently asked at the Scout Hut if their CCTV captured any incidents in the park. The main concern is the matter of new, expensive play equipment which is going to be installed in the park, aimed at older children and there is a sense of protection that needs to be put in place for this equipment. Should that be coverage of the park?

Chris Smith reiterated that there needs to be a justification of installation based on the crime figures. The matter will be closely monitored and if issues arise it will be discussed in due course for consideration.

Councillor Bambrick (Chair) thanked Chris Smith for his update and response to the questions.

4. Local Community and Voluntary Sector Projects/ Update

Liz Gumbley, Community Development Manager at South Derbyshire CVS (SDCVS) provided the following service update: -

Active Travel

This service supports people who have no transport and are unable to use public transport to take them to medical appointments - GP, Hospital, Vaccinations. The service is still limited as we do not have too many drivers active and we are being careful about the



number of passenger journeys drivers undertake per day. We are only doing Hospital and GP appointments at the moment as we have to prioritise the journeys for health appointments. Drivers and Service Users are expected to still where masks, socially distance and use hand sanitiser to keep everybody safe. We will not transport anyone with any symptoms of Covid 19 and our drivers will not drive if they have any symptoms.

Befriending

Since March 2020 our Befriending Service has been carried out through telephone calls. Some face-to-face visits have started but this is dependent on many factors the befriendee, the volunteer and some processes. We have to check that this is safe for both parties and carry out new risk assessments. Some volunteers, who started volunteering in the last year telephone befriending, also need to go through extra checks and training before being able to start face to face visits. This takes time and we again need to do this before permitting people to start visiting in person. Please bear with us while we do this.

Home From Hospital

We are beginning to plan to introduce home visits again, but we will be doing so with caution and with procedures in place to keep everyone involved safe.

This service has been open again since April last year and visits were resumed to ensure people's homes are safe and secure and advise them on measures to improve security and to install locks etc to helps this. Food Bank

Our Food Bank is now operating from Hill St Baptist Church in Swadlincote and collection of food parcels is by appointment only on Monday, Tuesday and Thursday from 8am - 3:30pm. Please telephone 07458 305314 (please note this number is for food bank enquiries only, for general CVS enquiries call 01283 219761) or email projectsupport@sdcvs.org.uk to arrange an appointment. If emailing, please include your telephone number with your message so we can get back to you as soon as possible.

The service provides free emergency food parcels to families and individuals in the South Derbyshire area. We also have a fridge and freezer so are also able to support service users with fresh food donated by local businesses.

Anyone who needs emergency food can access the service. On the first occasion that you need a parcel, you can refer yourself to the service. For each food parcel after that, you will need to provide a referral form before you will be given a parcel.

<u>Covid Connectors Project – to set up a Covid Connectors Network throughout South</u> Derbyshire

This is used to empower residents and workforces in South Derbyshire with the information they need to lead the way in the community by giving consistent, timely and accurate information around Covid-19. Since January 2021 the team have been working with 32 Covid Connectors. Through these networks, covid related information has been shared with the Connectors who then disseminate the information to their local communities. 5. Local authority update and public Q&A

Frank McArdle provided the following update: -

Bikeability

The Councils Active Health and Wellbeing Team have secured funding to continue delivering Bikeability sessions to local primary schools for the next financial year, this is thanks to their hard work, dedication and ability to deliver and exceed targets over a number of years.

The Bikeability sessions are a modern version of the old Cycle proficiency whereby young children are taught how to ride bikes safely on the roads but also helps them to gain independence, social skills and a sense of wellbeing.

After Bikeability, children are better at responding to risk and report increased confidence.

As a result, more children cycle to school which in turn improves mental health and wellbeing.

High visibility items provided by the Community Safety Partnership are also provided to each child who attends the course.

Health and Wellbeing

A new Health and Wellbeing section has been developed on the Council's website, <u>Health</u> and wellbeing | South Derbyshire District Council.

The website is based around the 'Five Ways to Wellbeing' and contains information and support on physical and mental wellbeing.

The site also contains the latest 'Well for Winter' booklet and the latest Adult Activity brochure.

ISO14001 Recertification

Following an extensive eight-day external audit of the Council's ISO14001 Environmental Management System, the Council has been awarded re-certification to the international standard for the 12th time.

The audit required the Leadership Team and all services across the authority to provide evidence that the principles and practices of high-quality environmental management were embedded in everything the Council does.

The audit found the Council had made significant advances in its environmental management practices over the last two years with only a few areas highlighted for improvement.

Apprenticeship Update



The Council has employed six apprentices with a seventh currently going through the recruitment process to join as a Business Administration Apprentice in Housing.

The apprenticeship scheme has given the individuals involved the opportunity to gain real work experience and support whilst completing their respective qualification.

The feedback received from both our apprentices and those mentoring or managing them has been extremely positive.

Our goal is to create more apprenticeship opportunities in the coming months.

Careline Update

Derbyshire County Council has extended the current contract for the Careline service for another 12 months, until April 2023 – which is great news!

Careline has also received its Telecare Service Association accreditation - well done to Tina Karen and the rest of the Team.

Frank McArdle went on to respond to a resident question at the end of the last round of Area Forum Meetings, regarding the telecoms mast which has been erected in Newhall. He followed with investigation, the telecoms act gives permitted development to the telecoms companies to place them in those positions without planning able to enforce any conditions upon its location.

Debbie Punter raised a question on behalf of a resident in relation to phoning the Council and it is taking a long time to get through. Debbie has forwarded this onto Lizzie Barton who will look into this.

ACTION: Lizzie Barton to respond to resident in relation to complaint of the time it takes to get through to the Council as appropriate.

Debbie Punter raised a question on behalf of a resident regarding bin collection on Pine Grove. Waste and Transport team are aware and are going to investigate this matter.

ACTION: Waste and Transport to deal with bin collection matter on Pine Grove.

Lucy Felthouse raised a query regarding disposal of the Tetra Pack recycling bin near Hillcrest chip shop which is resulting in matters such as littering and ASB.

Lucy Felthouse explained as a resident on Hawthorne Rise, this street and other surrounding it had the pavements resurfaced at the back end of 2021. Yet, recently, Virgin Media have dug it up again and resurfaced making it look worse than before.

Additionally, Lucy Felthouse raised that outside Newhall Post Office, the roads has been resurfaced in the last few months, yet the chippings are coming off and is worn off completely in certain parts.



Frank McArdle explained in response to The Hill Crest recycling matter, it has been consulted based on a result of several requests. Frank McArdle is happy to take this back to Director of Services to see how this can be reviewed in the future.

ACTION: Frank McArdle to report back to Director of Services regarding Hill Crest matter.

Frank McArdle explained, telecoms have a given authority to enter pavements and locate cables and masts. As a Local Authority, we can do very little to have any control over that.

Regarding the pavement resurfacing matter, Frank McArdle is happy to take this back to the Highway Authority at the County Council to note if they have it programmed to repair.

ACTION: Frank McArdle to raise issue of pavement resurfacing around the area of Hawthorne Rise with DCC Highway Authority.

Councillor Bambrick (Chair) highlighted the road outside of the Post Office is not the only area whereby the chippings are coming away which has been resurfaced.

Councillor Bambrick (Chair) brought this to the attention of the County Councillors on the meeting to take forward the complaint to Highways Authority.

Councillor Peter Smith is happy to take this forward and to potentially get an engineer down from Willington to do a walk around Newhall to look at the areas which have been raised.

ACTION: Councillor Peter Smith to refer matters raised about resurfacing in the Newhall area.

John Pritchard raised a query on Willshee's Recycling Centre based in Stanton. As per the planning permission, it is noted there is a limit to the number of lorries to leave and enter per week. John Pritchard asked how this is monitored by the council?

Frank McArdle explained it is a County Council permission. Frank McArdle will make the enquiry and respond to Mr Pritchard.

ACTION: Frank McArdle to raise enquiry with County Council regarding monitoring the number of lorries entering Wilshee's Recycling Centre in Stanton.

Councillor Peter Smith referred to the previous meeting minutes whereby he took forward an action to follow up regarding a footpath between Church Road and Meadow Lane. Councillor Peter Smith explained he has had communication with County Council Highways and can confirm the footpath has now been adopted and will be maintained at public expense; it is known as footpath 1-11.

Councillor Peter Smith confirmed £7 million has been secured for partial rebuild of William Allitt School.

Councillor Peter Smith explained work is being done to formulate a Speed Watch Group for Woodlane, Newhall. If anyone is interested in joining, to contact Councillor Peter Smith.



Councillor Gary Musson explained there is an upgraded system on the website whereby members of the public can register an account and report things online and track updates on this system which is very effective.

Councillor Paul Dunn asked if the footpath between Church Street and Meadow Lane is open.

Councillor Peter Smith confirmed the footpath between Church Street and Meadow Lane is in fact now open and safe.
