TERMS OF REFERENCE:

1.0 Recommendations

1.1 That the Committee considers nominations from the Etwall Leisure Centre Community Group and co-opts two Members, on a non-voting basis, to the Joint Management Committee.

1.2 That the appointment of County Councillor Routledge be welcomed.

2.0 Purpose of Report

2.1 To provide an update on the co-option of Community Group representatives to the Joint Management Committee.

2.2 To note the appointment of County Councillor Routledge to the Joint Management Committee.

3.0 Detail

- 3.1 At the Meeting on 15th July 2002, the Joint Management Committee gave consideration to the co-option of Community Group representatives on a non-voting basis. A copy of that report is attached at Annexe 'A'. It was agreed to pursue such co-option, subject to the consent of the County and District Councils (Minute No.EL/6 refers).
- 3.2 The proposal was considered by the South Derbyshire District Council at a Meeting of its Community Services Committee on 18th July 2002. It agreed to the suggested co-option of Community Group representatives, subject to the consent of Derbyshire County Council.
- 3.3 Derbyshire County Council has also confirmed that it raises no objection to the proposal to co-opt two Community Group representatives. In accordance with the original 1974 Agreement, the County Council also wishes to resume Member representation and County Councillor Routledge has been appointed to the Committee.
