US/97. REPORT OF THE CHIEF FINANCE OFFICER

Unspent Revenue Budgets 2000/01

Details were provided of a number of budgets that had not been spent in the previous financial year. Traditionally, if a budget had not been spent the money would no longer be available for that purpose and the sum would be transferred to general reserves. This presented particular difficulties in relation to grants which had been approved but not paid. It was proposed to transfer the monies identified into an earmarked reserve for expenditure on the specific items reported.

US/98. CONTAMINATED LAND INSPECTION STRATEGY

It was reported that part IIA of the Environmental Protection Act 1990 came into force on 1st April 2000, to provide a regime for dealing with contaminated land. Local Authorities were required to publish an inspection strategy to identify the contaminated land within their district. The inspection strategy for South Derbyshire had now been prepared, subjected to a consultation exercise and revised to take account of the responses received where appropriate. The implementation of the strategy had been timetabled to take approximately five years, dependant upon the availability of resources within the Pollution Control Section of the Environmental Health Division.

The Council had previously purchased a "Landmark" digital mapping system which had identified approximately 2,300 sites throughout South Derbyshire which would need to be assessed. These would be prioritised with those posing potentially the greatest risk being assessed first. It was proposed to levy a charge for enquiries from companies in relation to contaminated land. The fee suggested was an initial charge of £30 per enquiry made and thereafter a fee of £30 per hour for work undertaken.

In considering the report, Members discussed the financial implications of dealing with contaminated land, the possibilities of securing additional resources from Government to meet these costs and the principles of the "polluter pays". Members also congratulated the Officers concerned for their work in preparing the Contaminated Land Inspection Strategy.

RESOLVED:-

- (1) That the Contaminated Land Inspection Strategy for South Derbyshire, as amended following consultation, be approved for publication and submission to the relevant Government department.
- (2) That approval be given to any future amendments being undertaken at the discretion of the Environmental Health Manager.
- (3) That approval be given to levy a charge for commercial contaminated land enquiries at a rate of £30 per enquiry and £30 per hour thereafter, the charge to be increased in line with annual review of charges.
