In everything we do, Derbyshire County Council is committed to:

Energy and water

Optimising the use of energy and water in Council operations.

Pollution

Identifying and promoting the use of technologies to reduce the emissions of greenhouse gases, both within Council properties and the wider community.

Minimising and, where possible, eliminating the release of any pollutant which may cause damage to health and the environment.

Transport

Reducing the social and environmental impacts of road vehicles caused by County Council business.

Waste

Minimising the generation of wastes by reducing, reusing, composting and

recycling resources and managing wastes safely, responsibly, and by the best practicable environmental option.

Natural and built

Protecting, conserving and enhancing both the natural and built environments: protecting landscape, habitats and heritage by promoting bio-diversity and local distinctiveness.

Environmental education

Fostering a sense of environmental awareness and responsibility amongst elected members, employees, the general public and particularly children and young people through information, awareness-raising and environmental education.

Objective setting

Continually improving our environmental performance by setting realistic objectives and targets and regularly reviewing our progress.

Purchasing and contracts

Including environmental standards in appropriate contracts and service level agreements, and developing conditions to ensure that contractors working on our behalf apply environmental standards as high as our own.

Environmental Management Systems Operating and extending environmental management systems to co-ordinate and monitor County Council activities, ensuring that practices affecting the environment comply with these principles.
