CL/1. **SHARPE'S HERITAGE AND ARTS RESOURCE CENTRE**

Members received a presentation by Mr. J. Oake, Chair of the Sharpe's Pottery Heritage and Arts Trust and Mr. P. Heath, Heritage Officer on the proposed Heritage and Arts Resource Centre. Members thanked Mr. Oake and Mr. Heath for the informative presentation.

CL/2. **APPOINTMENT OF THE LEADER OF THE COUNCIL**

CL/10. **DRAFT PASTORAL SCHEME**

It was reported that in accordance with the Melbourne Deanery Plan, it was proposed to join the united benefice of Ticknall, Smisby and Stanton-by-Bridge with that of Barrow-on-Trent with Twyford and Swarkestone to form one united benefice. The parsonage house for the new united benefice would be the Vicarage at No. 7 Church Lane, Ticknall. The Vicarage at Barrow-on-Trent, presently used for the Industrial Chaplain, would be transferred to the Diocesan Board of Finance for diocesan purposes.

Views had been requested prior to the end of the consultation period of six weeks, which had commenced on 23rd April 2001.

RESOLVED:-

That the draft Pastoral Scheme proposed by the Diocese of Derby under the Pastoral Measure 1983 be noted.

CL/11. **COMMUNITY PLANNING – UPDATE**

It was reported that the Local Government Act 2000 was an important milestone in the Government's plans for reforming and modernising local government. Part I of the Act provided Councils with new powers to promote or improve the economic, social or environmental wellbeing of their area. This was linked to a duty to prepare community strategies within local strategic partnerships and to involve local people fully in the process. A substantial amount of guidance had now been produced by the Government to support these new arrangements and Members received an outline of several sections which highlighted several key components.

The power of wellbeing was designed to encourage innovation and closer joint working between local authorities and their partners to improve the quality of life, opportunity and health of their local communities. Whilst this power did not include any spending limits, it could not be used to raise money and in exercising the power, a local authority must have regard to its community strategy.

With regard to community strategies, each strategy would have four key elements and several guiding principles should underpin the strategy. The strategy should engage and involve communities, actively involve all Councillors, be prepared and implemented by a 'broad local strategic partnership' through which the local authority could work with other local bodies and be based on a proper assessment of needs and the availability of resources. The Government considered that the most effective method of ensuring the commitment of other organisations would involve local authorities working with other bodies through a local strategic partnership. The guidance stressed that all tiers of local government would have an important role to play in developing community strategies and it was important that the different tiers determined a joint approach to strategy

preparation before other partners were approached. This issue was currently being explored through the Derbyshire Partnership Forum which included representatives of the County Council, District Councils, the Police and Health Authorities.

The new duty to prepare a community strategy linked to the new power of wellbeing was likely to have a significant impact on the way in which the Council conducted its business and on its relationship with partners in the public, private and voluntary sectors. It was therefore proposed that a seminar should be organised in order to inform Members of the latest guidance and developments and to explore methods of progressing this important issue. There would be a small cost associated with the seminar, which could be met from existing budgets.

RESOLVED:-

That the report be noted and Officers be authorised to arrange a seminar for Members on the new duty to prepare community strategies and the new power of wellbeing.

CL/12. **'WORKING WITH OTHERS TO ACHIEVE BEST VALUE' – CONSULTATION PAPER**

It was reported that the Department of the Environment, Transport and the Regions (DETR) had issued a Consultation Paper entitled "Working with Others to Achieve Best Value". This set out the Government's proposals to use its powers under the provisions of Section 16 of the Local Government Act 1999 to facilitate partnership working under Best Value. Essentially, the powers under Section 16 would enable the Secretary of State to modify or exclude existing legislation applying to Best Value authorities if he was satisfied that such action would remove a provision which restricted a Best Value authority's ability to achieve its statutory duties under Best Value, and confer on Best Value authorities a power to do anything which he considered necessary or expedient to permit or to facilitate the achievement of Best Value.

The aim of the Government's proposals was to facilitate partnerships between Best Value authorities, and between them and other organisations in the public, private and voluntary sectors. In particular, Best Value authorities would be enabled to provide financial assistance to other bodies in the public, private and voluntary sectors and enter into agreements with them for the purposes of pooling budgets, taking a lead commissioning role and commissioning the delivery of goods and services; form and participate in local authority corporate structures, including companies; provide a wider range of goods and services to partners, whether in the public or private sector; and, in the case of waste management, enable authorities to explore options other than divestment to the private sector or arms' length companies.

The Government wished to ensure that Best Value authorities were able to consider a wide range of options as to how they delivered Best Value, including those that involved partnership working with others. According to the consultation paper, the provision of a new power to promote the economic, environmental and social wellbeing of an area had progressed considerably to achieving this target. However, there were other issues, such

as local trading, delegation and charging, which were not addressed through the wellbeing power. The current proposals were designed to tackle these issues.

Clearly, partnership working was an important service delivery option, especially for small councils. Therefore, the Government's aim of providing a robust legal framework that ensured proper accountability to local people was commendable. However, in terms of detail, the proposals appeared to have several shortcomings. These were highlighted in the policy briefing produced by the Local Government Information Unit (LGIU), which was considered by Members. Of particular concern was the relationship between Section 16 powers and the new wellbeing power.

RESOLVED:-

That the views expressed by the LGIU be endorsed as the basis of a response to the DETR.

CL/13. **PARLIAMENTARY AND COUNTY COUNCIL ELECTIONS 2001 – DESIGNATED POLLING PLACES**

It was reported that prior to each election, the Council designated a list of premises to be used as polling stations. Provisional bookings had been made for those premises used as polling stations for the elections held in 1999, subject to one alteration involving the inclusion of Scropton Riding Centre following the completion of alterations. Members considered the schedule of designated polling places to be used for this year's Parliamentary and County Council Elections and several Members expressed concerns at the locations identified relating to problems experienced at previous elections. The Chief Executive advised that these matters would be investigated accordingly and addressed in preparation for the District and Parish Elections in 2003.

RESOLVED:-

- (1) That the list of designated polling places for the 2001 Parliamentary and County Council Elections, as submitted, be approved.***
- (2) That investigations be made into the issues raised by Members and such matters be considered in the preparation of a designated list of polling places for future elections.***
