

1	Chair's Introduction. Apologies. Nominations for vice-chair	Action
	Apologies were received from Colin Dobson and Councillor Neil Tilley.	
2	Minutes of the last meeting (to be agreed) and update on actions.	
	The minutes of the meeting held on February 15 th were agreed as a true and correct record. Councillor Kim Coe had an action to discuss a potential safety issue at the Swadlincote Christmas lights switch-on with SDDC Cultural Services Manager Malcolm Roseburgh. She had been unable to see him due to his absence from work for an operation, but would meet him before the next event to discuss.	
3	Safer Neighbourhoods Sergeant's Overview / Priorities Update	
	Sgt Graham Summers reported that ASB had been causing problems in the town centre, with previous troublemakers again involved. Police rapidly dealt with the problem using their historic knowledge and offenders were dealt with by way of Fixed Penalty Notices and Community Protection Notices. As a result, calls for service were vastly reduced. McDonald's remained a hot-spot for ASB and there were still calls for service. There had been problems with vehicles attending the eatery. Since the previous meeting there had been serious problems with shoplifting in the town centre. It had risen by 56% and officers had virtually become a shoplifting squad in the previous month. Six prolific offenders who had recently come out of prison had been identified as the problem. Out of the six, one had gone back to prison for 20 weeks, two were on remand and two were on conditional bail. One suspect was still outstanding and police were trying to find them.	
	A lad who had gone through the roof of a town centre property, losing two teeth in the process, before being chased by officers for two hours around Swadlincote and Midway, had been arrested. He was being released from prison in the next couple of weeks and police were prepared to monitor him.	
	Regarding overweight vehicles using Coppice Side, Sgt Summers had details of the vehicles and they had been sent to Trading Standards. A joint operation had been

planned, but it had been put on hold due to the recent spike in crime in the town.

Colleagues in others areas had been supported across a number of issues, particularly the execution of drugs warrants. Operations in Area 5 (Midway, Newhall, Stanton) and in hard to reach areas had been successful. There had also been several vehicles seized under Section 165 of the Road Traffic Act.

In the previous week there had been a significant threat of violence made against Pingle School by a disruptive former pupil who had been moved away from Derbyshire. It had been dealt with and the individual, who was 16 or 17, arrested for what was quite an alarming threat.

An alarming incident had taken place in Midland Road, Swadlincote, the previous day. A resident had covered himself in petrol and threatened to set himself on fire. He had been stopped from doing so.

A new PC had started in the area – PC John Anwar. He was an experienced officer and from the moment he had arrived he had been out arresting people. He'd even walked into a house with a cannabis grow after 'following his nose'! Residents would be protected and the cannabis grower was going to court.

PCSO Claire Statham reported that police had been approached by Castleton Park residents regarding the formation of a Community Speed Watch. Letters had also been sent out regarding inappropriate parking at Pennine Way School during pick up and drop off times. Councillor Stuart Swann asked which roads in Castleton Park would be checked. PCSO Statham confirmed it would be Brunel Way. Councillor Swann asked for Westminster Drive to be focused upon. A resident added that a lot of information could be gleaned from Community Speed Watch, with motorists caught without tax and MoTs on occasion.

4 Partnership Update / Funding / New Project Ideas

lan Hey reported that the partnership had received reports of nuisance motorbikes in Woodville around Finch Close and Vale Close. Descriptions were needed of bikes and bikers.

Liberation Day had been very successful, with 300 over-55s from across the District gathering at Gresley Old Hall for an event promoting services to older people.

The Safer South Derbyshire Partnership had produced a partnership plan 2017-20 and it could be viewed on SDDC's website.

Funding was again available for projects related to crime and disorder. There was £4,000 available to Area 4 and last year (2016-17) only £2,000 was spent. Any project impacting upon crime or ASB would be considered and any ideas should be discussed with the partnership. An application was up for consideration for £500 towards youth activities on the Goseley Estate. The meeting voted unanimously to award the funding.

5 Local Issues – open forum (20 minutes)

Councillor Robert Coe reported that the owner of Salt's in Swadlincote was worried about the regular ASB crowd potentially damaging a curved window as they had been hanging around outside the shop. Safer South Derbyshire had been dealing with the issue as the owner was reluctant to ring 101. Dennis Bateman added that he had been to visit the shop owner and was keen to bring it to SDDC's attention, but not the police for fear of repercussions.

A resident asked whether High Street, Swadlincote, was open to traffic or pedestrianised. PC Stuart Kelly replied that before 10am the street was open to

vehicles. The resident said the previous week a car drove the wrong way along the one-way street. Councillor Kim Coe said everyone was aware the street was a problem. Sqt Summers said police didn't have the resources to keep a permanent eye on the street, with threat and risk assessments used to priorities concerns. PC Kelly added that installing bollards at the bottom of High Street could help the problem. Councillor Swann raised an unfortunate incident when someone reporting a domestic violence issue was kept waiting outside Swadlincote Police Station before not being seen at all. Sgt Summers said the station didn't have an enquiry office and any interaction with the public was on an appointment basis. He had made an appointment for 9.30am but when the woman arrived 20 minutes early she used the phone outside, which connected to the 101 number and not to the station. No-one answered and the woman left before 9.30am, when an officer checked outside only to find no-one there. Nine times out of 10 the officer would have been waiting for the appointment and could've rescued someone from outside. The situation shouldn't have arisen and he'd asked for the process of appointment making to be reviewed. Councillor Robert Coe asked if volunteers could be used for an enquiry office. Sqt Summers said that would be impossible from a union point of view. 6 **Agreed Priorities** ASB and shoplifting. 7 Date of next meeting To be announced. 8 **Enforcement update** Mr Bateman gave a presentation on the work being done by his team at SDDC to combat environmental offences such as fly-tipping, littering, dog fouling and abandoned vehicles. Councillor Linda Chilton said DCC was very aware of fly-tipping. The previous administration had brought charges in for bringing waste to tips and those charges had been rescinded. A resident said South Street and the Cutting in Woodville were still a mess with fly-tipped rubbish.

SA/3 Nomination of vice-chair

Councillor Stuart Swann nominated Councillor Robert Coe to be vice-chair of the meeting for the forthcoming year. The councillors present voted unanimously to appoint Councillor Coe as vice-chair.

SA/4 Chairman's announcements

Councillor Mrs Kim Coe reported on a consultation being conducted by South Derbyshire District Council's Planning Policy department, the Physical Activity, Sport and Recreation Strategy which was due to be adopted by SDDC the following day and the work being undertaken by the Safer Neighbourhood Wardens.

SA/5 The minutes of the meeting held on February 15, 2017

The minutes were approved as a true and correct record.

SA/6 Report back on issues raised at the last meeting

Pedestrian crossing at Hepworths Retail Park

Frank McArdle had an action to raise the positioning of a pedestrian crossing with the owner of Hepworths Retail Park. He was now in possession of an aerial photograph of the site and had a health and safety officer looking into the issue.

Flooding of the roundabout in Civic Way

Mr McArdle updated the meeting that he was waiting for feedback from Severn Trent. The drains in question were in full working order and the problem was not at the locality, but elsewhere, possibly in Darklands Road. The issue would be discussed at SDDC's Flood Liaison meeting.

Flooding under the bridge in Occupation Lane, Woodville

Councillor Robert Coe reported that the problem seemed to have been eased by the building of an entrance and the installation of a new drain.

Potential for a pedestrian crossing / refuge at Castle Road

A resident said he felt a report into a possible crossing suggested it was a pedestrian's own fault if they were run over at the location.

SA/7 <u>Public questions on issues raised by residents</u>

A resident raised the issue of signage for HGVs in Coppice Side. Was it possible to have it improved? Mr McArdle asked the resident to speak to him after the meeting and show him exactly where signs were needed. He would take that information away and see what could be done.

ACTION: Frank McArdle to report back on possible new signage

A member of the public reported that a bollard in Thorn Street, Woodville – off High Street – had been broken and left lying on a verge since 2016. It wanted removing or reinstalling.

ACTION: Tom Sloan to report issue to Derbyshire County Council

Councillor Mrs Kim Coe raised the issue of drivers continuing to go the wrong way along High Street, Swadlincote. There were still bollards in place. Could they be raised to prevent this from happening?

ACTION: Tom Sloan to obtain a report from Derbyshire County Council regarding the bollards

A resident asked about a public footpath sign at the bottom of Coppice Side, Swadlincote, which seemed to have no footpath near it. Could it be removed? Mr McArdle asked the resident to see him after the meeting.

Councillor Mrs Kim Coe introduced Councillor Ray Tipping, who had recently won a by-election in Woodville. She also introduced Councillor Swann, the new Derbyshire County Council representative for Swadline of South. Councillor Mrs Linda Chilton was also offered congratulations for being selected as the Chair of Derbyshire County Council for the year.

SA/8 County council issues

None.

SA/9 District council issues

Mr McArdle reported that at the recent General Election, 76,000 people were eligible to vote in South Derbyshire and 52,000 did, of whom 11,000 were postal voters. It represented a turnout of 69%.

The Festival of Transport had taken place since the previous meeting. It had been a safe, secure and professional festival.

Mr McArdle welcomed Councillor Tipping to the authority.

Swadlincote had switched from holding a farmers' market to a makers' market, hosted by Curly Magpie. Visitors were coming in larger numbers.

The Environment and Development Services Committee had approved a scheme to improve shop fronts on the Delph, Swadlincote. An artist's impression of what the area would potentially look like was impressive. Councillor Mrs Chilton asked how many empty shops there were in the town. Mr McArdle replied that an average market town had 14% of its shops empty. Swadlincote town centre currently had only one shop empty. People wanted to feel good about being in the town and free parking was key. SDDC's members resisted the chance to get an income from it year after year – it was not a way to encourage economic development.

Mr McArdle had asked Morrisons to help with improvements to Ernest Hall Way. The back entrances of traders in High Street, Swadlincote, were often blocked by parked cars and a scheme to discourage parking using tubs of plants was being considered by the supermarket's head office.

Mr McArdle was talking to a company which built care homes for older people about possibly coming to Swadlincote. The secret of a successful town centre was to put people in it.

SDDC's Depot was soon to disappear from its position opposite Sainsbury's and be relocated to an industrial estate. The land would be used for a pub and a Kentucky Fried Chicken eatery. A day centre and residential centre for young people with mental health issues would be built at the rear of the site. Work was predicted to start in September.

A resident asked if the old TG Green site in Swadlineote would be developed. Mr McArdle replied that the site had been bought but the problem was that five kilns, which were protected as a Site of Special Scientific Interest, needed investment. However, there was little commercial value in doing so. The kilns were falling into disrepair and the investor had been hit with a bill before work could even start. Until the issue was solved the site would not get developed.

Councillor Mrs Kim Coe reported that the Festival of Transport had become a charity. The plan was to expand it into a Festival of History. It was a case of 'watch this space'.

A community awards ceremony, sponsored by Toyota, was taking place on October 13, involving the Swadlincote Chamber of Trade and the CVS.

Mr McArdle reported that Sharpe's Pottery Museum was close to delivering a potter and wheel at the museum.

A resident asked if there was anything further to report on the regeneration route at Woodville. Mr McArdle replied that £6.4m was guaranteed to pump prime the scheme.

REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

At the last Swadlincote Area Forum, held on June 13, 2017, at Goseley Community Centre, the following issues were raised and a progress report is provided.

South Derbyshire District Council issues:

1. HGV signage in Coppice Side

A resident raised the issue of signage for HGVs in Coppice Side. Was it possible to have it improved? Frank McArdle asked the resident to speak to him after the meeting and show him exactly where signs were needed. He would take that information away and see what could be done.

ACTION: Frank McArdle to report back on possible new signage
