Dear Sirs,

Please take this email as notification that the Police wish to make representations to the above mentioned premises in relation to an application to vary a premises licence. This application was received by the Police on 04/10/2010. The consultation period therefore ends on 02/11/2010.

The Chief Officer of Police makes this representation on the basis that should this variation application be granted in it's current form, there is a likelihood that the Licensing Objectives will be undermined, namely; the prevention of crime and disorder, public safety, and the prevention of public nuisance.

The area in which the premises is situated attracts an amount of anti-social behaviour. This behaviour is already observed in similar premises in the town of Swadlincote. It is feared that the premises licence, when considered with the proposed variation application, does not contain sufficient safeguards to satisfy the Police that the premises will suitably, and sufficiently, promote the Licensing Objectives.

The Police Licensing Team is currently in consultation with the premises licence holders, JD Wetherspoons, and is confident that an agreement can be reached which will provide the Police with an assurance that suitable safeguards can be proposed within the variation application and eventually attached to the premises licence if the variation application is granted.

If an agreement cannot be reached, the Police will continue with the above representations and further information and evidence will follow in due course.
