# HGS/5. HISTORIC BUILDING AND CONSERVATION AREA GRANT APPLICATIONS

(a) No. 32 Derby Road, Melbourne

#### **RESOLVED:-**

That the applicant be offered a grant of £2,000 towards the eligible costs of £5,937.50 for restoration works to the front and right-hand side elevations of No. 32 Derby Road, Melbourne by the removal of render, cleaning and repair and re-pointing of brickwork, reinstatement of joinery

and the addition of chimney pots, subject to the usual conditions and the additional conditions set out in the report.

(b) Nos. 44 and 46 Potter Street, Melbourne

#### **RESOLVED:-**

That the applicant be offered a grant of £1,512 towards the eligible costs of £3,780.21 for restoration works to the front elevations of Nos. 44 and 46 Potter Street, Melbourne by the reinstatement of four vertically sliding sash windows, subject to the usual conditions and the additional conditions set out in the report.
