(2) That the Committee authorises a financial contribution of £5,000 per annum to this DMP.</p>

10.	<u>AGENDA ITEM</u> PUBLIC SPEAKING AT THE DEVELOPMENT CONTROL COMMITTEE	
	DECISION: (1) That Council be recommended to adopt a scheme for allowing public speaking at the Development Control Committee, as contained within Section three of the Consultant's report, for a trial period of six months, as soon as the necessary literature, procedures and equipment are in place. (2) That five months into the trial period, a report be submitted to Members, in order to determine whether or not the scheme should continue on a permanent basis, either as existing or in an amended form.
