1. PURPOSE

To determine a variation application submitted in accordance with section 34 of the Licensing Act 2003 for the premises known as Oakland Village. (application attached at Appendix 1) pages 6 to 23.

2. BACKGROUND

2.1 The applicant is seeking to amend their existing premises licence which was granted on 8th January 2013 to extend the times when the licensable activities are permitted to occur. The full details are indicated below in paragraph 3.

5.1 No agreement has been reached.

6. OTHER RELEVANT CONSIDERATIONS

- 6.1 The Authority should consider its responsibilities under the Crime and Disorder Act 1998, and the Human Rights Act 1998 when considering the fair balance between the interests of the applicant and the rights of local residents.
- 6.2 Any decision taken by the Sub-Committee must be appropriate and proportionate to the objective being pursued.
- 6.3 Members are reminded that whenever they make a decision under the Licensing Act 2003, they have a duty to act with a view to promoting the licensing objectives.
- 6.4 When considering any representations, only those issues relating to the four licensing objectives should be considered and appropriate weight given to the importance and relevance to the application of each representation.
- 6.5 In making its decision, Members must also have regard to the Statutory Guidance issued under section 182 of the Licensing Act 2003 and the Council's own Licensing Policy. If Members depart from either, they must specify their reasons for doing so.

7. DETERMINATION

- 7.1 The Sub-Committee must take such of the following steps as it considers appropriate for the promotion of the licensing objectives:
 - 1. To modify the conditions of the licence (and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added.
 - 2. Reject the whole or part of the application.
- 7.2 The Sub-Committee may also vary a licence so that it has effect subject to different conditions in respect of different parts of the premises and/or different licensable activities.
- 7.3 Members are asked to note that they may not modify the conditions or reject whole or part of the application merely because they consider it desirable to do so. It must actually be appropriate to do so in order to promote the licensing objectives and any such step must relate to any outstanding representation made.
- 7.4 If Members grant the application, the details of the operating schedule will be

incorporated into the licence as conditions. The licence will also be subject to certain mandatory conditions.

8. RIGHT OF APPEAL

8.1 Members should note that the applicant or persons making representations have the right of appeal against any decision made by the Sub-Committee.

Trident Reach the People Charity has applied to extend the hours of the premises known as Oakland Village so that they may open to the public seven days a week and from 08.00 to 24.30 and to extend the licensable activities until 24.00 seven days a week.

As this is predominantly a residential area and has 2 pubs nearby with the recently flagship Oakland retirement village at its centre this is an application which should be refused for the following reasons.

1. Parking.

There is already a problem at certain times with parking and the Oakland retirement village is not yet fully occupied. I understand that there are 92 parking spaces for the 88 flats and dementia unit including staff for the unit and village. At times vehicles are currently having to park on the frontages of the houses and bungalows surrounding Oakland.

I understand that weddings have been suggested with up to 120 guests.

2. Noise.

This area is predominantly residential with the retirement village plus a significant number of bungalows and houses, mainly occupied by the elderly. A large number of people leaving a function in the early hours will inevitability result in noise and disturbance for the local residents.

Events will create additional noise as by nature they usually have music played loudly.

3. Planning application.

The original planning application and associated publicity material has only ever referred to Oakland as a retirement village.

Surely this is a step too far and will only create more problems.

This will attract larger numbers of visitors and disco music is far louder than most other entertainment. Some occupants of nearby flats have breathing problems so need to keep their windows open.

Parking is inadequate at present and the village is not yet fully occupied.
 There are only 92 parking spaces to accommodate, 88 flats, 2 Visitors rooms, 1 recycling bin and Staff - i.e. Receptionists, Care workers in both the private area and the Dementia Unit, Cleaners, Handyman, Bar workers, Kitchen Staff, Waitresses, Support workers & Administrative staff.
