APPLICATION FOR A PREMISES LICENCE UNDER THE LICENSING ACT 2003

Report of the Head of Housing and Environmental Services

1. PURPOSE

To consider representations that have been made and to determine the application for a premises licence received on the 17th January 2012 from the Rock & Bike Festival (individual applicant named as Michael Stevenson). The application is for a time specified event to run for 4 days proposed to be from 12th until 15th July 2012 (Application attached at Appendix 1).

Matters included by the applicants within the application to promote all four licensing objectives can be seen at Page 19 of Appendix 1 and a Risk Assessment (Appendix 2)

Mr Paul Burke has given his consent to be named as Designated Premises Supervisor for the event. (Appendix 3)

2. BACKGROUND

Previous events of this nature have been held in Sandiacre and Draycott. The applicant attended Safety Advisory Group Meetings at County Hall Matlock in previous years (**Pre-event notes attached at Appendix 5**). In 2008 numbers were limited to 3,000 people and Temporary Event Notices were used.
