

1	Chair's Introduction, Apologies	Action
	Mick Mulgrew opened the meeting and recorded apologies from Councillor Stuart Swann, PC Stuart Kelly, Colin Dobson, Vonny Heath and Ron Lane.	
2	Minutes of last meeting (to be agreed)	
	Minutes of the meeting held on June 30 were agreed as a true record of the last meeting.	
3	Safer Neighbourhoods Sergeant's Overview / Priorities Update	
	Sergeant Graham Summers reported that crime figures in Area 4 were not as favourable as in other areas. Crime had gone up by 14% overall. Sgt Summers pointed out that crime had fallen for a significant period of time and that downward trend couldn't continue indefinitely. He stated that Area 4 was still a safe place, although there had been an extra 85 offences reported this year. That did not equate to a "crime wave".  The reporting of sexual offences has risen in recent years and in the wake of high profile cases more people are coming forward to report crimes. Sgt Summers added that the public now has more faith in the police regarding domestic violence allegations. The number of offences hasn't changed, but the fact they are being recorded has.  Theft-related offences have risen but Sgt Summers said the type of crime can come in patches, with one of South Derbyshire's most prolific burglars having recently been arrested.  There have been quite a few opportunistic thefts from vehicles in recent months. Sgt Summers warned of offenders checking from car to car to find one unlocked. He is part of a police campaign to educate people to lock their cars and while the police will do all in their powers to catch the thieves, they are relying on the public to help themselves in the first instance.

ASB is down but still creeps up from time to time to certain areas. Swadlincote town centre, McDonald's and the library are the known hotspots. Despite a shortage of resources, Sgt Summers says that strategies are in place to deter problem youths. The dance studio near the library has been a particular problem. Inspector Kate Bateman has suggested the youths be invited in for a street dance lesson.

PCSO Lee Walker reported that he had conducted speed and weight checks in Coppice Side on six occasions. Eleven cars had received advisory notices for travelling between 30 and 33mph, with no vehicle travelling faster than that. In conjunction with Trading Standards officers, five HGVs were found using Coppice Side and were given warning notices.

PCSO Walker told the meeting that parking issues remain a priority around schools in the area. Belmont Street is a major area of congestion. With the Lidl supermarket under redevelopment, B&M have allowed part of their car park to be sectioned off for the contractors. Once the redevelopment is complete, the difficulties should ease.

ASB reports have increased slightly at McDonald's and PCSO Walker is working to resolve them.

PCSO Walker reported a big crackdown on drugs in the Derby South area. A cannabis raid in Church Gresley yielded 11 plants with one arrest. Another raid in Woodville netted 38 plants, with two suspects due in court. A theft of fuel from the SDDC depot resulted in one suspect being caught. Five Section 59 Warnings have been handed out to five nuisance motorcyclists in Sage Drive, Woodville, Morrison's and Belmont Street. A member of the public said a lot of the bikes being ridden are "cobbled together" and the riders are inexperienced having just passed their CBTs.

Sgt Summers said the seizure of 38 plants is a significant haul for the police. He said the plants themselves are not dissimilar to tomatoes and are easy to grow. One plant, if grown and harvested correctly, can yield between £600 and £1,000 of the drug at street prices. So 30 plants can earn the grower in the region of £30,000 per harvest. Sgt Summers said that every time a single plant is taken by police it removes hundreds of pounds of drugs from the street. Big money is being taken away from the dealers, he said. Sgt Summers paid tribute to PC Kev Cassidy for the focus he has on intelligence-led policing and the sterling work he has done in garnering prosecutions for drugs

offences.

Councillor Trevor Southerd reported that parking around junctions was still taking place across Area 4. With the cuts to police numbers that had taken place, Councillor Southerd asked if a time was going to come where it would be "uncomfortable" to police the area. Sgt Summers said the force felt like it was spread thinly. With 300 square miles to cover in Derby South and only a handful of officers with which to do it, the priority was identifying where officers could be used best. Sgt Summers said that crime would always be policed but where the force would struggle would be issues arising from meetings such as this one. He also said that the public didn't always realise the work that PCSOs do in areas such as ASB.

PCSO Walker to update Councillor Tilley on HGV stats in Westfield Road.

Councillor Neil Tilley asked for statistics on HGVs on behalf of residents of Westfield Road. PCSO Walker said he would check the figures and inform Councillor Tilley.

PCSO Walker to do a leaflet drop in the area.

Councillor Gill Farrington thanked the police for their work in Coppice Side. She also reported cars parked in Lansdowne Road in the evening which would prevent a fire engine or an ambulance from gaining access. Sgt Summers asked the public to report similar incidents to ensure there was a police response.

Councillor Linda Chilton reported that she had attended a drug summit in June where 85% of attendees had voted to decriminalise cannabis. She voiced her concern that police cuts would force the decriminalisation of drugs and wanted people to be aware that there could be a tacit move towards it.

#### 4 Partnership Update/ Funding/ New Project Ideas

Phil Marriott reported that Communities Manager Chris Smith had been working closely with the dance studio in Swadlincote in an effort to curb the ASB regularly seen in the area. Mr Smith has also given a presentation on legal highs and training on awareness of sexual exploitation.

A loan shark has been operating in the Goseley area and sheds are still being targeted by burglars. Mr Marriott reported that the Safer Home Scheme is still operating for people to improve the security of their property.

A new Neighbourhood Watch scheme has started in Castle Gresley. It features a "Community Pledge" which encourages residents to agree not to engage in ASB and inappropriate parking. Councillor Farrington applauded the resident who set up the scheme and drew up the pledge.

Mr Marriott also reported on the arrival of retired police inspector Shaun Woodcock as interim ASB Officer in the absence of Claire Rawlins, who is on maternity leave.

#### 5 Local Issues – open forum (20 minutes)

A member of the public reported takeaway delivery vehicles from USA Chicken coming straight down Hill Street and across into the end of High Street. She said pedestrians should not have to look two ways to be safe in the area. Sgt Summers said the management of the takeaway had to take responsibility for their vehicles. The complainant added she thought a camera was needed to monitor the situation. PCSO Walker said the owner needed to be spoken to and told of the situation.

A member of the public asked about 30mph stickers for wheelie bins and Mr Marriott said he would investigate if it was possible to fund stickers. Sgt Summers confirmed the stickers are being used in Aston on Trent.

A member of the public requested a map relating to area forums and Sgt Summers said he did not look at maps in that detail.

	A resident of Ash Street, Woodville, reported a car had been left in the area for three weeks with a "Police Aware" sticker on it. Sgt Summers asked for the details of the car so he could investigate the situation.  Councillor Sandra Wyatt asked how much cannabis someone had to possess before they could not get away with a warning. Sgt Summers responded by saying cannabis use is prevalent and warnings are given to avoid criminalising large numbers of people for a first offence. Possession goes down as a recorded crime but the user doesn't get a criminal record

#### SA/12 **DECLARATIONS OF INTEREST**

#### SA/13 CHAIRMAN'S ANNOUNCEMENTS

There were no announcements.

#### SA/14 TO NOTE THE MINUTES OF THE MEETING HELD ON JUNE 30, 2015

The minutes of the previous meeting were agreed as a true record.

#### SA/15 REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

#### **Derbyshire County Council Issues**

#### **Promotion of Catch the Bus Week**

Paul Jameson (AFLO) reported that, while the county council does as much as it can to promote the use of public transport, it was unaware of this particular initiative. The Communications Team is now aware of this and will look out for any future promotions.

#### Pedestrian Activity at St George's Primary School

The AFLO reported that children could not be supervised at the school before 8.40am and therefore the gates could not be opened to mitigate pedestrian activity on the pavement outside. He also reported that there is a proposal to make an entrance at the back of the school off Thorpes Down Road.

#### **South Derbyshire District Council Issues**

#### South Street

Mike Haynes (Director of Housing and Corporate Services) reported that SDDC had responded to the resident regarding planning issues and that no further action could be taken.

#### Anti-Social behaviour related to Oaklands Village

Mr Haynes reported that he had visited the scheme to review parking procedures and had not received any new complaints since then.

#### SA/16 PUBLIC QUESTIONS ON ISSUES RAISED BY RESIDENTS

A resident said he had been promised a map defining the boundaries of Area Forums but was yet to receive one. He is interested in the boundary of Area Four and Area Five.

#### **ACTION:** Mr Haynes to pursue the map issue for the resident

A member of the public asked when roads were adopted by Derbyshire County Council. The AFLO replied that there was no definitive answer to the question

as it depended on whether the builder brought the highway in question up to DCC standards. He also stated there is no legal duty upon the county council to adopt a road. Councillor Trevor Southerd added that County Highways inspectors have visited Castleton Park, most of which is unadopted. There is a lack of road lining and speed bumps and areas which need parking restrictions. Councillor Southerd stated he felt most of Brunel Way falls into the category of needing adoption.

# ACTION: AFLO to report back at a future meeting over adoption of roads in Castleton Park

A member of the public asked Mr Haynes if there were any proposals for lighting in Pennine Way car park.

#### ACTION: Mr Haynes to pass query on to the relevant department at SDDC

A resident of Castleton Park asked who has responsibility for street lighting in the area. She stated that four lights in Edinburgh Road have been out for the past year and nothing has happened since a phone call to Derbyshire County Council. The AFLO said that if the road is unadopted then the responsibility falls upon the developer. The resident said she had contacted the developer, Barrett Homes, and they said it was not their responsibility. Councillor Paul Dunn seconded what Councillor Southerd had said and insisted the developer is responsible if the road is unadopted. Another resident asked if the issue related to the planning department. She was told by Councillor Gordon Rhind that conditions are attached with the planning permission. Councillor Southerd said that until adoption has taken place, lighting is still the responsibility of the developer, with the planning authority (SDDC) able to enforce this.

A member of the public said that a proposed development in North West Leicestershire on the border with South Derbyshire would see new residents using Derbyshire facilities. However, she said that all Section 106 monies would go to Leicestershire if the development was approved on appeal. Councillor Dunn said that was not the case and should the development go ahead, Derbyshire would be able to claim its share of cash to improve facilities.

A resident asked if flooding issues in Occupation Lane, Woodville, had been resolved. Councillor Dunn said an inspection was being conducted into where the water is coming from. A drain on the Derbyshire side of the border had been cleaned but it was yet to be cleaned in Leicestershire. A new pipe had been found at the site and an inspection on November 23 was going to see if the pipe could be used to clear the water away.

A member of the public thanked SDDC for their input into the Remembrance Day parade.

A resident reported noise pollution coming from the recycling plant in Woodville, saying noise was continuing until 8pm.

#### **ACTION: Mr Haynes to mention situation to Noise Management Team**

A member of the public asked if 30mph stickers could be made available for residents to place on their wheelie bins. The AFLO confirmed such stickers were not legal.

A resident asked if there was to be a school built in Castleton Park. Councillor Rhind said land had been set aside for a school but according to Derbyshire County Council formulae a new school wasn't warranted. The land set aside was then sold back to the developer for housing.

#### SA/17 COUNTY COUNCIL ISSUES

The AFLO raised one issue, which is the online consultation for the 2016/17 budget being carried out by Derbyshire County Council. He told the meeting that savings need to be made by 2018, and DCC needs to identify £40 million of savings from next year's budget. The online consultation was an opportunity for the public to give their thoughts on how the savings should be achieved. He said it gives a picture of the challenge being faced by the council and other public bodies. The consultation closes on December 4.

Senior Neighbourhood Warden Dennis Bateman to give an update on dog fouling, fly tipping and other issues at the next meeting.

#### REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

At the last Swadlincote Area Forum held on November 12, 2015, at Church Gresley Methodist Church, the following issues were raised and a progress report is provided.

#### **Derbyshire County Council Issues:**

1. A member of the public asked when roads in Castleton Park would be adopted by Derbyshire County Council, with most of the estate currently unadopted. Councillor Trevor Southerd stated he felt most of Brunel Way falls into the category of needing adoption.

The AFLO is currently in the process of arranging a site visit for Brunel Way with Councillor Southerd so that local highway concerns can be discussed. The AFLO will be attending, along with the area Clerk of Works. The meeting will probably take place in mid-January if a mutually convenient time and date can be arranged. An update to the forum will be made of any action to be taken as a result of the site visit.

#### **South Derbyshire District Council Issues:**

1. A resident said he had been promised a map defining the boundaries of Area Forums, but was yet to receive one. He is interested in the boundary of Area Four and Area Five.

We are reliant on others, such as the Police, for the maps to be updated as requested. We will continue to work with others to ensure future maps are in a format that can be easily shared and understood. Unfortunately, we are unable to give a timescale for this as the work is not under our control.

2. A member of the public asked if there were any proposals for lighting in Pennine Way car park.

We have a number of sites in the district where lighting would be beneficial. We are in the process of surveying all sites with a view to costing these improvements. We will update residents in due course. 3. A resident reported noise pollution coming from the recycling plant in Woodville, saying noise was continuing until 8pm.

The plant at Woodville operates within the guidelines set out in its licence, and as such we are unable to take any action against the company.
