Dear Sirs,

Please take this email correspondence as notification by the Chief Officer of Police of representations in respect of a Temporary Event Notice given by Mr Ian Sheppard in respect of an event proposed to take place on 01/07/2010 to 04/07/2010 at Elvaston Castle Country Park (Elvaston Steam Rally).

The representations are based upon the belief of the Chief Officer of Police that should the Temporary Event Notice be authorised, the crime prevention objective will be undermined.

A Temporary Event Notice operated at the same event in 2009 and at this event the Police received calls for service in relation to disorder that was directly related to the sale and supply of alcohol at the event. During the period of the Notice, the Police had to request that the sales of alcohol cease in order to control disorder that was occurring on the temporary premises.

The Chief Officer of Police submits that should this Temporary Event Notice be authorised, similar disorder may well take place and that the proposed premises user may well not be in a position to control or prevent the disorder.

I would be obliged if you would accept this email correspondence as a notice of objection by the Chief Officer of Police as required by Section 104(2) of the Licensing Act 2003.

May I respectfully ask that we are notified in due course of the date of the hearing to be fixed in order to consider the objection made?

I can confirm that this email has been sent simultaneously to the proposed premises user using the email address contained in the original notice given.
