CL/64. **MINUTES**

The Open Minutes of the Meeting of the Council held on 20th September 2001 (Minutes Nos. CL/52 - CL/61) were taken as read, approved as a true record and signed by the Chair.

CL/66. **CHAIR'S ANNOUNCEMENTS**

The Chair thanked those Members who had supported his Civic Service on 7th October 2001 and advised that the Remembrance Day Parade and Service would be held on 11th November 2001. The switch-on of the Swadlincote Christmas lights would take place on 30th November 2001 and the Chair advised that the last date for ticket applications was 16th November 2001. A Supper and Song Evening with Rachel would be held on 19th January 2002, the proceeds of which would be donated to the Chair's Charity Appeal.

The Chair welcomed Kevin Stackhouse to the Meeting, the newly appointed Finance Services Manager who had recently commenced employment with the Council. The Chair also welcomed two young persons who were

shadowing Councillors Harrington and Mrs. Mead as part of Democracy Week.

CL/67. **LEADER'S ANNOUNCEMENTS**

The Leader reported on his visit to Sweden with the Chair of the Council, the Chair of the Development Services Committee and the Chief Executive. On behalf of the party, he expressed his gratitude at the hospitality and welcome given and also thanked the Chief Executive for his efforts in attracting sponsorship to cover the costs of the visit. The Chief Executive responded and Members expressed a wish that such links with the Authority in Sweden be continued. It was agreed that a letter of thanks be forwarded to the Authority in Sweden.

The Leader advised that during the afternoon of Friday 26th October 2001, he was called to several properties in Hatton concerning flooding issues following a period of heavy rain. After contacting Severn Trent Water regarding the serious problem of sewerage, the Leader had spoken to Mr. Hansed, the District Council's Technical Services Manager who had telephoned several offices of Severn Trent Water to obtain a response. However, no response was forthcoming and the Leader condemned the actions of Severn Trent for its insensitive manner in this regard, which was endorsed by Members. It was noted that this Council's officers, being Mr. Hansed along with Mr. Reid, the Deputy Chief Executive, were the only officers assisting in the problem.

The Leader advised that it was necessary to clear the watercourses to enable the water to flow into the River Dove. It was noted that this was the responsibility of the appropriate landowners and the Council had committed itself to ensuring that these would be cleared, which the Council could enforce as the Land Drainage Authority by requiring action by the landowners or undertaking the works and recharging accordingly. The Deputy Chief Executive confirmed the accuracy of the Leader's understanding and advised that staff within Mr. Hansed's Division had recently visited landowners in Hatton to commence discussions.

On behalf of the residents of Hatton, the Leader expressed his gratitude to Mr. Reid and Mr. Hansed for their efforts in this matter.

“The thousands of job losses announced by Rolls Royce in the wake of the events of 11th September represent a bitter blow for the East Midlands in general, but in particular for the skilled and talented Rolls Royce workforce from South Derbyshire.

The proposed job losses will have an enormous impact on the region and serious consequences for those suppliers and businesses who rely on their contracts with Rolls Royce.

Local communities are likely to be affected badly by the proposals as individuals and their families face the prospect of losing their jobs and their incomes.

This Council calls upon Government and agencies to take immediate steps to respond to the announcement of job losses by Rolls Royce and initiate action to mitigate the serious consequences for individuals, families, communities, businesses and suppliers by:-

- ◆ providing advice, guidance and support for those seeking new jobs and training opportunities;
- ◆ examining the action which can be taken to support the communities affected;
- ◆ extending the exceptional aid which is currently available to airlines to European aircraft and aero engine producers; and also to those businesses who rely on their contracts with such producers.”

Councillor Wilkins proposed the Motion, which was duly seconded. It was debated and, on a vote, it was,
