CL/57. **MINUTES**

The Open Minutes of the Meeting of the Council held on 29th September 2011 (Minutes Nos. CL/39 - CL/54) were taken as read, approved as a true record and signed by the Chairman.

CL/58. **PRESENTATION OF RAM MAJOR'S SASH TO THE MERCIAN REGIMENT**

It was noted that it had been necessary to withdraw this item. Sadly, there had been a fatality the previous week and Members observed a minute's silence in memory of Private Matthew Haseldin. The presentation had been rescheduled for the Council Meeting on Thursday, 19th January 2012.

CL/59. **PRESENTATION BY THE AIR TRAINING CORPS – BOOK OF WAR MEMORIALS IN SOUTH DERBYSHIRE**

Squadron Commander Alyn Thomson addressed Members, explaining that to mark the 70th Anniversary of the 1211 ATC, a piece of work had been undertaken to record details of all War Memorials in South Derbyshire. The Chairman received the book of War Memorials, thanking the representatives of the Air Training Corps for their work and the other ways in which they assisted the Council.

**CL/60. CHAIRMAN'S ANNOUNCEMENTS**

The Chairman referred to his civic diary, which was circulated separately and gave details of the events attended. He highlighted a number of events, particularly arrangements to mark Remembrance Day and the official opening of the new cinema on The Pipeworks development. He also referred to the Christmas Lights Switch-On ceremony in Swadlincote.

CL/65. **COMPOSITION OF COMMITTEES, SUB-COMMITTEES AND WORKING PANELS**

There were no amendments to the compositions of Committees, Sub-Committees and Working Panels.

CL/66. **COMPOSITION OF SUBSTITUTE PANELS**

There were no amendments to the composition of Substitute Panels.

CL/67. **REPRESENTATION ON OUTSIDE BODIES****RESOLVED:-**

***That Councillor Mrs. Patten is appointed as the Council's representative on the Derbyshire Hate Crime Panel.***

CL/68. **FUTURE OF LOCAL STANDARDS FRAMEWORK**

A report was submitted to consider the Government's proposals on the future of the Local Standards Framework, following the deferral of this matter at the Council Meeting on 28th February 2011. Initially, the report set out changes to the standards regime in England, following the coalition government's announcement to abolish the Standards Board regime. The implications of the Localism Bill were reported, which included provision for the abolition of Standards for England. The Bill included a duty for local authorities to ensure that Members and Co-opted Members maintained a high standard of conduct. A contrast was provided to the current arrangements under the Local Government Act 2000. Further sections of the report addressed alleged breaches of codes of conduct, Members' interests, Standards Committees and pre-determination. Conclusions were provided, together with the Standards Committee recommendation for the adoption of a voluntary Code of Conduct in due course, when further details on the provisions of the Localism Bill were announced.

Subject to the provisions of the Localism Bill, a motion was submitted, duly seconded and debated. Particular areas discussed were the responsibility for dealing with parish council matters and clarification was sought regarding the adoption of a voluntary, rather than statutory code. It was confirmed that all Members would have to sign up to the code adopted by the Council. A further aspect was the need for thorough investigation before cases were brought into the public domain and there was concern about the potential for frivolous or vexatious cases.

**RESOLVED:-**

***That the Council agrees:-***

- (1) A Standards Committee should be retained solely to recommend and police the Code of Conduct for SDDC only.***
- (2) Other bodies, including specifically Parish Councils, should make their own arrangements, perhaps together through DALC, but SDDC would offer our Standards Committee's services on a full cost recovery basis.***
- (3) The only sanction available to the Committee should be public censure of the Councillor concerned (as deprivation of a Councillor's access to SDDC Officers and premises would be at least as great a punishment on constituents as Councillors).***

- (4) ***So far as is practicable, Councillors should be informed when firm charges of breaches of the Code are made and all proceedings should be open to Councillors and the public.***
- (5) ***To minimise cost, Officers should investigate the possibility of sharing a committee with neighbouring authorities, as is the case with the Fire Authorities.***

CL/69. **REVIEW OF PARLIAMENTARY CONSTITUENCIES 2013**

It was reported that the Boundary Commission for England was undertaking a review of parliamentary constituencies. The report explained the criteria being used to reduce from 533 to 502 constituencies nationally. The Boundary Commission had completed the first stage of the review process and published initial proposals, which were set out within the report. The Commission was consulting on the initial proposals for twelve weeks and following the representations received, there would be a further consultation period towards the end of 2012 on any revised proposals. Final recommendations would be made to the Government by 1st October 2013.

In detail, there were currently 11 constituencies in the Derbyshire sub-region and the report explained the changes affecting South Derbyshire. The former Etwall, Hatton, Hilton and North-West wards would be included in the Derbyshire Dales constituency and the current City of Derby wards of Bolton and Chellaston added to the remainder of South Derbyshire wards, to form the Derby South and Swadlincote constituency.

It was recognised that each political group was likely to formulate its views and responses to this consultation process.

**RESOLVED:-**

***That Council notes the proposals of the Boundary Commission and leaves the political groups to make representations on this matter.***
