The new Chairman of the Board Councillor Martyn Ford introduced himself and welcomed members to the meeting. All other introductions took place.

Apologies were noted.

The Minutes of the Meeting held on 18 April 2018 were taken as read, approved as a true record.

SDP/30. **MATTERS ARISING**

Agreed to hold the Summer Board meeting at the beginning of July before the Schools break for holiday in future.

SDP/31. **HEALTHIER COMMUNITIES THEME**;

Place Based Locality Working

Vicky Smyth who had taken over from Mary Hague, Derbyshire County Council Public Health gave a review of progress on the locality approach in 2017/18 and the health needs in South Derbyshire, plus an overview of the Healthier Communities priorities and action plan for 2018/19.

Joanne Finnegan gave an insight into the Place-based approach and Joined up Care Derbyshire (Sustainability and Transformation Plan) and the Place priorities. The high level of synergy between the outcomes sought by Joined Up Care Derbyshire and the South Derbyshire Partnership's Healthier Communities theme was noted.

A comparison of East Staffordshire's adult obesity levels compared to South Derbyshire was requested. **ACTION: VS.**

For information Samantha Elks is the new Public Health Development Worker for South Derbyshire having replaced Jamie Dix.

A discussion took place on the SDP Board's views on what the current year's £10,000 small grants scheme for other locality projects to address health and wellbeing needs should target; these views would be put forward to the SCG to be discussed further.

- Access to sanitary items for young women from deprived backgrounds.
- To make a difference to activity levels in 65-85 year olds and to encourage a rise in activity levels for the middle aged before reaching age 65.

- An idea was put forward from the Strategic Director to encourage the workforce to raise activity levels in order to live a healthy life and reduce sickness absence.
- Raise awareness of prostrate cancer.
- Encourage smoking cessation to the parents of the children taking part in the Summer activities. Look into 'smoke free' playground/parks etc.
- Drug awareness in Schools given the current issue with drugs such as Mamba/spice and criminal gangs 'cuckooing' properties.
- To get the infrastructure in place to get people more active (NFC).
- To encourage School and work place travel planning.
- Communication stream or strategy for these initiatives:
 - GeoApp for mobiles to communicate location of the nearest activity, walks, health centres etc.
 - Information communicated to parents via school bags and Surgeries.

A Focus on Debt

David Symcox, Chief Executive Officer of Citizens Advice South Derbyshire and City gave an overview of the growing issue of debt and benefit issues in our community and how Citizens Advice can provide the support to help people to find a way forward.

Debt issues are greater in South Derbyshire than in neighbouring areas and the capacity of services to address them is more limited.

A discussion took place on Universal Credit and concerns regarding its impact; an event will take place on Wednesday 26 September from 11:00 am until 1:30pm at Oakland Village; here Partners will be available to offer support and advice on the new benefit payment and associated issues.

The impact of Universal Credit roll out is being addressed by the Welfare Reform Group.

1.1 To inform the Board on the Theme Groups work to date.

These provide a summary of progress against priorities in the Sustainable Community Strategy, note issues that the Partnership could add value to, and highlight any action required of partners such as attendance at or promotion of an event.

Young people are more aware and informed about risks to their safety from child sexual exploitation, sexting and drugs:

Dates have been set for the four secondary schools to hold Prison Me, No Way events. The schools get to choose five sessions each for delivery to their year group. The sessions include: street scene anti-social behaviour, Fire Service, prison life-cell van, choices and consequences – serving prisoner, knife crime and CEOPs (Online Safety).

A new Child at Risk of Exploitation (CRE) Group has been set up and has met twice. The group discusses individuals who are most at risk of exploitation and any local concerns where children could be exploited.

As part of the Children's Locality Partnership Group, a new Children at Risk of Exploitation action plan has been produced. This will be worked on over the year and will be disused at the CRE group.

SV2 (Sexual Violence Charity) still have funding to deliver their 'Consent Workshops' into secondary schools. We have contacted all secondary schools to promote the service and William Allitt have confirmed an interest in booking the session.

The Police have produced a Knife Crime Action Plan and held a briefing last week. The Community Safety Partnerships have been asked to assist with the delivery of the plan, including liaising with schools around any concerns, education for pupils in schools, promoting force-wide Op Zao campaign and delivering theatre in education performances. The Police will also be conducting knife sweeps in local parks and carrying out knife test purchase operations.

More people feel safe and secure in their home and in the community particularly those who are most vulnerable

There was a large increase in referrals to the Safer Homes scheme in Q1, while Q2 figures have remained high. Liberation Day was thought to have helped boost Q1 figures.

Cuckooing victims continue to be discussed in weekly Police tasking meetings. Six individuals have now been imprisoned for their involvement in cuckooing in and around Swadlincote.

Increased Voluntary and Community Sector Activity in the District

Midway Community Centre – A local volunteer is due to start running a Monday night youth club in October. The People Express art sessions are due to commence again soon and the CVS is trying to get more local people involved through an afternoon tea session.

Gresley Old Hall – The trustees of Gresley Old Hall have a number of projects in the pipeline. The Community Partnership Officer is assisting in identifying funding to assist with these. CVS continues to develop groups and initiatives at the centre as well as supporting existing staff. They are currently working towards a community café project with the existing grow outside project. The concept is to base it around 'grow it, cook it and eat it', and will work with the food project at the CVS to develop the drop-in type café.

The CVS is also providing free training for volunteers at the Old Hall through their highly motivational and successful three-day volunteer passport course. The sessions run from 10am to 3pm on November 20th and 27th and December 2nd. For more information contact CathyM@sdcvs.org.uk.

Liberation Day – The organisers of Liberation Day would like to increase the size of the steering group in order to get fresh impetus into the event.

After 17 years of holding Liberation Day, numbers over the last few years have dwindled and the event has largely remained the same. There is huge potential for the event to impact positively on local older people but we need fresh ideas in terms of the structure and agenda of the day and which support services should attend. The existing steering group is very small and is mostly made up of local volunteers with little or no representation from local services.

The event, usually held in May, is aimed at over-60s and provides information on local services, entertainment and a variety of safety messages.

We would like the event to really target local issues that older people face and to get relevant organisations involved in the planning. We also have a large number of repeat attendees and would like to target the event at new people and those that would benefit the most from it.

Hate Crime Awareness Week takes place between October 13th and 20th. The Safer South Derbyshire Partnership will be promoting the campaign via social media and the Police SNT teams will be visiting taxi firms, fast food eateries and local shops to promote Stop Hate UK and to encourage them to report any hate incidents.

Significant work has been taking place to agree outcomes of new locality funded projects. Below if a selection of examples of work taking place to support current health and wellbeing priority area:-

Health inequalities between different communities are reduced.

Community Based Work Club

The Health and Wellbeing Group and Sustainable Development Group are match funding an additional year's delivery of the successful Community Based Work Club. The project, delivered by the Old Post Centre, aims to support local job seekers who are ready to re-enter the workforce but need additional support, help and guidance in accessible non-threatening venues located in the heart of some of the most deprived areas in South Derbyshire.

This year there is a particular emphasis on supporting those who may be affected by the implementation of Universal Credit.

Support and help consists of building confidence and motivation, developing / increasing IT skills, CV writing, interview skills, improved letter writing and form completing skills, support setting up and using email accounts and Universal Job Match.

Sessions will be delivered at key locations throughout the urban core of Swadlincote (Newhall, Swadlincote Central, Woodville). The project will also link with partners engaged by the Welfare Reform Group at South Derbyshire District Council to ensure vulnerable clients at risk of Universal Credit are directed to the service.

Delivery will be via a combination of bookable one to one specialist sessions, supporting the most vulnerable, and 'drop in' group sessions across the 3 locations above.

People make choices in their lifestyles that improve both their physical and mental wellbeing.

Mental Wellbeing Small Grants - *addition funding available

To support our priority of improving mental wellbeing, Derbyshire Public Health have allocated an additional £10,000 a year/for 2 years to the South Derbyshire Partnership Health and Wellbeing Group.

This money will form part of an emerging Community Wellness Approach, by delivering a grants fund that local voluntary sector organisations can bid into to deliver against one or more of the "5 Ways to Wellbeing" which are: Connect, Be Active, Take Notice, Keep Learning and Give. New Economics Foundation '5 Ways to Wellbeing'

The scheme will be administered by South Derbyshire CVS in accordance with the model used for the existing Small Grants pot (a further £10,000 pot of funding for 2018/2019)

This funding will build on, and enhance existing local activity of the Health and Wellbeing Group and other local partners.

Outline criteria:

- Applicants must be voluntary sector organisations (or in event of an underspend as determined by the PH MH team).
- Delivery staff from the applicants' organisation must have attended, or must sign up to attend, Mental Health Awareness training or Mental Health First Aid training.
- Applications must be aimed at increasing the understanding of and participation in the 5 Ways to Wellbeing by people who are at higher risk of developing mental ill-health (Appendix 1).
- Applications should demonstrate an understanding of the needs of the target group.
- Applications should be for a maximum of £1,000.

Older people, people with dementia and other long term conditions and their carers have a good quality of life, retain their independence for as long as possible, and receive the support they need at the end of their lives.

Self-Care Pilot

South Derbyshire CVS are working hard to divert people away from Adult Social Care, Primary Care & Acute Services by supporting people to access the support and services they need in their communities

The new Self Care Pilot will identify gaps and capacity in services and support the development of community led solutions, particularly for people who do not fit neatly into services. This will be facilitated through a combination of social prescribing, community development and building of social capital and volunteering in our community.

The pilot aims to combat challenges in the System (austerity/funding, growing demand for services, changes in the system) by thinking differently about how we work together – unlocking the potential of communities and individuals through social action, by adapting a whole system approach.

Integration between the voluntary sector and care pathways will improve to meet shared Place priorities.

The Health and Wellbeing group is supporting this project with match funding of £10.000.

Promotion of both the main Small Grants fund and the Mental Wellbeing Small Grants fund where possible.

CVS are administrating both of these funding pots on behalf of the Partnership.

The South Derbyshire key priorities, linked into the Derbyshire Childrens partnership and a summary of the last three months (July to September) is highlighted below:

Promoting emotional health and wellbeing

Work around Drug and alcohol prevention and intervention is ongoing, Training has been offered for MAT and schools exploring current trends, exploring parental substance misuse and drug usage. We are in the process of arranging 2 workshops for front line practitioners and school staff on current Drug trends, identification & support and children affected by parental substance misuse.

Consideration has been given to Public Health Funding or 'Holistic Health Funding' for Tier 2 substance misuse. The Young Person's Health Group discussed the required outcomes for funding and have agreed to use it to acquire an additional resource. Discussions have taken place with Pingle and Granville schools regarding how we can meet the set outcomes.

It was agreed that DCC would employ an additional specialised Tier 2 drugs worker. The vacancy is currently out to advert run for 3 months. It is not known whether the funding will be renewed for next year. It was identified that this is an ambitious plan and funding runs from the financial year.

We have development of a resilience programme to be delivered on a one to one basis in primary schools to increase self-esteem and confidence. 10 primary school children 1:1 input from sports worker through Lee English and sports mentoring money.

The 'Working for Marcus' CSE prevention and awareness programme by Loudmouth Education and Training, includes YP's sessions and pre and post-performance lesson plans. There have now been 14 performances in secondary schools and 1,781 KS 2 pupils have viewed the play. Feedback from pupils and teachers has been unanimously good, this is set to continue.

CAMHS are offering a mental health support service for age 6-18. South Derbyshire have 2 wellbeing practitioners, where individual support is offered to children and young people through school clinics. There is a high demand for this service as part of the future in mind initiative.

Children at risk of CSE and substance misuse

Chris Smith (Communities Manager SDSC) is developing a programme around safer internet use for 2019 working within schools to promote this further.

Derbyshire localities have developed a monthly meeting around supporting vulnerable children, the children at risk of exploitation meeting (CRE) is in its early stages inviting key agencies to share local knowledge around risks and themes, with information highlighting our most at risk young people through police tasking and tactical missing persons meetings. Derbyshire child protection manager for vulnerable children gathers this information and links into locality to share information to support local action plans and reduce risks. The links between CSE and missing are also explored at the CRE meeting along with agreement that formal strategy meetings would be held by social work team managers where a child going missing more than 3 times within 30 days.

• Targeted family support including 0-5

Incredible Years Parenting Programme has been a continuing success with multi agency teams and schools working together with families delivering targeted parenting support. This parenting programme is delivered into two areas, 8-13 and 2-8 with equal demand for both courses. We are currently establishing the trainers we have across South Derbyshire within schools and MAT to set up a further training programme for 2018/19.

School readiness road shows are being supported by Angela Devine South Derbyshire 0-5 co-ordinator. This will promote the 10 keys to unlocking school readiness, from making friendships, potty training, emotions, following instructions and sharing books. The South Derbyshire roadshow is 3rd April 2018 at Woodville Youth Centre and it is hoped following success that further dates will be approved.

Work around 'little acorns to mighty oaks' outline from birth to school age offering support to parents around the early help services available, this is linked with health and supporting those crucial years to develop all aspects of development and learning. This is with particular focus on communication and language, personal, social and emotional development and physical development.

Work is also ongoing around linking in with health mapping out the key shared services that are provided to families

Issues that the Partnership could add value to (time will be given at the Board meeting for partner input/solutions to each theme group).

We need greater representation within the partnership working groups for the following priority areas:

- Aspiration
- Children effected by domestic violence

The working groups have completed their plan for the next 12 months, these seek to identify any gaps or duplications in partnership service provision and set targets within their theme group for the year. The working groups report their progress and impact to the LCP.

There have been good partnership representation within some of these working groups and assistance in promoting this further is requested.

Any action required of Partners i.e. attendance or promotion of an event.

Promotion of Derbyshire Youth activity grants, county wide grants to support the development of youth activity, to build and expand the voluntary sector and build on existing youth services.

Derbyshire have 500 universal grants up to £500 each and 250 targeted grants up to £500 for vulnerable young people, this replaces the 'UTHINK we Grant' programme previously known.

Would like to promote this within the voluntary youth sector, applications can be 6 times per year and are approved though the Locality Childrens Partnership youth grant sub group.

Promotion of the Locality Childrens Partnership which seeks to have a strategic overview of all services that are offered to children and young people in the locality. It assists us in recognising duplication and gaps in service provision. It also provides a forum for information sharing around new services in the locality that all partners can utilise and draw upon.

Locality Childrens partnership is moving towards inviting youth leads to attend the meetings to ensure we receive a young person's perspective on the themes and priorities.

Priority - A more prosperous, better connected, increasingly resilient and competitive South Derbyshire economy.

Work Club (led by Old Post Centre) – an SLA is now in place for the programme to support individuals with CV writing and job searching. As part of the offer there will be some pre-employment sessions in the lead up to Swadlincote Job Opportunities event in April 2019.

ALICE (led by South Derbyshire CVS) – the Accessible Learning in Community Environments works with unemployed residents facing multiple challenges to entering the workforce. An SLA is now in place to cover the service up until March 2019.

SD Skills Festival – the new South Derbyshire Skills Festival will be taking place on 28th November 2018, 3pm at Green Bank Leisure Centre. The event is aimed at young people and their parents to help them understand the world of work, and make informed decisions about their future careers. Priority - A better place to live, work and visit at the heart of The National Forest.

National Forest Walking Festival May 2018 – There were a total of 1505 walkers who took part in 95 walks across the whole of The National Forest area in this year's festival, this is up 5% on the previous year.

'Our National Forest' Campaign – The National Forest Company have launched a new marketing campaign which aims to raise brand awareness of the National Forest. Audiences will be targeted with a series of themed stories told by people who live, work and visit the National Forest. The first story is about outdoor learning and will be used to help launch the campaign. Issues that the Partnership could add value to (time will be given at the Board meeting for partner input/solutions to each theme group).

Investing in People – businesses are increasingly struggling to fill opportunities within their organisations due to skills shortages across a range of sectors including, engineering, hospitality, and healthcare. The SD Skills & Employment Group are working with schools, colleges, The Department for Work and Pensions, and businesses to develop and implement solutions that will raise aspirations amongst young people and their parents, as well as support for those furthest from the labour market to meet the needs of local businesses.

In addition to low level interventions it was highlighted at the previous partnership board that there is an increasing demand for additional support for those with more complex needs, along with the requirement to build capacity within our communities to provide preventative models that can respond to ever-growing demands from our residents.

Investing in Place – Access to employment and training opportunities is an ongoing issue and the Sustainable Development Group is continuing to work with East Midlands Enterprise Gateway (EMEG) – Access to Work Partnership, and local public transport providers to address this. The partnership can help by influencing changes in policy, as well as assisting in generating contributions for sustainable infrastructure off the back of new housing and commercial developments, to ensure communities are better connected to the opportunities available across the district and beyond.

Increasingly employment land and premises provision is becoming an issue across the district, there have been a number of businesses seeking to grow or move in to the south of the district and have struggled to find suitable land or premises. The Woodville Regeneration site is in the planning process, and is unlikely to be available for another year or two, and Drakelow which will provide over a 100acres of commercial land, requires the new bridge to be implemented to unlock the site.
