SDP/2. **INTRODUCTIONS**

SDP/3. **DECLARATION OF INTEREST**

SDP/4. **MINUTES**

The Minutes of the Meeting held on 20 January 2016 were taken as read, approved as a true record and signed by the Chairman.

SDP/5. **MATTERS ARISING**

(SDP/97) SB to formally write to Derbyshire Fire & Rescue and East Midlands Housing Association regarding board membership. **ACTION: SB**

Cllr Wheeler gave a brief update on the current position with regards to the proposed Derbyshire & Nottinghamshire Combined Authority.

The next Agenda Item Thriving Communities was to follow after Item 6.

SDP/6. **UPDATE ON CHILDREN'S SERVICES**

Chris Lavelle from Derbyshire County Council gave a presentation on Children's Services and the effects of the unprecedented budget cuts on the service. In South Derbyshire and South Dales it is proposed 3 out of 4 centres will close, leaving only Woodville Children Centre.

Initial referral reasons to the South Derbyshire and South Dales Multi Agency Teams were highlighted and the amount of cases open in February 2016 was given out.

CL outlined the proposed Local Commissioning Partnerships/Hubs to be in place from September 2016 and operating in April 2017. The focus will be upon collaborative working and joint commissioning, with schools taking control of the budget and receiving the referrals that had previously gone to the MAT Teams.

A discussion took place on what the Partnership could do to support the service and CL highlighted the impact of losing Children Centres.

SDP/7. **THRIVING COMMUNITIES**

Rob Lowe and Sarah Eaton from Derbyshire County Council gave an introduction on Thriving Communities. An explanation was given on how the evidence is gathered in a different way and how the community were engaged and ideas tested. A new perspective on service redesign was discussed along with the use of Ethnographies 'A day in the life' – to enhance understanding of families with complex needs, highlight duplication and increase the effectiveness of support services. The next step model was discussed and how the Partnership could be involved. It was agreed the SCG to take on a steering group role and look at moving forward with the development of this work in South Derbyshire.

A suggestion was to involve the Parish Councils and organise a meeting to engage them in the project. It was also noted that CVS hold small pots of funds that could be identified for this project. **ACTION: SCG**

SDP/8. **SAINSBURY'S WASTE LESS SAVE MORE**

Nicola Lees gave an introduction on the background of the Sainsbury's Waste Less Save More project; and the objectives/targets that, with the support of the District Council, the project aims to deliver during the one year term.

The Projects funded so far were presented along with a discussion on how the reduction of waste would be measured. Delivery of the projects will focus on the period to December 2016, but there may be opportunities beyond this through £10m available nationally.

Food Banks were raised; CVS to send out further details. **ACTION: MS** (Poster circulated on 4 May).

SDP/9. **TOUR OF BRITAIN**

Stuart Batchelor informed the group of the Aviva Women's Tour of Britain cycle race coming through South Derbyshire on Saturday 18 June and requested Member's approval for financial support to develop a programme of activities and support the event, and the promotion of cycling in general. Members formally agreed the allocation of funds.

SDP/10. **VOLUNTARY SECTOR UPDATE**

Michelle Skinner gave an update on the progress of the Voluntary Sector funding review. A 12-week consultation has been launched from 4 May until 24 July to get the views of voluntary and community groups and people using their services. Views are sought by filling in a questionnaire online or paper copies of the questionnaire are available.

SDP/11. **REPORT FROM STRATEGIC CO-ORDINATING GROUP**

Members formally approved the Terms of Reference of the Strategic Co-ordinating Group.

SDP/12. **SUSTAINABLE COMMUNITY STRATEGY – YEAR END**

The Partnership Newsletter gave an overview of the theme group's latest developments on their projects. The three theme group leaders had nothing else to add on their actions to date.

Stuart Batchelor gave an update on the proposed Actions for 2016/2017. The Members approved the allocation of funds to support the delivery of the programme.

**QUARTER 1 (April - June 2016)**

**SUSTAINABLE DEVELOPMENT**

***Raising Aspirations:** Raising aspirations and assisting unemployed groups into employment and training, particularly amongst younger people and in the more deprived areas of the District.*

**Swadlincote Jobs & Careers Fair** was staged in the Sports Hall at Green Bank Leisure Centre in April led by Swadlincote Jobcentre plus. Fifty exhibitors offered over 1,500 job opportunities, plus a range of apprenticeships, training courses, volunteering places and self-employment support. 644 members of the public attended, seeking to improve their skills and employment prospects. The early part of the day was reserved for school pupils to 'have a go' at new skills, explore future education and training opportunities and learn about local employers. 238 young people attended from the William Allitt, Granville and Pingle secondary schools.

The **South Derbyshire Young Enterprise** initiative commenced with William Allitt School in May. Pupils took part in an exercise to develop their own business idea and discussing it with Business Advisers from the South Derbyshire Business Advice Service. As part of Swadlincote Market's support for 'Love Your Local Market' (a national campaign to promote the market industry, culture and entrepreneurship), the pupils then had market stalls and implemented their business ideas, raising money for charity.

***Promoting Town Centres:** Working with local businesses and organisations to attract visitors and investment, enhance the physical environment and promote the vitality of town centres.*

The **Swadlincote Townscape** programme is now well underway with a range of activities being delivered with the support of the Heritage Lottery Fund. A grant scheme has been launched to assist property owners in improving historic buildings in the town centre, together with a programme of community and educational activities engaging schools, businesses and members of the public.

**Swadlincote Wedding Fair** was staged in April by Swadlincote Town Team with the active support of numerous town centre businesses. A large number of wedding-related businesses opened on the Sunday for the event, from florists to travel agents. The Town Hall staged a catwalk display of wedding outfits and wedding suppliers took stalls at the Ski Centre and Sharpe's Pottery. The event was well-attended with the 50+ businesses participating reporting good sales on the day and appointments for future business. The attractive event marketing materials were created by a design student from Burton & South Derbyshire College, helping them to gain practical work experience.

**Swadlincote Farmers' Market** continues on the last Thursday of the month. During 2016 it now includes cooking demonstrations from the Food Saver Champs – part of Sainsbury's Waste Less, Save More initiative to reduce food waste in Swadlincote. There are also exhibitions from OLIO, a free app which connects neighbours with each other and local shops so that surplus food can be shared.

The **National Forest Walking Festival** was held in May, with analysis of attendance and feedback currently underway. The Festival was supported by more than thirty organisations and voluntary groups which led individual walks. Funding for the event was received from the National Forest Company, Leicestershire County Council and South Derbyshire District Council. Eighty-five walks took place over the two weeks, ranging from short health walks to full day rambles.

The **Swadlincote Festival of Transport** was staged in May by the Box Motor Club & Rotary Club of Swadlincote, with a mix of historic and contemporary vehicles, including cars, motorcycles, campervans, buses, lorries and tractors. The ever growing number of exhibitors attracted a huge audience to the event, to the benefit of town centre retailers, food & drink outlets and local charities.

A **Town Centre Guide** was launched by Swadlincote Town Team at a tea party in June. The Guide is an encyclopaedia of over 200 places to shop, eat, visit and enjoy in Swadlincote town centre, together with details of local markets, attractions and free car parks. The Guide has been well received by local businesses who are now helping to distribute it to both residents and potential visitors.

***Encouraging Enterprise:*** *Encouraging entrepreneurship, supporting the formation and development of businesses, and maximising the take-up of advice and financial assistance.*

**South Derbyshire Business Advice Service** staged a Cybercrime Breakfast Seminar at Foston in April with guest speaker David Benford MSc of Derby University, attracting some fourteen business attendees. The event was very well-received, focusing on higher level protection, exploring current threats from internal and external sources to businesses, their customers and supply chain. The Service has seen an increase in uptake by existing businesses, interested in grants and other assistance.

# Health and Wellbeing Group update July 2016

## South Derbyshire Health and Wellbeing Action Plan allocation of locality funds 2016/2017

Derbyshire County Council Public Health has confirmed funding of £92,283 to support delivery of the 2016/2017 public health locality plan. The plan develops collaborative working through partnerships, match-funding, shared capacity to deliver and joint ownership of local outcomes.

Applications to access locality funding closed on the 22<sup>nd</sup> April. Projects needed to clearly address one of the 5 priority areas:-

- Reducing health inequalities within families and young people living in the urban core around Swadlincote
  - Supporting health of older people in their own home
  - Supporting individuals and families living in rural areas experiencing health inequality (rural isolation, deprivation)
- Healthy Communities Priorities:
- Increasing Physical Activity
  - Urban Planning and Growth – inclusion of health improvement

The Health and Wellbeing Group have agreed to fund the following projects:

- South Derbyshire's community food hub project, 'BUH – DOOF'.
- Money aspirations programme – 1:2:1 income maximisation and budgeting advice/training

## Healthy Communities

South Derbyshire has become the newest member of a worldwide network committed to improving the health of its communities.



The District Council successfully applied to become affiliated to the World Health Organisation's UK Healthy Cities Network, whose aim is to address health inequality and put health improvement at the top of local agendas.

It means access to a developing pool of knowledge and resources that will help to shape a co-ordinated approach to health and wellbeing, encouraging a range of organisations to share good practice.

In South Derbyshire that will mean a focus on two priority areas – physical activity and urban planning and growth.

Work already happening or planned for 2016-17 includes increasing access to community food hub opportunities for vulnerable groups, local mental health awareness training and the development of dementia-friendly community status.

This is fantastic news for the District that makes up part of a dynamic and supportive network of 24 UK cities and towns, including major players such as Belfast, Bristol and Liverpool.

Coupling the knowledge from these areas with our own strong Healthier South Derbyshire brand will enable us to build on existing good work and give us a more focused approach to improving people's health.

Over the next year in South Derbyshire there will be an expansion of the Parklife project to ensure development of infrastructure for an active environment and opportunities to increase physical activity in Swadlincote's parks.

Work will also focus on the urban planning and growth priority by encouraging partners to link together to ensure that health is embedded in new policy and project development. A South Derbyshire planning and health summit is also being considered for later in the year.

## Q1 Update 2016 /17

### Bike Safety / Security

PCSOs have been attending the SDDC bike-ability sessions at primary schools, offering security marking and giving out high visibility stickers and snap-bands. PCSOs were also present to provide bike security marking at the Eureka cycle event which was part of the activities around the Women's Tour of Britain race.

### Prevent (Counter Terrorism) Briefings

A 30 minute 'Prevent' briefing (part of the Counter Terrorism Strategy) was given to Customer Services Staff to raise awareness of what Prevent is, how to identify people with vulnerabilities, and how to report concerns. The briefings will be given to each council department in the coming months.

### Domestic Abuse Campaign

A domestic abuse awareness campaign is running at Argos in Swadlincote as part of the European Football Championships. Statistics from the last few tournaments show a steep rise in domestic violence when England play in tournaments, so adverts promoting the new Derbyshire Domestic Abuse helpline will be on all Argos till receipts for 8 weeks during June and July.



### Swadlincote Town Centre PSPO

Consultation with police is currently taking place about whether to proceed with a Public Space Protection Order in Swadlincote Town Centre. The order would make the town centre an alcohol-free zone and would also enable police to disperse groups of two or more out of the area if they are causing or likely to cause anti-social behaviour.

### Nuisance Motorbikes in Woodville

A nuisance motorbike leaflet has been produced and distribution around Woodville in the hope of identifying individuals who are riding illegally around the village.

### Crime Prevention at Scropton

Crime prevention materials were provided for Scropton Fete. The Scropton NHW group gave out various community safety leaflets and freebies to local residents.

### Hate Crime Training

Hate crime awareness presentations have been given by the Communities Team at the recent Community Forum which was held in Hatton and to the newly formed Youth LGBT group which meets at Woodville Youth Centre. The presentation provides information on the protected characteristics, gives real life case studies and provides information on how to report hate crime and where support can be accessed.

### Vehicle Crime Leaflet Drop

Following a spike in theft from vehicles in Stenson Fields, the Police Cadets were out on patrol on Thursday, June 16th, along with the Mercia SNT team. Together they carried out a leaflet drop and checked vehicles. The leaflet offers security advice to car and van owners. While out, the cadets checked 411 vehicles, with 22 of them unlocked and six left with valuables on display. Advice was given to the owners.

## **Liberation Day**

More than 300 people attended the 14th Annual Liberation Day event in May. The theme this year was the 1970s and the entertainment for the event was provided by an ABBA tribute act. The audience was addressed by the new Police and crime commissioner, Hardyal Dhindsa, local Police Inspector Kate Bateman and the District Community Safety Officer for the Fire Service, Emily Harrison.



## **ASB in Hilton and Etwall**

Six young people have been signed up to Acceptable Behaviour Contracts (ABCs) for committing ASB and using cannabis in the Hilton and Etwall area. Three of these individuals have since breached the orders and have now been issued with a Community Protection Notice Warning which if breached again could lead to a fine for their parents.

## **Criminal Behaviour Order (CBO)**

On April 15th the Communities Team was successful in obtaining a Criminal Behaviour Order on a 12-year-old boy who had been causing ASB in the town centre for the previous 18 months. The order prevented him from entering Swadlincote town

centre (other than for appointments), from associating with a number of his peers who he was causing issues with and from causing harassment alarm or distress anywhere in the District.

*\* Unfortunately, in June we were notified the CBO had been rescinded in court on appeal. We are currently involved in discussions with the CPS to see why this was. There is however still an injunction in place to prevent him going to three named locations where he was causing a nuisance.*

## **Arleston Lane Meeting**

A residents' meeting was held with police, council wardens and the Communities Team to discuss the ASB issues on Arleston Lane. The issues, including fly-tipping, boy racers and prostitution, have been commonplace down the lane over the last two years. The meeting chaired by County Councillor Rob Davidson was successful and a number of actions were identified to take forward.

## **Parish and Members ASB Briefing**

The Communities Team provided a 45-minute update to parish and district councillors on the ASB Tools and Powers and how they have been implemented locally. Since their introduction in 2014, the council has successfully obtained three Criminal Behaviour Orders and issued 29 Community Protection Notice Warnings, with 17 full notices made and six fixed penalty notices issued (*figures accurate as at 11th May*).
