1	Chair's Introduction, Apologies	Action
	Councillor Andrew Billings welcomed those in attendance to the meeting. Apologies were received from Councillor Amy Plenderleith, Lis Kolkman, Bryan Myring and Councillor Andy Roberts.	
2	Minutes of last meeting (to be agreed) and update on actions	
	The minutes of the last meeting held on July 1 were agreed as a true record. Sgt Graham Summers was asked if he had figures for prosecutions related to Area 1 and he said he would try to collate them and bring them to the next meeting.	
	PC Karen Martin reported that she had undertaken several radar speed checks in Area 1. One in Scropton Main Street checked 39 cars, with an average speed of 28.6mph recorded. There was one case of excess speed at 40mph. A check in Main Street, Etwall involved 29 cars with an average speed of 28.4mph with one car found to be speeding at 41mph. Another check in Egginton Road, Etwall, involved 25 cars, with one driver given words of advice. A member of the public reported that speeding in Etwall was worst around the school run time.	
3	Safer Neighbourhood Sergeant's Overview / Priorities Update	
	PC Martin reported that ASB in Hilton has risen in September and October, with

36 incidents reported since July. Etwall had seen 19 reports over the same time frame. Most of the recent reports in Hilton stemmed from apple throwing at houses. CCTV cameras were used in various locations and PCSOs have spoken to a group of youths, with one set of parents spoken to.

PC Martin told the meeting that issues at Hilton Primary School have continued with youths climbing over fences into the grounds. Spikes have been put in place to prevent access. The school is now looking at installing CCTV to address the issue.

There have been issues with benches in Hilton. One has been removed, easing ASB for residents of Bloomfield Road.

Sgt Summers reported that crime had fallen significantly in Area 1.

PC Martin said that thefts from insecure cars had risen across the area. She said that people need to be careful and ensure their car is secured. Sgt Summers said the issue had become a significant one in Melbourne but that there was only so much the police could do. He urged people to secure their cars after leaving them and not to leave items of value in the car. The police have footage of someone walking along a street in the district checking the doors of every car. PC Martin said possessions ranging from loose change to iPads had been taken. Inspector Kate Bateman reiterated the need for care, with thefts taking place at any time of the day or night. Sgt Summers said with Area 1 being a low crime area, people needed to be even more careful with fewer police resources in the area.

In a round-up of activities, PC Martin reported that a Section 59 warning had been issued to a driver in Area 1 for inconsiderate driving. Letters have been sent to various parents regarding ASB in the area. A Section 165 has been issued removing a vehicle for the driver having no documents. A vehicle has also been stopped on stolen number plates and was found to be carrying £30,000 of stolen plant equipment. PC Martin reported that the occupants are facing custodial

sentences as a result. Alcohol has been seized in Area 1 with the offender related to incidents in other areas.

A member of the public stated that a significant number of fires were being started in Area 1, including in public toilets outside John Port School in Etwall. PC Martin confirmed that there had been three fires in the public convenience but CCTV cameras couldn't be used for obvious reasons. She told the meeting that she had been out to a group of youths loitering around the toilets and found a strong smell of cannabis inside. Police have suggested the toilets be closed when school finishes each day during the winter months. A member of the public asked if a camera could be installed outside the toilets. PC Martin said there was little chance of getting a camera to be effective at the location and Chris Smith added that officers had to review hours of footage related to overnight incidents.

4 | Partnership update / funding / new project ideas

Chris Smith raised the issue of the chairing of the Area 1 meeting. A new chair and vice chair was required and asked for nominees. Councillor Billings had kindly agreed to remain as chair for this meeting.

Chris Smith reported the arrival of Shaun Woodcock as the interim Anti-Social Behaviour Officer during Claire Rawlins' maternity leave.

Two applications have been made for Safer Neighbourhoods Funding from Area 1.

- 1. Etwall Cricket Club CCTV. Mark Lomas from Etwall CC reported a lot of issues regarding ASB around the club, hence the application for £1,300 towards a £2,600 bill for four CCTV cameras. Mr Lomas blamed youngsters who travel between various villages in the area causing a nuisance. He and the club have tried to interact with the youths and engage them in club activities. Unfortunately, a minority of the youngsters have caused several thousand pounds of damage to the club and, latterly, the cemetery.
- 2. Hilton Primary School. An application has been made to clear an area of overgrown land at the school to widen the pavement and reduce the likelihood of having to step into the road during busy times. A child was recently hit by a car after straying out into the road. A figure of £2,000 has been sought against a total project cost of £6,500.

Both projects were approved by the meeting. Another enquiry has been made by St Helen's Church, Etwall, for funding CS will provide the Church with the necessary Application form.

5 | Local issues – open forum

Councillor Julie Patten reported issues related to a van parking inconsiderately outside the Nisa shop in Hatton. Sgt Summers said it was unlikely police would be driving past at the time it happened. Insp Bateman suggested putting a notice on the van asking the driver to used available parking spaces. Councillor Billings confirmed that this had been tried without effect. A member of the public reported that the van was also parking on the pavement. Sgt Summers stated that puts it in the realm of ASB. Dennis Bateman asked if this was an issue for the community and it was confirmed that complaints had been made about it. Mr Bateman

reported that there is a new Community Protection Notice Warning which could be used against the driver. A member of the public suggested Nisa use 'no parking' signs which could easily slip over the bollards outside the shop. Sgt Summers agreed this was a good idea.

A Hatton resident reported a van parking on the pavement at Station Road, when he could easily move the vehicle two feet further back and clear the way so pushchairs could easily be taken past.

A Hilton resident reported trouble at night around a bench in School Close, Hilton. The police have asked the Parish Council if the bench could be moved as it is is near to some houses A Parish Council rep stated that their concern was if the bench was removed, the problem would only move elsewhere in the village. PC Martin said the bench was a concern but that the village needed benches for people to use.

A member of the public from Burnaston reported problems with drug usage in Green Lane, Burnaston, with people going there driving at "phenomenal" speeds. PCSO Karen Coldicott said police would look into the problems and see if a night "wildlife" camera could be useful. PC Martin confirmed three cars could get down the lane with enough room to turn at the end. She asked for registration numbers to be written down.

6 Agreed priorities

- 1. Inconsiderate parking.
- 2. ASB in Etwall. A member of the public reported trouble with youths heading to Etwall from Hilton and Mickleover to cause trouble. The trouble has included: kicking the window of the fish and chip shop, abuse of local residents and smoking drugs in the church yard. PC Martin says the situation is difficult to police with so many exit routes for the troublemakers. Sgt Summers suggested getting PCSOs from Mickleover to come over and police the situation since it was youths from their area getting involved.

EA/11 **APOLOGIES**

Apologies were received from Councillor Mrs Amy Plenderleith, Councillor Andy Roberts, Lis Kolkman, Brian Myring and Miles Nesbitt.

EA/12 **DECLARATIONS OF INTEREST**

None.

EA/13 CHAIRMAN'S ANNOUNCEMENTS

Councillor Mrs Lisa Brown reported that as part of the Local Plan part two being produced by South Derbyshire District Council, in total sites for around 600

additional houses were being sought in rural areas around the district. A paper will soon go to the Environmental and Development Services Committee.

Councillor Mrs Brown updated the meeting on the forthcoming Parish and Member Training meetings at SDDC.

Councillor Mrs Brown then presented a list of current planning applications in the district and said that a certain number of homes have to be built. She gave a taster of the workload SDDC's Planning Department is dealing with, citing it as one of the hardest-working departments at the council under great pressure to deal with a range of applications.

Dennis Bateman, a recently appointed Senior Neighbourhood Warden, was introduced to the meeting by Councillor Brown. Mr Bateman's 33 years in the police were highlighted, as was his service in the army, both as a cook and parachutist. He told the meeting he was in his post to tackle dog fouling and fly tipping, two of the most complained about issues for SDDC, among a range of other things. Mr Bateman has signed 150 people up to the Green Dog Walking Scheme, which sets an example to all dog owners of the standards of behaviour expected of them. He also asked for assistance from the public in identifying offenders so he could act. Regarding fly tipping, Mr Bateman reminded people at the meeting that handing rubbish over to a stranger would land them in trouble if that rubbish was later fly tipped. A member of the public suggested that younger dog walkers would be more inclined to leave their animal's mess instead of picking it up. Mr Bateman agreed that teenagers were the worst offenders.

Councillor Mrs Brown asked Mr Bateman to return at a future meeting for an update on how the Green Dog Walking scheme fared.

EA/14 TO NOTE THE MINUTES OF THE MEETING HELD ON JULY 1, 2015 (COPY ATTACHED)

The minutes of the previous meeting were agreed as a true record.

EA/15 REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

Burnaston Lane, Etwall: Overhanging Trees

Councillor Martyn Ford said he would keep an eye on the trees after Derbyshire County Council reported that they were in good health and not an issue over the highway.

Ash die-back in the District

Councillor Mrs Brown said it was unfortunate that a large number of ash trees – which make up 15-20% of trees in the National Forest – would be lost to disease.

EA/16 PUBLIC QUESTIONS ON ISSUES RAISED BY RESIDENTS

None.

EA/17 COUNTY COUNCIL ISSUES

Paul Jameson (AFLO) raised one issue, which is the online consultation for the 2016-17 budget being carried out by Derbyshire County Council. He told the meeting that savings need to be made by 2018, and DCC needs to identify £40m of savings from next year's budget. The online consultation was an opportunity for the public to give their thoughts on how the savings should be achieved. He said it gives a picture of the challenge being faced by the council and other public bodies. The consultation closes on December 4.

Councillor Mrs Brown raised the issue of "white areas" with poor access to superfast broadband, of which there are several in the North West Parishes of South Derbyshire. She asked the AFLO if it was possible to have a presentation on the subject.

AFLO to report back on Digital Derbyshire initiative at the next meeting

A member of the public reported potholes in Etwall Lane and Dee Lane, Burnaston and said he believed DCC had a substantial backlog of holes to deal with. The AFLO said he was unaware of a substantial backlog and that all potholes are referred to a control centre which issues them to area Rapid Response Teams to get fixed. He also said that potholes can be reported online and by phone.

A resident reported a lack of white lines being replaced on the roads in Hilton. The AFLO said that lining works was an area where there was a backlog of work due to serious issues with a previous lining contractor. These issues have now been resolved but there is a backlog of work remaining. The work was now being dealt with on a priority basis, with relining after surfacing works on A and B roads taking precedence.

EA/18 **DISTRICT COUNCIL ISSUES**

Frank McArdle, Chief Executive of South Derbyshire District Council, reported his presence at an industrial ground breaking ceremony in Dove Valley. He said there was little which inspired more confidence than a developer building industrial units which will be empty upon completion, showing how bullish they are at the chance of them being occupied.

Mr McArdle told the meeting that the Festival of Leisure had been another success in South Derbyshire and the Christmas Lights were soon to be switched on in Swadlincote. He clarified a story recently published in the local press which stated that the lights had cost £41,000. Mr McArdle said this was not a true figure as the figure quoted included everything which went with the lights, which themselves are a smaller proportion of the total cost. Mr McArdle added that the lights provide a phenomenal boost to the economy of Swadlincote.

Unemployment in South Derbyshire is running at 0.6%, compared to 0.7% when Mr McArdle last spoke at the Etwall Area Forum. It is the second lowest figure in Derbyshire after Derbyshire Dales. The figure is down – and down in the area where Mr McArdle wants it most, the 16-24 age group, where South Derbyshire unemployment is half the national average.

Children from Pennine Way Junior Academy held a school parliament gathering at the SDDC Civic Offices where they debated the Magna Carta. Mr McArdle reported the event was a great success, with the great seals of South Derbyshire present to inspire the youngsters.

Mr McArdle urged those present to register as an elector on the Electoral Register by the end of the month, if they were not already registered.

Newhall and Stanton had submitted a petition with the minimum required 7.5% of the parish to get themselves a parish council. A consultation by SDDC will now take place with residents of Newhall and Stanton about whether they want a parish council.

Mr McArdle gave an update on Combined Authorities, which he says could offer benefits to Derbyshire, Nottinghamshire and beyond in terms of strategic infrastructure, spending and transport. He said that he was working with political leaders towards getting a proposal for South Derbyshire that members could say yes or no to at a meeting of the council.

A member of the public asked Mr McArdle how much losing the New House Farm appeal cost SDDC. The Chief Executive said the final figure was currently unknown. Mr McArdle said SDDC had objected on what it felt were valid grounds but the Secretary of State disagreed.

Councillor David Muller raised the ongoing situation regarding noise levels coming from the A50 for residents of 120 houses to the west of Egginton Road. He has discussed the situation with Environmental Health at SDDC regarding decibel levels.

RECYCLING REPORT

I meant to bring this issue up at the last Area Forum.

Following an incident at the Almshouses when the recycling bin was not emptied and a tag attached to say that the contents did not comply I was alerted to the last circular which was distributed.

This was the one which banned certain items which from the inception of the new regime had been allowed.

These were black plastic containers, pizza boxes, plant pots, coat hangers, carrier bags, foam packaging etc.

The problem was that the revision circular was so similar in layout that recipients were not really alerted to the changes. It was not just the Almshouses residents that were caught out.

I talked to Norman Ireland about this after the meeting and he and I agreed that it would be good to have an update and some clarification / reasoning for the changes at the next Area Forum.

We also carried out roadshows across the District during June and July and information was added to the Council's website. Following this, during the fortnight commencing 2nd November 2015, the new collections calendars (which contained an update and information relating to the scheme), were hand delivered to all residents across South Derbyshire.
