Draft Pastoral Scheme

Foremark and Repton, Newton Solney and Bretby, Hartshorne

In accordance with the Repton Deanery Plan, the new united benefice of Foremark and Repton, with Newton Solney, is proposed. As an interim measure the united benefice of Hartshorne and Bretby is also proposed.

A. Foremark and Repton with Newton Solney

1. The Benefice of Bretby with Newton Solney shall be dissolved.
2. The plurality of Foremark and Repton and the Parish of Newton Solney shall be united to create a new benefice which shall be named "The Benefice of Foremark and Repton with Newton Solney." The area of the new benefice shall comprise the parish of Foremark, the parish of Repton and the parish of Newton Solney. The parishes shall remain distinct.
3. The new benefice and its constituent parishes shall belong to the archdeaconry of Derby and the deanery of Repton.
4. If immediately before this scheme comes into operation the Revd Julian R P Barker MA remains the incumbent of Foremark and Repton, and priest in charge of Newton Solney, he shall become the first incumbent of the new benefice.
5. The parsonage house of the new benefice shall be the parsonage house of the plurality of Foremark and Repton. The parsonage house for the benefice of Bretby with Newton Solney shall be transferred to the Derby Diocesan Board of Finance Limited for disposal.
6. The right of presentation to the new benefice shall, on each occasion, be exercised jointly by the Bishop of Derby in his corporate capacity; the Executors of Miss A I M Harpur-Crewe, care of Mr M A Alexander, Messrs Royds Treadwell, 2 Crane Court, Fleet Street, London EC4A 2BL and the Diocesan Board of Patronage.

Notes (not forming part of the draft scheme)

1. The Executors of Miss A I M Harpur-Crewe may wish to surrender their patronage, in which case patronage will be exercised jointly by the Bishop of Derby and the Diocesan Board of Patronage.
2. The churches of St Saviour Foremark, St Wystan Repton and St Mary the Virgin Newton Solney shall each remain the parish church of their respective parishes.

B. Hartshorne with Bretby

1. The benefice of Hartshorne and the benefice of Bretby shall be united to create a new benefice which shall be named "The Benefice of Hartshorne and Bretby" and the area of the new benefice shall comprise the parish of Hartshorne in the parish of Bretby. Both parishes shall remain distinct.
2. The new benefice and its constituent parishes shall belong to the Archdeaconry of Derby and the Deanery of Repton.
3. If immediately before this scheme comes into operation the Revd Ian R W Hunter remains the incumbent of Hartshorne, and priest in charge of Bretby, he shall become the first incumbent of the new benefice.
4. The parsonage house shall be the parsonage house of the benefice of Hartshorne.
5. The right of presentation to the new united benefice shall, on each occasion, be exercised jointly by the Bishop of Derby in his corporate capacity, the Diocesan Board of Patronage and the Martyrs Memorial and Church of England Trust.

C. This scheme shall come into operation on the first day of the month following the date of any order of Her Majesty in Council confirming this scheme.

Notes (not forming part of the draft scheme)

1. Simplification of the patronage for the proposed new united benefice of Hartshorne and Bretby will be investigated.
2. The church of St Peter Hartshorne and St Wystan Bretby shall each remain the parish church of their respective parishes.
