OV/7. REPORTS OF THE COMMUNITY AND CORPORATE SCRUTINY COMMITTEES

Councillor Harrington outlined those issues considered by the Community Scrutiny Committee at its Meeting held on 28th July 2003. Matters discussed included Best Value Progress Reports on Sheltered Housing, Housing Services Strategic Housing and Housing Services Landlord and Tenant Function, the Housing Strategy and HRA Business Plan, Disabled Facilities Grants, progress on the Disability Discrimination Act, the Lift Project, South Derbyshire Community Strategy and the Work Programme.
