## STREETSCENE REVIEW

## NOTES OF A MEETING HELD ON 29 NOVEMBER

#### Matters discussed:

Jackie Wardle began by reminding the group of the initial remit for the review – finding ways in which the County and District/Borough Councils could work better together.

She then went on to outline progress to date:

- the consultation undertaken by CVS in Swadlincote on what local people thought about the 'street scene'
- consultation with County Council staff from the Willington depot about their ideas for working better
- consultation with members of the District Council's waste management and street cleansing team , a copy of that report is attached)

Everyone agreed that there was a need to move forward and to bring the review to a conclusion.

Ron Lane summarised the issue in terms of two questions:

- Should there be one number for people to call to report 'street scene' issues (however they are defined)?
- Should calls be directed in the first instance to the County Council or the District Council?

There was general agreement that best solution would be to use 'Call Derbyshire'

The group then went on to discuss some of the 'practicalities' around the use of a single point of contact. These included the need for an education programme to make people aware of reporting arrangements, avoiding delays in dealing with complaints, the need for good communication between those receiving and those responding to complaints, IT infrastructure.

Trevor Southerd commented that it could cause confusion to include the Clean Team within 'Call Derbyshire'.

## Next steps

Officers to collaborate on the production of reports with common recommendations to County and District Committees.

The basic recommendation would relate to the use of 'Call Derbyshire' for reporting streetscene complaints with officers working together to 'make things happen'.
