#### DC/184. MINUTES

# DC/185. REPORTS OF MEMBERS

# (a) Bridleway No. 11 – Parish of Willington

Further to Minute No. DC/174 of 29th May 2001, Councillor Whyman enquired as to any updated information on this matter. The Chair reported that he had written to the Chair of the County Council's Environment Committee who was pursuing the matter. However, there were some difficulties and it was still anticipated that the outcome of the investigation would not be available imminently. In response, Councillor Whyman confirmed that he would continue to pursue this matter vigorously until the issue had been concluded satisfactorily.

# (b) Protocol for Site Visits

Councillor Southern expressed concern at the protocol adopted at the site visit held earlier in the day at Brandons Poultry Limited, particularly in respect of the tour of the premises and surrounding area, together with various information provided by the applicant on the site. These comments

were accepted but the Chair considered that there were unusual circumstances in this case and the information provided by the applicant had been helpful and necessary in the consideration of the application.

# (c) Environment Agency – Sustainable Drainage

The Chair reported that he had recently attended a meeting with the Environment Agency regarding flooding and had arranged for an Officer from the Agency to address a future Meeting of the Development Control Committee regarding sustainable drainage. A policy on this matter could then be established by the Committee.

# (d) Final Meeting of Sub-Committee

The Chair reminded Members that this would be the final Meeting of the Development Control Sub-Committee and future business would be controlled by a Development Control Committee, to be Chaired by Councillor Brooks. - DC/190. THE DEMOLITION OF EXISTING BUILDINGS AND THE ERECTION OF A DRIVE-THRU RESTAURANT (CLASS A3) ON THE SITE OF THE FORMER COAL AND COKE AND BRICK COMPANY, BELMONT STREET, SWADLINCOTE (9/2001/0015/F)

It was reported that Members of the Sub-Committee had visited the site prior to the Meeting. Amended plans had now been received, indicating the retention of trees on Civic Way. The comments of the County Highways Authority had also been received, arising from which appropriate amendments were recommended to conditions nos. 7 and 16.

A local Member considered that the County Highways Authority should be requested to consider precluding access to the proposed premises via Stanley Street. The Chief Executive also advised that the County Council recognised the need for partnership working and he had been assured that funds could be directed into appropriate projects. Accordingly, he suggested that in the interests of highway safety, the County Highways Authority could be requested to consider fencing an area of footway on Civic Way, thereby directing pedestrians towards the traffic refuges and nearby pelican crossing.

### RESOLVED:-

(1) That planning permission be granted, subject to the conditions recommended by the Planning Services Manager, with appropriate amendments to conditions nos. 7 and 16, as requested by the County Highways Authority.

- (2) That the County Highways Authority be requested to consider precluding access from Stanley Street together with the provision of fencing on Civic Way, as outlined above.
