



1	Chair's Introduction, Apologies	Action
	Frank Hood welcomed everyone to the meeting and introduced the panel. Frank chaired the meeting in the absence of Cllr Martyn Ford.	
	Apologies were received from Cllr Linda Chilton; Linda Pardner (SDDC); Cllr Michael Stanton; Cllr Martyn Ford; Inspector Nigel Lidsey; John Hawkins; Derek Lomas; Mrs Dahl-Cunningham; Barry Hanson; Cllr Shepherd; Cllr Chahal; Dave Parker; John Orme	
2	Minutes of last meeting (to be agreed) and update on actions	
	The minutes of the last meeting were agreed as a true record.	
2.1	<b>Dog poisoning in Stenson Fields</b> — vets confirmed they had one dog who had died but could not elaborate. No further complaints to Police Wardens or Environmental Health	
3	Safer Neighbourhoods Sergeant's Overview / Priorities Update	
	Sgt Todd gave a Police update on crime statistics.  Total crime: year to-date is down 50 crimes, which equates to 21% reduction.  During September there were 34 crimes, which was the same as in September last year.  Violent crimes have reduced; sex offences show a slight increase; stealing has reduced by 51 crimes; other thefts have reduced by 10 crimes; stop thefts have increased by 2 crimes; vehicular crimes have reduced by 36 crimes.	
	<ul> <li>Number plate operations have been carried out over the summer as number plates are frequently stolen. The next operation will take place at The Green Dragon car park in Willington from 3 pm to 6 pm on 20<sup>th</sup> November.</li> <li>Police have been targeting scrap metal collectors. Electrically powered loudspeakers have been confiscated and Council Wardens have issued tickets for not having the correct Waste Transfer licence.</li> <li>A property marking event took place on 11<sup>th</sup> October in Willington where items of value stored in sheds and garages were marked. More operations are planned from May next year.</li> <li>Drugs offences have reduced by 2 crimes.</li> <li>Anti-social behaviour in September reduced by 3 calls to service, but year to-date there has been an increase of 10 calls.</li> <li>Petrol station drive-offs have also increased. Forecourt watch scheme is being promoted to two BP garages on the Ypass and Shell at Willington have also signed up. They will receive signs and an advice pack.</li> </ul>	

 Community Speedwatch in Willington – letters have started to go out and people from Birmingham and Stafford have been among those to receive these.
 Residents asked why it can't be done on Twyford Road. Sgt Todd explained that Community Speedwatch can only be carried out in 30mph zones.

#### Update on priorities: -

- ASB in Stenson 10 calls received since the last meeting, only 6 were true ASB, ie: 2 were regarding parking and 1 was for harassment. PCSO Orme has carried out regular patrols on his bike. No calls have been received regarding nuisance bikes over the summer.
- A Resident raised there was still evidence of drinking in Stenson Fields, where bags of alcohol containers had been collected. Sgt Todd stated they will continue to patrol but need calls for service if and when it's witnessed.
- Mercia Marina Police are looking to have a base at Mercia Marina to store bikes and equipment.
- Sgt Todd promoted Derbyshire Alert, Immobilise.com and that the SNT team were now on Twitter.
- Cllr Hood raised at the last meeting about two number plates had been found in a drain. PCSO Orme stated it was reported as a crime in another area so our officers are not investigating it.

#### 4 Partnership update / funding / new project ideas

- "Get safe on-line" initiative has been running this week. Officers and SSDP staff have taken information into schools and it has been promoted via facebook and twitter.
- National Personal Safety week has ran last week in all four secondary schools with the PCSO's and SSDP going into the schools and providing discussion on issues including personal safety, drugs, legal highs, and ASBO's.
- A number plate operation will take place at The Mease, Hilton on 29<sup>th</sup> October.
- Youth Restorative Justice disposals are now being co-ordinated by the Youth Involvement officer and ASB officer and will involve more work in the community working in parks and with CVS
- No funding applications have been received as yet.
- A resident stated there may be an application coming in for the Willington Festival.

#### 5 Local issues – open forum (20 minutes)

- Cllr Smith raised about quad bikes on Repton Bottoms bridle paths. Two small children were out on the bikes with an adult on Sunday. PC Fearn wasn't aware but will speak with the gate keeper.
- Resident complained about a Police car going through Repton at 2 am with lights flashing and sirens on. Sgt Todd explained that if it's an emergency call out the officer will have been trained to have blues and twos on, even if it's an emergency call in a built-up area.
- Resident raised about HGV's being on roads they shouldn't be on around Bretby.
   Sgt Todd stated they need to report them to DCC Trading Standards. They have a website with details of the restrictions. DCC will write to companies if registration plates are reported. DCC can issue larger fines than Police.
- PC Fearn mentioned the lorry which recently got stuck under Willington bridge. The company will receive an £8,000 fine.
- Resident stated he had received a Derbyshire Alert with crime advice from Police stating cars should be parked under a street light even though DCC are turning some street lights off. PC Fearn stated that if they are areas of crime or areas having ASB issues then the Police can ask DCC to turn them back on.

#### 6 Agreed priorities

- Sgt Todd suggested speeding on Twyford Road and zig-zag enforcement issues.
- School parking at Findern was raised.
- Cllr Smith asked for a speed trap in Willington at peak times.

 Cllr Davison asked if they could still do late night patrols in Stenson near the pub and Irvine Close, together with a visual presence on Pilgrims Way to prevent speeding.

## **Agreed Priorities were:**

- Parking on the zig-zags on Castle Way and speeding on Twyford Road, both in Willington.
- It was agreed that speeding on Pilgrims Way, Stenson Fields would be investigated.

#### 1. **APOLOGIES**

Apologies for absence from the Meeting were received from Councillors Stanton; Ford; Shepherd; Chahal; Mrs Hood and Mrs Chilton; J Orme; L Nash (Findern Parish Council)

#### 2. **DECLARATIONS OF INTEREST**

None

#### 3. CHAIRMAN'S ANNOUNCEMENTS

The Chairman announced the Council are moving to 'paperlite'. As part of this Councillors will now have ipads rather than paper copies of minutes for all council meetings. This results in a saving of £20k per year.

Draft Local Plan Part 1 – Consultation event at Stenson Primary School on 24<sup>th</sup> October from 4 – 7pm. The event will detail Housing and employment provision required across the District up to 2028.

Neighbourhood Plans - Workshop to be held on Tuesday 12<sup>th</sup> November in the Chamber at SDDC from 5.30 pm for a 6 pm start. Only 25 spaces available — booking essential by emailing <a href="https://example.com/helen.frazer@south-">helen.frazer@south-</a>

<u>derbys.gov.uk</u>. Cllr Shepherd and Repton Parish Council are already booked on.

Garden tree giveaway. Residents can register at <a href="www.south-derbys.gov.uk">www.south-derbys.gov.uk</a> from 27<sup>th</sup> September to 31<sup>st</sup> October for free trees.

There has been positive feedback received on the new recycling bins issued by SDDC. Some of the positive feedback has come from people who were originally sceptical about the scheme.

Resident asked about the recycling paper bin and Salvation Army bin at Willington as proceeds from it support the local Scouts. The Chairman confirmed there were no plans to get rid of them. Resident also raised that commercial companies also use the Willington recycling bins.

Resident asked about tetra packs and whether there were plans to recycle them. The Chairman confirmed he didn't think there were existing plans to recycle them as it is too costly.

A Councillor stated that SDDC deserve praise for the recycling scheme.

Internet/broadband – DCC have commitment from BT that more than 95% of homes and businesses will have superfast broadband by 2016. The project aims to ensure all remaining premises will also see uplifts in speed and deliver a minimum of 2mbps to almost all homes and businesses.

## 4. MINUTES

The Minutes of the Repton Area Forum held on 3<sup>rd</sup> July 2013, were noted.

Item of accuracy – C Fellows incorrectly noted as Foston & Scropton Parish Council.

#### 5. REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

The Chairman handed over to the Forum Liaison Officer to report back on those items raised at the last Meeting.

In regard to the flooding in wet weather and possible signage at Anchor Church Ingleby - SDDC have agreed to pay for new signage.

Drainage in Bretby Lane – Work to be carried out in the near future to increase drainage capacity. Forum Liaison Officer has asked to be kept up to date with progress.

Resident asked if Severn Trent were contributing to the cost as they caused the problem. Forum Liaison Officer was not aware but suspected not.

Regarding Speed Limit on Stenson Road -Resident raised that the criteria has already kicked in to change to 30 mph. Forum Liaison Officer said they

would review it once development is complete. Cllr Davison was keen for it to stay at 40 mph as if it went down to 30 mph it would encourage motorists to use Pilgrims Way as a rat run.

In regard to the Road works at the Junction of Pilgrims Way and Stenson Road a Councillor asked why Virgin Media did the street work without DCC permission and asked if any sanctions could be put on to Virgin Media.

In regard to the Part time lighting scheme, It was confirmed that no changes have been made to the street lighting arrangements in Willington as of yet. However, Willington is in the programme for this financial year (2013/14); the village is yet to be surveyed and DCC have not prepared any proposals but it should be out to public consultation before April 2014.

Resident asked about putting in low energy lighting instead of taking out lights. Forum Liaison Officer said it was a good idea but too costly, whereas the current scheme will save £400,000 per year and was more financially viable.

#### 6. **PUBLIC QUESTIONS ON ISSUES RAISED BY RESIDENTS.**

Resident asked for an update on the Willington riverbank footpath. The Forum Liaison Officer informed the forum that DCC has submitted the case/documents to the Planning Inspectorate but the DCC Legal Team had not yet been informed of a date for a public inquiry.

Forum Liason Officer to update at next meeting

#### 7. **COUNTY COUNCIL ISSUES**

The Forum Liaison Officer informed the Willington residents of DCC funding for a zebra crossing at Repton Road, Willington (outside new health centre)

#### 8. **DISTRICT COUNCIL ISSUES**

The Village Games scheme has received funding and been extended for 3 years. New officer is Lee English who will continue the good work of developing new activities in South Derbys villages.

## 9. **DATE OF NEXT MEETING**

#### REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

At the last Repton Area Forum held on 22<sup>nd</sup> October 2013, at Newton Solney Village Hall the following issues were raised;

#### 1. ANCHOR CHURCH, INGLEBY - REQUEST FOR SIGNAGE

SDDC have offered funding for the signs and it has been agreed that signage would be provided. DCC Rights of Way Team have advised that two bespoke signs have been ordered and we are currently awaiting delivery. Once they arrive our Countryside Rangers will arrange installation.

## 2. BRETBY LANE, BRETBY - DRAINAGE ISSUES

DCC preparing a scheme to increase drainage capacity. The scheme is being funded entirely by the County Council.

#### 3. WILLINGTON PART NIGHT LIGHTING

I can confirm that Willington is in the part night lighting programme for this financial year (2013/14). However, we have not yet surveyed the village or prepared any proposals but it should be out to public consultation before April next year.

In regard to this forum area, Newton Solney and Stenson Fields are also included in this year's programme and still to be surveyed, etc.

The part night lighting programme is being rolled out countywide over a 3-4 year period. I would just like to stress that the process is very labour intensive – due to the need to risk assess and carry out consultation within each parish – and we have very limited resources. Currently we only have one full-time street lighting officer dedicated to the project.

Part night lighting was considered the most cost effective option available to us.

# 4. RIVERBANK FOOTPATH AT WILLINGTON

I spoke with a member of our Legal Service department and am advised that documentation has now been submitted to the Planning Inspectorate at Bristol for an independent decision to be made on the case. We have not been advised of a date regarding any potential Public Enquiry.
