

1	Chair's Introduction. Apologies	Action
	Apologies were received from Sheila Jackson, Carole Knight, John Powell, Sergeant Graham Summers and Carol Wright.	
2	Nominations for vice-chair	
	Chair Janice Pallett told the meeting that forms to nominate a new vice-chair were available at the back of the room.	
3	Minutes of last meeting (to be agreed)	
	The minutes were approved as a true and correct record.	
4	Safer Neighbourhoods Sergeant's Overview / Priorities Update	
	PCSO Dave McMillan reported that Sgt Summers was unable to attend the meeting and that no figures were available for crimes committed in Area 6.	
	There had been a large number of burglaries in South Derbyshire as a whole where keys to high performance cars had been removed at the vehicles stolen. The cars had been found in Church and Castle Gresley as well as Hunts Lane, Netherseal. One man had been arrested and was on bail but more offenders were being sought as offences were still taking place.	
	Thefts of tools from vans were still happening and batteries were also being stolen from caravans.	
	In Coton in the Elms, a number of cats had been poisoned and died as a result.

Two males from Castle Gresley had been given Community Protection Notices (CPNs) for riding bikes in an anti-social fashion.

One male from Castle Gresley had got six months in a Young Offenders' Institute for driving without insurance.

A neighbour dispute was taking place in Coton in the Elms. Warning notices had been issued to a number of youths. PCSO McMillan was currently working with SDDC to solve an issue in Elms Road, where a family had been targeted with ASB.

Leaflets regarding anti-social parking on pavements had been circulated around Area 6.

#### 5 Partnership Update/ Funding/ New Project Ideas

Phil Marriott reported that an event to educate parents about the dangers of sexting, mental health issues and child sexual exploitation (CSE) had been held at Granville School. Some very positive feedback had been received. It would be offered at other schools in South Derbyshire.

Hate crime surgeries had been held in other parts of the district.

The Safer Homes initiative had been running in South Derbyshire, improving home security for elderly and vulnerable people, as well as victims of domestic violence.

Prison Me? No Way! sessions had been run, using serving prisoners to show youngsters who had been in trouble what a future in jail would be like.

Plans were afoot to use Gresley Old Hall as a community food hub.

No new funding applications had been received from Area 6. The money was there to be used and applications were encouraged.

A resident asked if number plate security screws were available. Mr Marriott replied that there had been a rise in number plate thefts and there were going to be events in the summer to fit the screws and these would be publicised.

A new Neighbourhood Watch scheme had been launched in Coton in the Elms. A Rosliston resident said a scheme in the village was now dormant and they were looking at getting it reviewed.

A resident asked if the partnership had considered contacting other headteachers regarding talks around CSE and sexting. Mr Marriott replied that other schools would be covered soon.

#### 6 Local Issues – open forum (20 minutes)

A Coton in the Elms resident reported that she and several other attendees at the meeting had lost cats due to anti-freeze poisoning. The first cats had started dying in August, 2014. Nine had died since, all in a small area of the village. PCSO McMillan said he was producing a letter to put through letterboxes in the area

where the incidents were happening. As he had discussed with residents, he couldn't point a finger at who was doing it. Crimes were documented with evidence. Cats wandered about and it wasn't possible to know exactly where they had been. It wasn't peculiar to Coton in the Elms either, as one of the officers at Swadlincote Police Station who lived in Stanton had his cat poisoned. However, nine dying over a two-year period was a lot of cats. PCSO McMillan couldn't suggest what could be done. A resident said there were so many within a few hundred yards. Could PCSO McMillan not knock on some doors and show a uniformed presence? He agreed to do so. A resident added that the cats which had been poisoned suffered terribly as a result and it wasn't a quick death. Her son had seen three of the family's cats die and it was horrific. What unnerved her was that so many cats had gone in such a short space of time. PCSO McMillan said it could be accidental - but it was unlikely. Another resident said it could be someone putting anti-freeze in a water feature and cats were attracted to it due to its sweet smell. Mr Marriott said that all that could be done about the issue from the partnership's point of view was to raise awareness of it happening.

**ACTION: PCSO McMillan** to write a letter to residents and conduct house-tohouse enquiries

A member of the public from Walton reported two parking issues in the village. At 55, Bells End Road, drivers were going over a verge where there was no dropped kerb. Just around the corner in Main Street a black car was parking right on the junction with Bells End Road. There was also a car parked in the street with its clutch gone, near to the black car. It had been there for a considerable length of time. Could anything be done as it was obscuring the view in the direction of Drakelow? PCSO McMillan said he would have a look.

**ACTION: PCSO McMillan** to have a look at situation of car

A resident reported chaotic parking in Lullington Road from where it joined Valley Road, Overseal. PCSO McMillan explained that there were no parking restrictions in Lullington Road. DCC Highways were aware of the issue but weren't planning to put any restrictions in place.

A member of the public gave a short presentation on a code of conduct he had compiled for groups of club cyclists who rode through the country lanes of Area 6. If support could be gained from people and the media got on board and push it, he would be very grateful. Councillor Pat Murray added that he had taken the matter up with the Police and Crime Commissioner's Office. He agreed that some sort of campaign was needed. A resident said a Cycling Proficiency Test used to be undertaken in schools. PCSO McMillan said a test was now done at Rosliston Forestry Centre.

A resident reported a problem at Appleby Glade with a Ford pickup, registration no SIL4912. It didn't belong to a resident and was speeding up the close to a garage. Did the owner have a permit to operate a commercial vehicle from the garage? PCSO McMillan said concerns over speeding went to the speed safety team CREST. A check had recently been done in Hillside Road, Linton. However, there were 120 requests county-wide for the camera van so it was a case of reviewing sites.

#### LA/21 **CHAIRMAN'S ANNOUNCEMENTS**

Councillor Pat Murray had no announcements to make. Emma Simpson from Rural Action Derbyshire gave a presentation on the benefits of a community oil and gas buying initiative run by the charity she worked for. She also detailed a scheme where funding was available to replace faulty or aging boilers.

#### **Empty House at Stanley Close, Netherseal**

Councillor Murray updated the meeting that the son of the former owner had visited the property and, in light of its condition, decided to sell it. Arrangements were being made to obtain valuations from local estate agents.

#### Paul Jameson

Kevin Stackhouse reported that Derbyshire County Council Area Forum Liaison Officer Paul Jameson would no longer attend any Area Forums. He was still contactable at County Hall, and any issues raised would be fed back to him through Service Assistant Tom Sloan. Mr Stackhouse put on the record South Derbyshire District Council's thanks to Mr Jameson for the excellent work he had done for South Derbyshire.

#### LA/22 THE MINUTES OF THE MEETING HELD ON OCTOBER 31, 2016

The minutes were moved with one addition – Councillor Kath Lauro to be added to the list of attendees.

#### LA/23 REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

#### **South Derbyshire District Council issues**

#### **Vegetation at Blacksmiths Close, Netherseal**

Mr Stackhouse reported that SDDC had intervened and issued a formal notice to the developer on January 21 regarding the vegetation encroaching onto the footway of Dog Lane. The developer had 28 days to answer.

#### Sunken manhole on the A514

A manhole had been reported as sunken, but a DCC inspection did not identify any problems. Councillor Bob Wheeler said a manhole was either sunken or it wasn't! A resident said there were quite a few manholes opposite Ryder Close had been repaired but they kept on sinking periodically. Councillor Mrs Kath Lauro asked if they were in a bad state again. The resident confirmed that they were and a survey was needed to discover why they kept sinking.

#### **ACTION:** Issue to be reported to Derbyshire County Council Highways

#### Ivy encroaching onto the footway in Hillside Road, Linton

Councillor Wheeler thanked DCC for the work done on the issue, which had been a running sore for as long as he had been a district councillor.

#### LA/24 PUBLIC QUESTIONS ON ISSUES RAISED BY RESIDENTS

A resident asked for an update on the Walton bypass. Councillor Wheeler reported that the D2N2 Infrastructure and Investment Board had approved the plan for the bridge in December, subject to a further agreement. The bridge was desperately needed and Drakelow Developments said that as soon as it was done the building of new homes could begin. The bridge was not thought to be a big job and could be done in a calendar year. Councillor Mrs Lauro said she had met with Jim Seymour at DCC, who was involved in the project. The issue was making the funds used for the project secure.

An Overseal resident said that traffic up Lullington Road was travelling at speed, mounting the pavement and generally being a menace. The situation was about to get worse with the building of new housing in Valley Road. Councillor Murray said that DCC didn't see any issues at all. He drove there every day and the worst part of the journey was going from Valley Road to Lullington Road to the Robin Hood. The problem was at a particular corner and DCC's attitude was to get a resident to reduce the size of a bush to 3-4ft. However, he felt the problem was vehicles parked on the bend. Councillor Mrs Beth Hall added that she had been forced to drive on the pavement as a result of the parking and a bus coming the other way. A resident said they were disgusted with DCC Highways and it was time to bombard them with photographic evidence or even set up a petition. Councillor Murray said efforts still needed to be made, especially in light of two fatal accidents on the A444.

A resident asked if contractors working in Valley Road, Overseal, were signed up to the Considerate Constructors' Scheme? Councillor Murray said they weren't.

### LA/25 COUNTY COUNCIL ISSUES

Councillor Mrs Lauro reported that DCC was due to set its budget. Anyone interested could go online and read the reports.

#### LA/26 **DISTRICT COUNCIL ISSUES**

Mr Stackhouse reported that SDDC would set the Council Tax at a meeting of Full Council on March 1. The financial position of SDDC was quite healthy but there were challenges ahead. Some funding from Central Government would go

and the impact would be felt in 2018-19. It was a challenge that the council would meet like it had done before, with spending closely examined. Regarding the Council Tax itself, the proposal set down was to increase it by 1.95%, which would be a rise of around £3 per year on a Band D property. That would be debated and a rise agreed on March 1. As part of the budget, it had been recommended to increase funding to voluntary organisations such as the CVS and CAB by 1%.

DCC, like other county councils, had been allowed to increase its Council Tax by more than 2% – without the need for a referendum – to help fund adult social care. Meanwhile, parish councils in South Derbyshire were also allowed to increase their share of the Council Tax bill by more than 2% without a cap being enforced.

Councillor John Grant clarified that there were many facets to the overall Council Tax bill and they all rose at different rates. Mr Stackhouse said the biggest proportion of the bill was taken up by county councils, who took around 75 to 80% of the total. They were the biggest service provider, with education and social services in their remit. SDDC and the police took around the same figure.

#### REPORT BACK ON ISSUES RAISED AT THE LAST MEETING

At the last Linton Area Forum held on February 6<sup>th</sup>, 2017, at Coton in the Elms Community Centre the following issues were raised and a progress report is provided.

#### **Derbyshire County Council issues:**

#### 1. Sunken mahole

A manhole had been reported as sunken, but a DCC inspection did not identify any problems. Councillor Bob Wheeler said a manhole was either sunken or it wasn't! A resident said there were quite a few manholes opposite Ryder Close had been repaired but they kept on sinking periodically. Councillor Mrs Kath Lauro asked if they were in a bad state again. The resident confirmed that they were and a survey was needed to discover why they kept sinking.

**ACTION:** Issue to be reported to Derbyshire County Council Highways

The local Highways Inspector has advised that all manholes in this locality are the responsibility of DCC and that two currently require action (i.e. meet the intervention criteria). An order has subsequently been raised to renew the two manhole covers and frames, located between Ryder Close and Appleby Glade. Only the manhole covers which meet the intervention criteria are to be changed.
