EL/28. **USAGE INFORMATION**

The Leisure Centre Manager presented a report that gave a breakdown of public usage of the swimming pool, squash courts and tennis courts for the financial years 2001/02 to 2005/06. He also handed out a report on admissions to week 52 (2006).

In particular, it was reiterated, as reported at the last Meeting, that the large pool inflatable had come to the end of its useful life in July 2005. Other fun equipment was being used during the fun sessions, but the large inflatable was

In response to a question, the Leisure Centre Manager confirmed that the number of public swim hours currently available had changed recently to accommodate an increase in lessons. He also confirmed that lessons were not included within the public swim time figures.

The Leisure Centre Manager reported that the Derby Triathlon Club was holding an event for children on Sunday, 30th April. The pool would be closed for public swimming on this date until 1.30 p.m.
