## **Premises Licence Application - Royal Oak, Main Street, Cauldwell**

Further to our telephone conversation on Friday 26<sup>th</sup> August 2005, I can confirm that this section has some concerns in relation to the above application.

In section F "Recorded Music" you have asked for recorded music both outdoors and indoors until 1.00 a.m. Monday to Saturday and 12.30 a.m. on Sundays. We feel that this would almost certainly cause a nuisance to neighbouring properties.

After discussions with yourself you have informed me that you would only play music externally on rare occasions when you have events which mainly occur on Friday and Saturday nights. You said that the level had always been kept low in the past and that you would require to be able to do this until 11.00 p.m. at night.

Taking the above into account I would ask that section F "Recorded Music" is amended to say Indoors only until 1.00 a.m. Then in the "please give further details here" it is added "Outdoor Recorded Music to be played on occasion only until 11.00 p.m. on Fridays and Saturdays".

With regard to section Q(d) "The Prevention of Public Nuisance" I would ask the following is added:-

"The perimeter will be patrolled to ensure that noise from the premises is not affecting neighbouring properties."

"Noise or vibration shall not emanate from the premises so as to cause a nuisance to nearby properties"
