1. PURPOSE

1.1 To determine an application to vary a premises licence received by this Authority on the 26th September 2022 from Roger Lowe. The application is attached at **Appendix 1**.

2. BACKGROUND

2.1 The applicant is seeking to vary the plan attached to the premises licence. A copy of the plan is attached as **Appendix 2.**

3. APPLICATION DETAILS

- 3.1 The applicant is seeking to be granted a variation of the premises licence to add an adjoining premises to increase the internal seating/standing capacity by approximately 25-30 people as per the attached plan. No changes to the existing layout, conditions or hours are being requested.
- 3.2 The steps the applicant intends to take to promote all four licensing objectives can be seen at section 16 of the application form.

4. CONSULTATION RESPONSES

4.1 Representations were received from the Responsible Authorities.

5. AGREEMENT BETWEEN PARTIES

5.1 The Licensing Authority has now agreed conditions with the applicant and have subsequently withdrawn their representation as shown at **Appendix 6**.

6. OTHER RELEVANT CONSIDERATIONS

- 6.1 The Authority should consider its responsibilities under the Crime and Disorder Act 1998, and the Human Rights Act 1998 when considering the fair balance between the interests of the applicant and the rights of local residents.
- 6.2 Any decision taken by the Sub-Committee must be appropriate and proportionate to the objective being pursued.
- 6.3 Members are reminded that whenever they make a decision under the Licensing Act 2003, they have a duty to act with a view to promoting the licensing objectives.
- 6.4 When considering any representations, only those issues relating to the four licensing objectives should be considered and appropriate weight given to the importance and relevance to the application of each representation.
- 6.5 In making its decision, Members must also have regard to the Statutory Guidance issued under section 182 of the Licensing Act 2003 and the Council's own Licensing Policy. If Members depart from either, they must specify their reasons for doing so.

7. DETERMINATION

- 7.1 The Sub-Committee must take such of the following steps as it considers necessary for the promotion of the licensing objectives:
 - 1. Grant the licence in accordance with the application.
 - 2. Modify the conditions of the operating schedule by altering or omitting or adding to them.
 - 3. Exclude or restrict from the scope of the licence any of the licensable activities to which the application relates.
 - 4. Reject the whole of the application.
- 7.2 The Sub-Committee may also grant the licence subject to different conditions for different parts of the premises.
- 7.3 Members are asked to note that they may not modify the conditions or reject whole or part of the application merely because they consider it desirable to do so. It must be appropriate to do so in order to promote the licensing objectives and any such step must relate to any outstanding representation made.
- 7.4 If Members grant the application, the details of the operating schedule will be incorporated into the licence as conditions. The licence will also be subject to certain mandatory conditions.

8. RIGHT OF APPEAL

8.1 Members should note that the applicant or persons making representations have the right of appeal against any decision made by the Sub-Committee.

Full training will be given to staff on commencement of employment relating to the sale of alcohol and any system or procedures they are expected follow in the course of dealing with these goods.

Refresher training will be given at regular intervals - not less than 6 months

Records detailing the training provided will be kept on the premises for production upon request from Police or other responsible authority.

All records must be written and recorded and shall be retained on the premises for a minimum of 12 months. A challenge 25 system shall be in place at all times

Anyone attempting to purchase alcohol that appears under the age of 25 shall be asked to produce proof, all refusals will be recorded in the refusal log, kept on site.

b) The prevention of crime and disorder

The only acceptable forms of ID when challenged will be:

PASS - Government approved accredited proof of age card Photo driving license

Current Passport

HM Forces Identification card

Clear prominent and unobstructed signage informing customers of the proof of age scheme in operation shall be displayed at all entry points to the premises and at the point of sale

A system recording sales challenged under the proof of age scheme shall be operated at all times.

The refusal book shall be kept n the premises for production upon request by the police or other responsible authority. The records relating to the refusal log shall be retained on the premises for a minimum of 12 months.

The premises license holder shall ensure that a written incident log is maintained within the premises and details of all relevant incidents are recorded within the log.

This log shall be kept on the premises for a period not less than 12 months and shall be produced upon request by the police or other responsible authority.

It will be made clear on the website that in relation to the delivery service a Challenge 25 policy is in operation and that alcohol will not be delivered to anyone that appears under 25 and who does not have acceptable identification Anyone making a telephone order will be given the same information

Any couriers delivering the alcohol will have the age verification policy in place

Any alcohol packaged for delivery by a courier will be clearly labeled that it contains alcohol

An age verification notice will be displayed upon the home page of the website and again on ordering page

c) Public safety

Any movement of stock shall take place prior to 23:00hrs to keep disturbance to a minimum.

A full risk assessment will be carried out to ensure potential hazards are identified and appropriate measures will be in place such as signage to identify any risks or hazards.

A CCTV system is installed and the recording system is in good working order and is in operation at all times. Records are kept for a minimum of 28 days

d) The prevention of public nuisance

Due to operating times and through the promotion of the facility being used by families we will ensure any nuisance is kept to a minimum. Regular consultation with local community groups and parish councils will ensure any issues are resolved quickly.

No customers shall be allowed to remove any alcoholic or other drinks from the licensed area in an open container, unless to an external area set aside for consumption indicated on the plan

The premises license holder shall comply with the noise management strategy.

A telephone number shall be made available to residents to contact in case of noise disturbance or anti social behavior by persons associated with the premises.

A record will be kept by management of calls in the incident log.

e) The protection of children from harm

Children shall be supervised at all times by a responsible adult when they are on the licensed premises.

NOTES ON REGULATED ENTERTAINMENT

In terms of specific regulated entertainments please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.



The premises currently being in receipt of a premises licence authorising the following licensable activities of live music, recorded music and the sale by retail of alcohol to the public on and off the premises. The premises licence also has numerous conditions that were offered and agreed by the applicant and responsible authorities on receipt of their initial application to promote the four licensing objectives in support of their application. However, the condition shown below in its current form would not be achievable due to human nature whilst also placing an added staffing control and financial measure upon the establishments management. Thereby placing the applicant in a precarious position in attempting to comply with and adhere to this condition whilst undermining the licensing objectives and the applicant's business. All the other conditions as shown at Annex 2 and Annex 3 would remain in place. In order to aid, assist and ensure the promotion of the four licensing objectives in line with the application submitted by the applicant I would remove this condition from the premises licence. |

I wish to oppose the expansion of the licensed area as detailed in the Premises Licence application on the grounds of the 'Prevention of Public Nuisance'. Myself and my family live in the residential area opposite the business premises.

The reason for my objection is that the licensee is currently not abiding to his own Noise Management Statement v1.1 which is required as part of the Premises Licence granted by the SDDC Licensing Committee in 2021.

From my point of view the particular aspect of the business operation which generates a public nuisance is the playing of live music outside the business premises and inside the Melbourne Hall Courtyard. During the late spring, summer and early autumn months, this has been taking place each Wednesday and Saturday evening. More recently the business has expanded the playing of live music on a Thursday evening as part of an 'open mic night' (which may or may not continue into 2023).

On June 8th 2021, The SDDC Licensing Committee granted the licensee a premises license subject to a number of conditions which included 'The Applicant complies with the Noise Management Strategy'. This 'strategy' was annexed in Statement v1.1 and distributed by email to all members of the public who made a representation to the council at that time.

This Noise Management Statement v1.1 includes the following wording: 'The proposal is to provide incidental entertainment on an ad-hoc basis, typically consisting of a classical guitar, small piano and artists providing music genres typically of jazz, blues, classical etc. Indeed, the restrictions on space do not lend themselves to other genres and a single performer is the most likely form of entertainment. It is also stressed that such performances are primarily limited to internal only with ad hoc or occasional external events......Acoustic music inside is intended to take place once a week, whilst outdoor events <u>may take place once a month</u> depending on season and weather etc.". Rather than the genres specified, the music has been more in the genre of rock/pop with amplification. Sometimes, audience participation is encouraged which increases the disturbance.

On several occasions throughout 2022 I have been forced to complain to the Licensee as the sound from the live music emanating from Stable Ales / The Brewhouse has been audible in my garden, inside my living room and my bedrooms. I consider this to be a public nuisance as it is preventing myself and my family from enjoying our own home undisturbed.

There is also recognition from the SDDC that the applicant does not comply with his own Noise Management Strategy v1.1 as doors and windows are not closed during any music event, no discussion with local residents takes place and there is no background noise level in which to determine a breach.

If possible please suggest alterations to the application/licence that would resolve the problem mentioned above, again paying attention to the licensing objectives

The licensing decision in respect of the variation for Stable Ales / The Brewhouse premise should be deferred until the licensee demonstrates compliance with the current premises licence conditions.

The Licensee should abide by his Noise Management Strategy v1.1 as defined by the Premises License (June 2021) and now be formally limited on the frequency that external live or prerecorded music may be played each month.

Nothing exists in the 'Noise Management Policy' (an appendix to the Noise Management Statement v1.1) regarding external live music events, only that they may take place once per month. The definition of 'external live or prerecorded music' must now be clearly defined by the Licensing Committee as the licensee has often had artists positioned inside the business premises with music amplified outside the business premises towards guests seated outside. This is the element that generates a public nuisance.

Once the licensee can demonstrate full compliance with the current premises license conditions and further conditions (such as above), any adjustment to the Noise Management Strategy v1.1 must have the full approval of SDDC and local neighbouring residents.

Objection. Application to vary a premises licence. **Stable Ales.** Unit D, The Courtyard, Melbourne Hall, Melbourne

I refer to the variation to a premises license application submitted by Mr Roger Lowe of Stable Ales, Unit D, The Courtyard, Melbourne Hall, Melbourne. Your licence reference is LAPRE/0398.

Please accept this objection to the proposed variation which adds an adjoining premise (for which building alteration will require planning consent) and increase the internal seating and standing areas for an alleged 25-30 persons. The objection is made on the grounds of the prevention of public nuisance.

Since the creation of this live and recorded music venue within the Courtyard of Melbourne Hall the South Derbyshire District Council and the applicant has received significant complaint with regards to noise nuisance. It is no longer possible to enjoy the peaceful privacy of one's home without having to close windows in the summer months and, if appropriate, to turn up the volume on the television if the interruption from unwanted music intrusion is to be tolerated.

In addition to these complaints there is recognition from the South Derbyshire District Council that the applicant does not comply with his own Noise Management Strategy (Joynes Nash May 2021 version 1.1) in that doors and windows are not closed during any music event, no discussion with the community takes place and there is no background noise level in which to determine any breach. The council has requested the applicant rewrite his own strategy in order to ensure compliance!

Joynes Nash Technical Note 1 relating to the Brewhouse and dated May 2022 refers to:

"a single guitarist, whose performance took place indoors but was amplified by the use of a speaker in the doorway of the premises"

The statement further reinforces the point of non-compliance. Joynes Nash are independent experts whose evidence is beyond reproach.

The decision in respect of the licence variation for The Brewhouse premise should be deferred until the applicant is able to show compliance with the current premise licence conditions. To approve at this juncture would be to condone the actions of the applicant, fail to uphold the principle of the prevention of noise nuisance and provide a signal to the Brewhouse that the council is unable to apply the provisions of the Licensing Act 2003 with any certainty.
