Crown Court have also issued a Restraining Order made
on the 03/06/2019 For Edward FELIX that is live for 10
years. FELIX is also on the sex offenders register until the
3rd of June 2029

As the result of the above points, I believe that FELIX is
unsuitable to hold a Personal License and make a
representation on the behalf of the Chief Constable of
police that the panel revoke Edward FELIX Personal
